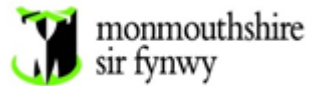

**1. PURPOSE:**

- 1.1 To seek approval for the attached report which will form the basis of our application to the Fairtrade Foundation to renew our status as a Fairtrade County.

**2. RECOMMENDATIONS:**

- 2.1 To approve the attached report (Appendix 1) and supporting evidence (Appendix 2) as an accurate record of the progress made by Monmouthshire County Council to promote Fairtrade from 2014 to date.
- 2.2 To approve the actions that are proposed in the report as Monmouthshire County Council's commitments towards promoting Fairtrade from 2017 to 2019.
- 2.3 To authorise the Sustainability Policy Officer to submit this report to the Fairtrade Foundation to renew our Fairtrade County status.

**3. KEY ISSUES:**

- 3.1 Monmouthshire County Council needs to renew its Fairtrade County status by submitting a report on progress to date and actions for the next 2 years.

**4. REASONS:**

- 4.1 Monmouthshire County Council's Fairtrade Resolution was passed by full Council in May 2007 and endorsed by Cabinet 25<sup>th</sup> July 2007. Fairtrade County status was first awarded to Monmouthshire by the Fairtrade Foundation in November 2008.
- 4.2 To keep our status as a Fairtrade County, this needs to be renewed every two years, and renewal is due now.

**5. RESOURCE IMPLICATIONS:**

- 5.1 None at present. The actions contained in our renewal can be delivered within existing staff resources.

**6. WELLBEING OF FUTURE GENERATIONS IMPLICATIONS (INCORPORATING EQUALITIES, SUSTAINABILITY, SAFEGUARDING AND CORPORATE PARENTING):**

6.1 Renewing Monmouthshire's Fairtrade County status contributes to multiple wellbeing goals and has benefits for Monmouthshire and for the global community. Work is delivered in close partnership with community groups, schools, Fairtrade Wales, businesses and others, and raises awareness of Fairtrade amongst people in the county. Local businesses benefit from being able to promote themselves as a fair trade venue and farmers and growers across the world benefit from guaranteed, fair prices for their work and premiums which they can invest in their communities. There are no negative impacts.

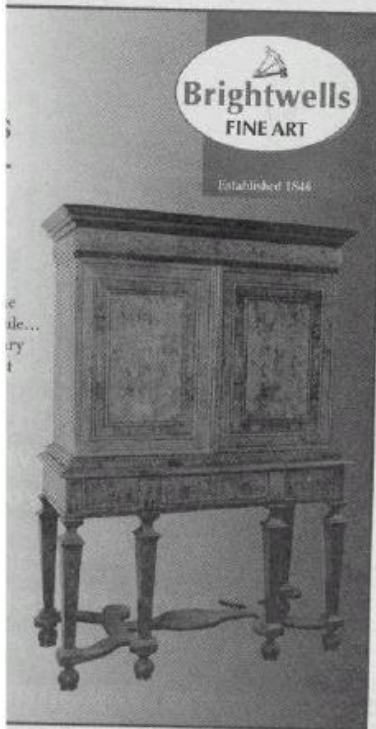

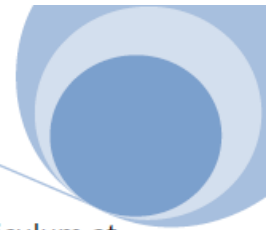

### **Fairtrade Cotton School Uniform**

Our school will be introducing an ethically manufactured school uniform option made with Fairtrade Cotton.

### **WHY FAIRTRADE COTTON SCHOOL UNIFORM?**

1. There is no difference in quality between Fairtrade cotton and normal cotton. Fairtrade cotton means that we can be sure that the farmers who grow the cotton receive a fair and sustainable payment for their crop. Their communities also receive a premium for projects such as building schools, hospitals, access to clean water and so on.
2. Being "Fairtrade Cotton Certified" means that all parts of the manufacturing process of the Fairtrade cotton garments have been inspected and audited. The factories are signed up to Fairtrade Minimum Standards, designed to ensure that practices such as child labour and enforced overtime/long working hours don't exist.

#### Introductions

The meeting started with introductions. The Fairtrade Town groups explained a bit more about what they do and Sara explained a little about her portfolio in MCC's Cabinet.

#### Matters arising from the minutes

- Hazel still to put Fairtrade information on MCC main website. **Action: Hazel**
- It was agreed that we will drop the idea of a Fairtrade Way in Monmouthshire as the distances between towns are too far, and we couldn't see the added value in it. Maybe holding a local walk between Fairtrade café's etc as part of the MCC Countryside's programme of guided walks might be more useful.
- Following on from the discussion about Fairtrade Ways, most towns have already got maps or town guides showing outlets selling Fairtrade. However, paper maps quickly go out of date, so perhaps more could be put on <http://monmouthshirefairtrade.org.uk>. Sara suggested that there might be Rural Development Plan money available to support an app or interactive map. Hazel to speak to Mike Powell about this. **Action: Hazel**
- Fairtrade Fortnight went well for the local groups and for MCC, with some good press coverage. MCC found funding for a Fairtrade Flag which was flown at County Hall during the fortnight.

#### Car Park signs

Hazel has met with Amanda Perrin from Car Parks to discuss the Fairtrade logos going on the new car park signs. The tender for the new ticket machines is out, and then the tender for the signage will follow. - *a March for Africa, starting 1.00 pm on Sat 16th Sept, including songs on the Castle stage, also Angel Hotel and Brewery Yard and crossing Market Hall. Money raised will support sustainable food in Zimbabwe. 40 children have been invited, 1 parent each given free admission. Llantilio Pertholey & RC schools are so far interested.)*

NB The Wales Fairtrade Fair will be held in Abergavenny on the 8<sup>th</sup> October

### **Renewal of Monmouthshire's Fairtrade County Status**

Hazel circulated a draft of the action plan she has put together to renew our Fairtrade County status and asked for any comments, or any supporting evidence the groups have that could be used in the County application. **Action: All**

In particular she would welcome any information about Fairtrade Schools in the County. She has emailed the schools and discovered that Goytre Fawr Primary School has achieved its Fairtrade Achiever award. **Action: All**

Sara was keen to see how schools are working on Fairtrade, especially as it forms part of the National Curriculum.

One action that has not been progressed was around developing a Fairtrade town group in Caldicot. Julia has agreed to help at a couple of events in Caldicot to see if this will generate some local volunteers. Sara agreed to raise it with the mayor of Caldicot when she sees them tomorrow. **Action: Julia / Sara**

### **Any Other Business**

- Sara suggested that it would be good to do something on Fairtrade to raise awareness amongst new members. Hazel to consider. **Action: Hazel**
- Bethia had previously had some challenges with the Town Council. Sara suggested that working with the Area Committees might be effective?
- There was concern that Sainsbury's are changing their own brand tea to their own label "fairly traded" which will lead to customer confusion and takes the power away from the farmers. Hazel has written to Sainsbury's on the group's behalf and Julia has drafted a letter with several questions to them. ## **1. PURPOSE:**

- 1.1 To seek approval to convert the three existing Designated Public Place Orders (DPPO) (old legislation) into a Public Spaces Protection Orders (PSPO) (new legislation), in respect of Bailey Park, Abergavenny; Abergavenny Town, Abergavenny and Monmouth Town, Monmouth in Monmouthshire.

## **2. RECOMMENDATIONS:**

- 2.1 To approve the transition to Public Spaces Protection Orders in respect of Bailey Park, Abergavenny; Abergavenny Town and Monmouth Town in Monmouthshire.

## **3. KEY ISSUES:**

### **3.1 Key Issues - Bailey Park**

- 3.1.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Bailey Park connected to the consumption of alcohol. The boundary of the park is identified on the attached map at Annex A1.
- 3.1.2 The Designated Public Place Order was imposed in September 2008 by the Licensing Committee of Monmouthshire County Council.
- 3.1.3 The order provided the police with powers to deal with persons in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.
- 3.1.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20<sup>th</sup> October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, where they would then convert into a PSPO.
- 3.1.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB in Bailey Park between 2014 and 2017. Gwent Police complaints log are attached at Annex A2.

### 3.2 Key Issues – Abergavenny Town, Abergavenny

- 3.2.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Abergavenny Town connected to the consumption of alcohol. The boundary of the area concerned is identified on the attached map at Annex B1.
- 3.2.2 The Designated Public Place Order was imposed in September 2008 by the Licensing Committee of Monmouthshire County Council.
- 3.2.3 The order provided the police with powers to deal with persons in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.
- 3.2.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20<sup>th</sup> October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, where they would then convert into a PSPO.
- 3.2.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB in Abergavenny Town between 2014 and 2017. Gwent Police complaints log are attached at Annex B2.

### 3.3 Key Issues – Monmouth Town, Monmouth

- 3.3.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Monmouth Town connected to the consumption of alcohol. The boundary of the area concerned is identified on the attached map at Annex C1.
- 3.3.2 The Designated Public Place Order was imposed in October 2008 by the Licensing Committee of Monmouthshire County Council.
- 3.3.3 The order provided the police with powers to deal with persons in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.
- 3.3.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20<sup>th</sup> October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, where they would then convert into a PSPO.
- 3.3.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB Monmouth Town between 2014 and 2017. Gwent Police complaints log are attached at Annex C2.

## 4. REASONS:

- 4.1 Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 states Local Authorities have the responsibility to make a Public Spaces Protection Order providing two conditions are met:

- 4.2 The first condition is that –
- (a) Activities carried out in a public space within the authority's area have had a detrimental effect on the quality of life of those in the locality, or
  - (b) It is likely that activities will be carried on in a public place within that area and they will have such an effect.
- 4.3 The second condition is that the effect, or likely effect, of the activities –
- (a) Is, or is likely to be, of a persistent or continuing nature;
  - (b) Is, or is likely to be, such as to make the activities unreasonable, and,
  - (c) Justifies the restrictions imposed by the police.
- 4.4 A Public Spaces Protection Order is an Order that prohibits specified activities taking place in a restricted area.

## **5. RESOURCE IMPLICATIONS:**

- 5.1 The ASB Reduction Officer will work with Gwent Police and community partners as part of the substantive role to issue the Public Spaces Protection Order and Gwent Police will enforce the Order through their usual policing practices.
- 5.2 Should the Order be granted, there is a requirement for signage to be erected outlining the conditions of the Order. The cost of signage will be met from the Community Safety Grant funding.

## **6. WELLBEING OF FUTURE GENERATIONS IMPLICATIONS (INCORPORATING EQUALITIES, SUSTAINABILITY, SAFEGUARDING AND CORPORATE PARENTING)**

## **7. CONSULTEES**

- 7.1 Under the Anti-social Behaviour, Crime and Policing Act 2014, as no action has been taken by the council during the last three years (20<sup>th</sup> October 2014 to 20<sup>th</sup> October 2017) regarding the existing DPPO's, they will, from the 20<sup>th</sup> October 2017, be treated as PSPO's.
- 7.2 At this point there is no need for consultation until the three years of the order has elapsed.
- 7.3 However, consultation has taken place with the Chief Officer of Gwent Police for the concerned areas in order to establish the necessity of continuing with the restriction.
- 7.4 The below statutory partners and other identified stakeholders were emailed advising of the proposal and invited to provide feedback as part of the consultation. These include:
- Chief Constable, Gwent Police
  - Police & Crime Commissioner (PCC)
  - County Councillor, Priory, Castle, Grofield and Drybridge Wards
  - Gwent Police, Abergavenny and Monmouth local policing teams
  - MHA – Chief Executive and SLT

- MCC Car Park Manager
- MCC Head of Operations
- MCC Head of Legal
- MCC Head of Public Protection
- Abergavenny and Monmouth Town Council Clerks

7.5 The local police support the continuation of the restrictions imposed by the DPPO's in the form of the new PSPO's.

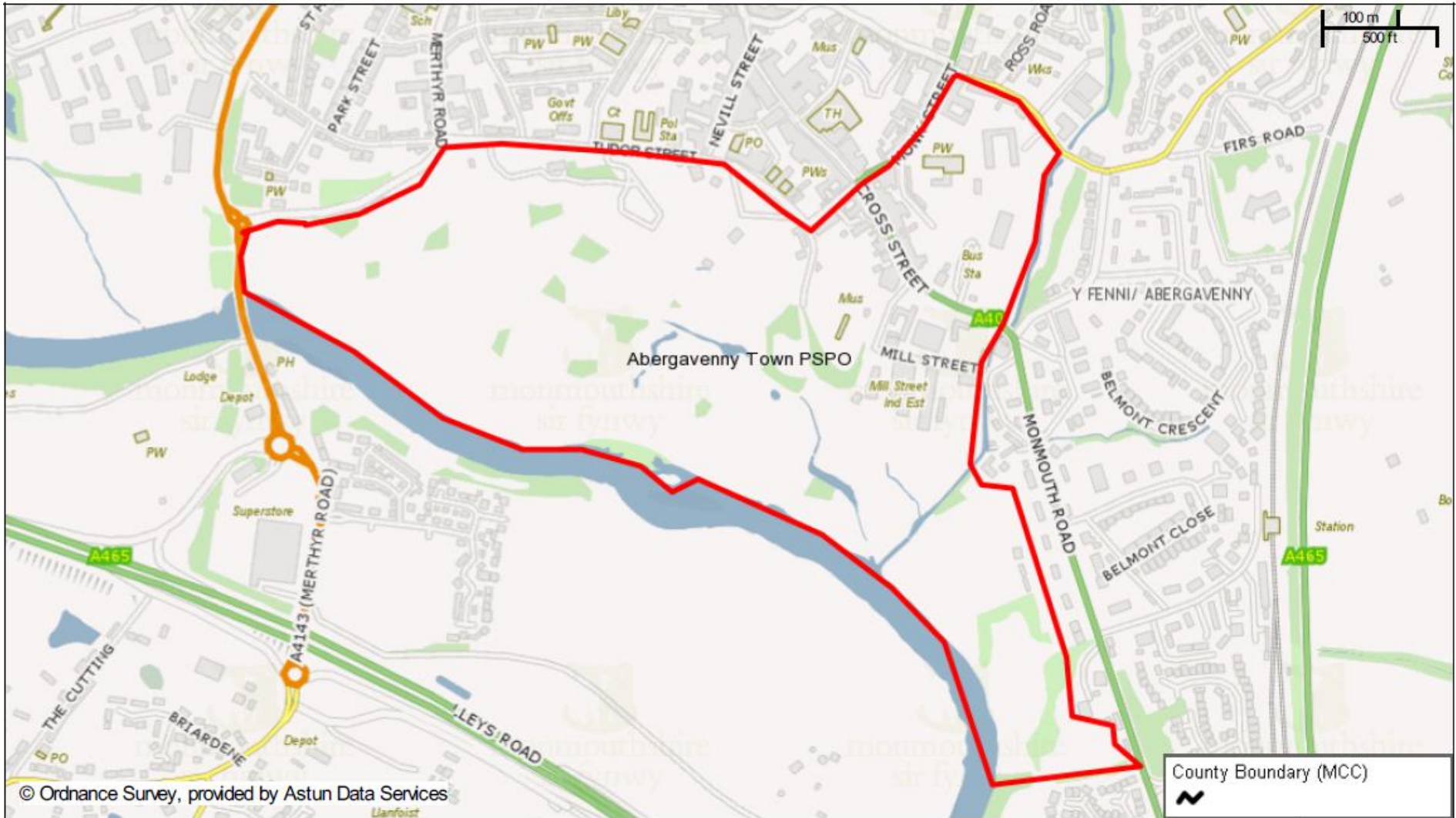

**MONMOUTHSHIRE COUNTY COUNCIL**  
**ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014**  
**Public Space Protection Order (PSPO) covering Bailey Park, Abergavenny**

Monmouthshire County Council (“the Council”) in exercise of its powers under Sections 59, 60, 62, 63, 66, 67, 68 and 72 of the Anti-social Behaviour, Crime and Policing Act 2014 (“the Act”) and all other enabling powers hereby makes the following order.

1. The Order shall come into operation on 20<sup>th</sup> October 2017 and shall have effect for a period of 3 years thereafter unless varied or discharged by further orders of the Council.
2. The Order relates to the areas defined edged red on the attached map(s) known as Bailey Park (referred to in this Order as “the Restricted Area”).
3. The Order is made because the Act allows for the transition of existing designated public place orders to convert to Public Space Protection Orders where three years has elapsed since the commencement date of the Act.
4. In making this Order consultation has not been required by the Act as the existing DPPO is converting to a PSPO on 20<sup>th</sup> October 2017 under Section 75 of the Act. However, consultation has taken place with representatives of the Chief Constable of Gwent Police, the Office of the Police and Crime Commissioner and relevant community representatives of the Town and Community Councils.
5. The effect of the Order is to impose the following prohibitions and requirements within any part of the Restricted Area.
  - 5.1. No person shall within the restricted area refuse to stop drinking alcohol or hand over containers (sealed or unsealed) which are believed to contain alcohol, when required to do so by an authorised officer to prevent public nuisance and disorder.**
  - 5.2. This Order does not prevent the taking place of community events organised by the Council**
6. Section 67 of the Act applies to the prohibitions and requirements set out in paragraphs 5.1 to 5.2 of this Order, namely:
  - 6.1. It is an offence for a person without reasonable excuse
    - a) To do anything that the person is prohibited from doing by paragraphs 5.1 to 5.2 of this Order
    - b) To fail to comply with a requirement to which a person is subject under paragraph 5.1 to 5.2 of this Order

- 6.2. A person guilty of an offence under this section is liable under summary conviction to a fine not exceeding level 3 on the standard scale (or to a Fixed Penalty Notice of a maximum of £100 as an alternative to the prosecution).
- 6.3. A person does not commit an offence under this section by failure to comply with a prohibition or requirement that the Council does not have power to include in the Public Spaces Protection Order

## 7. Appeals

- 7.1. Any challenge to this Order must be made in the High Court by an interested person within six weeks of it being made. 1. The Order shall come into operation on 20<sup>th</sup> October 2017 and shall have effect for a period of 3 years thereafter unless varied or discharged by further orders of the Council.
2. The Order relates to the areas defined edged red on the attached map(s) known as Abergavenny Town (referred to in this Order as “the Restricted Area”).
3. The Order is made because the Act allows for the transition of existing designated public place orders to convert to Public Space Protection Orders where three years has elapsed since the commencement date of the Act.
4. In making this Order consultation has not been required by the Act as the existing DPPO is converting to a PSPO on 20<sup>th</sup> October 2017 under Section 75 of the Act. However, consultation has taken place with representatives of the Chief Constable of Gwent Police, the Office of the Police and Crime Commissioner and relevant community representatives of the Town and Community Councils.
5. The effect of the Order is to impose the following prohibitions and requirements within any part of the Restricted Area.
  - 5.1. No person shall within the restricted area refuse to stop drinking alcohol or hand over containers (sealed or unsealed) which are believed to contain alcohol, when required to do so by an authorised officer to prevent public nuisance and disorder.**
  - 5.2. This Order does not prevent the taking place of community events organised by the Council**
6. Section 67 of the Act applies to the prohibitions and requirements set out in paragraphs 5.1 to 5.2 of this Order, namely:
  - 6.1. It is an offence for a person without reasonable excuse
    - a) To do anything that the person is prohibited from doing by paragraphs 5.1 to 5.2 of this Order
    - b) To fail to comply with a requirement to which a person is subject under paragraph 5.1 to 5.2 of this Order

- 6.2. A person guilty of an offence under this section is liable under summary conviction to a fine not exceeding level 3 on the standard scale (or to a Fixed Penalty Notice of a maximum of £100 as an alternative to the prosecution).
- 6.3. A person does not commit an offence under this section by failure to comply with a prohibition or requirement that the Council does not have power to include in the Public Spaces Protection Order
