

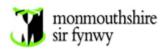



#### 1. PURPOSE:

To consider the proposed Order subsequent to representations received following advertisement in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1994.

#### 2. **RECOMMENDATIONS:**

Not to hold an inquiry into the proposal.

To approve the proposed Order as consulted and advertised upon to implement the Order. No objections to the proposals have been received during the consultation period.

#### 3. KEY ISSUES:

Monmouthshire County Council has previously received concerns from local community representatives regarding inappropriate and obstructive vehicle parking on the highway around the junction of the R1 within Llanvihangel Crucorney village.

#### 4. REASONS:

The junction by The Skirrid Inn is bounded by masonry walls. The presence of vehicles parking around this junction is considered to be a detriment to road safety and is a hazard to normal highway usage. The presence of parked vehicles also causes larger vehicles entering and exiting the village at this junction to have to veer into the opposite side of the carriageway thereby causing a road safety issue and potential conflict with oncoming vehicles and other highway users. The R1 is a relatively busy highway which also leads onto Hay on Wye via the Llanthony valley and is a very popular route to significant tourism sites within the valley and The Black Mountains e.g Llanthony Priory. Larger vehicles related to forestry and agricultural operations also use this junction within the village and are experiencing turning difficulties due to the presence of parked vehicles. Officers consider that in view of the fact that no objections have been received that the Council's proposals do not warrant the holding of any inquiry.




#### Schedule

- (a) The eastern kerbline of the northeasterly bound part of the R1 from a point 17 metres south west of its junction with the centreline of the northwesterly bound part of the R1 for a distance of 35 metres in a generally north easterly direction.
- (b) The western kerbline of the northeasterly bound part of the R1 from a point 19 metres south west of the centreline of the northwesterly bound part of the R1 for a distance of 10 metres in a generally north easterly direction.
- (c) The western kerbline of the northeasterly bound part of the R1 from a point 9 metres north east of the centreline of the northwesterly bound part of the R1 for a distance of 10 m in a generally north easterly direction.
- (d) The southern kerbline of the northwesterly bound part of the R1 from its junction with the northeasterly bound part of the R1 for a distance of 10 metres in a generally north westerly direction.
- (e) The northern kerbline of the northwesterly bound part of the R1 from its junction with the northeasterly bound part of the R1 for a distance of 10 metres in a generally north westerly direction.

#### **STATEMENT OF REASONS**

The council has received concerns from local stakeholders regarding inappropriate vehicle parking at this road junction. The R1 is the main route from Llanvihangel Crucorney up to the Llanthony valley. In the interests of road safety and ensuring the free flow of traffic it is necessary to prohibit waiting at any time on all approaches at this road junction within the village environment.

SUBJECT: USE OF S106 PLAY FUNDING IN WYESHAM

MEETING: SINGLE MEMBER DECISION

DATE TO BE CONSIDERED: 13th MARCH 2019

WARDS AFFECTED: WYESHAM, MONMOUTH

#### 1. PURPOSE

To seek member approval for the use of Section 106 play funding in Wyehsam, Monmouth.

#### 2. RECOMMENDATION

That the Section 106 funding received for play provision on the former Wyesham Infants School site be used to provide additional play equipment at the existing established play areas at Tudor Road and/or at Woodland View.

#### 3. KEY ISSUES

- 3.1 As part of the Section 106 Agreement for the redevelopment of the site of the former Wyesham Infants School, the developer made a contribution of £17,500 for the provision of a small children's playground on part of the site.
- 3.2 The development was completed before the play area was installed and, as part of the landscaping works for the site, a footpath was installed and tree planting undertaken on that part of the site proposed for the new play equipment.
- 3.3 Due to the very limited size of the site on which it was proposed to install play equipment, officers wrote to the developer requesting agreement to use the funding on one of the other play areas in Wyesham namely Tudor Road and Woodland View. Woodland View is a well-established play area and Tudor Road has recently been upgraded with a range of new equipment.
- 3.4 Unfortunately, no reply was received to that initial request and two further requests have been made in writing by the Council's solicitor again with no response having been received from the developer.
- 3.5 Under the terms of the Section 106 Agreement, the money for the play provision has to be used by 14<sup>th</sup> May this year, failing which it has to be returned to the developer. Officers want to avoid having to do that, as the significance of the Tudor Road site as a neighbourhood play area will increase in the foreseeable future when the allocated housing site served off Tudor Road is developed.

3.6 The local member and the immediate neighbouring properties have been consulted and they are in favour of the recommendation in this report.

#### 4.0 OPTIONS APPRAISAL

The options are to:

- 1. take no action and return the money to the developer with no additional play provision;
- 2. install a limited amount of play equipment on the originally approved site;
- use the funding to enhance the established play areas at Tudor Road and Woodland View, to which all children living in Wyesham have open access.

#### **5. EVALUATION CRITERIA**

Please see evaluation criteria set out in **Appendix A**.

#### 6. REASONS

- 6.1 To ensure the Section 106 funding received from the developer is used effectively to enhance fixed play provision in Wyesham.
- 6.2 Some of the Section 106 funding received from the same development has been used, in partnership with Transition Monmouth, to enhance the existing Claypatch woodland area opposite the former school site and this provides excellent informal play and recreation opportunities for children living in the locality.

#### 7. RESOURCE IMPLICATIONS

The S106 capital funding identified in this report has been received to improve play facilities in the local area, so the works proposed will not impact on existing capital or revenue budgets.



#### 2. RECOMMENDATIONS:

2.1 To approve the making of a common Public Spaces Protection Order in respect of All MCC owned Car Parks in Monmouthshire.

#### 3. KEY ISSUES:

- 3.1 Key Issues Vehicle related Anti-social Behaviour in MCC Car Parks
  - 3.1.1 For some years there have been complaints of Anti-Social Behaviour (ASB) linked to the use of motor vehicles and their occupants in a number of our MCC owned car parks. The source of these complaints has moved around as attention and action is focused in one area, then the process starts again for new complainants.
  - 3.1.2 New legislation provides us with the opportunity to put an order in place where we can anticipate issues are likely to occur, as well as dealing with current problem locations.
  - 3.1.3 In 2017 we tackled a similar issue in Fairfield Car Park, Abergavenny with a PSPO, in conjunction with other measures including the use of barriers.
  - 3.1.4 In the last year there has been a rise in this type of Vehicle related ASB in the Byefield Lane Car Park in Abergavenny and Welsh Street Car Park in Chepstow. Disruptive activity in Chepstow resulted in a shift to the Leisure Centre.
  - 3.1.5 In light of 3.1.4 this recommendation is an order to place the same restrictions in all our MCC car parks. See point 4.5 below.
  - 3.1.6 Vehicle related disorder in and around the car park tends to occurr during the evenings from 6pm, and at weekends this can continue until 4am.

    These times will vary with the change of seasons and prevailing weather conditions.

- 3.1.7 Some adverse activity has been reported during the day especially around Bank Holidays, however, the detrimental impact to the locality is naturally lower when combined with other daytime noise.
- 3.1.8 This order is not looking to criminalise people who use the car parks legitimately or those that congregate in an orderly manner that does not adversely affect others in or within earshot of the car park.
- 3.1.9 Examples of ASB activity reported includes:
  - Driving erratically, racing around and doing doughnuts
  - Excessive noise from car music systems and amplified devices
  - Loud exhaust systems whether modified or illegal
  - Unnecessary sounding of horns
  - Speeding vehicles with increased engine revs
  - Concerns with substance misuse, drug exchanges and use
  - Gathering in groups in the car park with associated anti-social behaviour and noise
  - Litter being left in the area
  - Some associated threatening and intimidating behaviour.
- 3.1.10 There have been a numerous calls to Gwent Police complaining about vehicle related ASB. An example of Gwent Police complaints log are attached at **Appendix 2**. It is possible the record minimises the extent of the ASB as residents have raised issues when using 101 due to delays in answering, which may have prevented more complaints being logged and a reduced the number of recorded complaints.
- 3.1.11 We also have a detailed diary maintained by a victim who has witnessed first hand the behaviour in Byefield Lane car park. **Appendix 3**.
- 3.1.12 Gwent Police have taken a number of steps to reduce ASB in these areas, including the issue of 35 individual Section 35 Direction to Leave 'Dispersal Notices' over a period of one weekend. Individual notices only last 24 hours whereas a PSPO would last up to 3 years.
- 3.1.13 Other actions utilised to try and reduce ASB in these areas have included:
  - Installation of a barrier gate to the Fairfield car park reducing the available space during certain hours.
  - Flow plates fitted to the exit of the car park to prevent re-entering.
  - Police issuing Sec 59 Warnings to drivers seen committing ASB or driving without due care and attention. This gives police the power to seize an offending vehicle if behaviour is repeated within twelve months.

#### 4. REASONS:

- 4.1 Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 states Local Authorities have the responsibility to make a Public Spaces Protection Order providing two conditions are met:
- 4.2 The first condition is that -

- (a) Activity carried out in a public space within the authority's area have had a detrimental effect on the quality of life of those in the locality, or
- (b) It is likely that activity will be carried on in a public place within that area and it will have such an effect.
- 4.3 The second condition is that the effect, or likely effect, of the activity
  - (a) is, or is likely to be, of a persistent or continuing nature;
  - (b) is, or is likely to be, such as to make the activities unreasonable, and,
  - (c) justifies the restrictions imposed.
- 4.4 A Public Spaces Protection Order is an Order that prohibits specified activities taking place in a restricted area.
- 4.5 The proposal would be to apply for the conditions to be approved for all MCC car parks because this issue tends to be of a transient nature and will move from one area to another. So rather than submit a Report each time a new car park is affected, this report will lay out the standard restrictions applicable to all car parks with a proviso that they will be implemented as an when a situation arises.
- 4.6 In effect, the PSPO will be in force from the date of the signing of this report, but will remain dormat, until such time as it is activated by the displaying of the required signage in the specified 'Restricted Area'.

#### 5. RESOURCE IMPLICATIONS:

- 5.1 The Community Safety Officer will work with Gwent Police and community partners as part of the substantive role to issue the Public Spaces Protection Order. Gwent Police and MCC will enforce the Order using policing practices and MCC Fixed Penalty Notices, on behalf of MCC.
- 5.2 The imminent creation of an Enforcement Team within MCC for Parking Offences will additionally be given the powers to issue FPN for Breach of PSPO.
- 5.3 Should the Order be granted, there is a requirement for signage to be erected outlining the conditions of the Order in the restricted areas. The cost of the signs will be sought by the Community Safety team.

# 6. WELLBEING OF FUTURE GENERATIONS IMPLICATIONS (INCORPORATING EQUALITIES, SUSTAINABILITY, SAFEGUARDING AND CORPORATE PARENTING)

- 6.1 This PSPO will have a significant positive impact on the local community as it will prevent any further exposure to ASB and its detrimental impact on the quality of life to residents, local businesses and the community, thus contributing positively to a more Prosperous Wales, Healthier Wales and a Wales of Cohesive Communities. There are no negative impacts on the wellbeing goals.
- 6.2 The whole community will benefit, including those from all protected characteristics. A small minority of young people may perceive there to be a negative impact on age, but the aim is to prevent unsocial gatherings of 'car enthusiast's' who play loud music through car stereos or amplified means, who drive dangerously and make excessive noise by loud engine revs or exhaust

systems designed to amplify noise. Furthermore the amount of litter left behind and the intimidating nature of the group.

#### 7. CONSULTEES

- 7.1 Consultation must be undertaken when making, extending, varying or discharging a Public Spaces Protection Order.
- 7.2 The necessary consultees prescribed in the Anti-social Behaviour, Crime and Policing Act 2014 are:
  - (a) The Chief Officer of Gwent Police, the local policing body and Police Crime Commissioner (PCC) for the Gwent Police area that includes the restricted area:
  - (b) Whatever community representatives the local authority thinks it appropriate;
  - (c) The owner or occupier of land within the restricted area.
- 7.3 All necessary consultees have been contacted in respect of the public consultation to comply with the legislation.
- 7.4 An initial consultation meeting was held with key stakeholders at Safer Monmouthshire Group on 20<sup>th</sup> December 2018 which confirmed support for the Order.
- 7.5 A formal consultation period of 21 days was held, ending on 21st February 2019.
- 7.6 All statutory partners and other identified stakeholders were emailed a copy of the consultation letter to advise of the proposal and invited to provide feedback as part of the consultation. These include:
  - Chief Constable, Gwent Police
  - Police & Crime Commissioner (OPCC)
  - MP Monmouthshire
  - Assembly Member, Monmouthshire
  - County Councillors,
  - Gwent Police, Geographic Inspector for Monmouthshire
  - MCC Chief Executive
  - MCC Youth Service Manager
  - MCC Car Park Manager
  - MCC Head of Operations
  - MCC Head of Public Protection
  - MCC Head of Social Care
  - Members of Safer Monmouthshire Group
  - Members of PSB Programme Board
  - Town Council Clerks.
- 7.7 The Consultation has also been placed on the MCC and Gwent Police website, Facebook & Twitter feeds, inviting members of the public to have their say. Copy of Consultation letter in **Appendix 4.**
- 7.8 There have been 54 responses to the external online consultation with 48 people supporting the proposal and 6 objections. There have been no objections to the

proposal to make the Order from the Statutory partners listed in 7.6 above. Some examples of the feedback can be viewed as **Appendix 5**.

7.9 A draft PSPO is attached as **Appendix 6.**

#### Appendix 2 - Police Report and some examples of Incident Logs

For a sustained period of time (although reported incidents and persons involved have been changeable) there has been reports made by several members of the public complaining of anti-social behaviour in WELSH STREET CAR PARK, CHEPSTOW. The reports involve persons congregating in vehicles, driving in an anti-social manner, playing loud music and being a general nuisance during the evenings and into the night.

Efforts have been made by Police to deal with the ongoing problem and methods have included: education-speaking with the persons involved and advise them reference their behaviour; prevention- patrolling the car park when able to provide a visible deterrent to the anti-social behaviour; enforcement- the issuing of Section 59 warnings for anti-social use of the vehicles. CCTV have also been provided with information to help assist in identifying and capturing evidence of offending persons and vehicles. The issues still exist and at present there appears to be a growing amount of vehicles and persons attending the car park each evening.

#### INC 586 16/06/18- Report from a resident of Chepstow

Report of around 15 cars being noisy in the car park near to midnight. Earlier the same evening Police had attended and advised the driver's reference noise. An amount of nitrous oxide canisters were also seized from one driver who had travelled from the Coleford area.

#### INC 607 15/06/18- Report from resident of Dell View, Chepstow

Report of a group of 20 youths in 6 vehicles congregating at the car park, playing loud music and racing their cars. It is becoming a nightly occurrence and affecting a number of residents.

#### INC 593 12/06/18- Report from resident of Chepstow

Report from a member of the public who stated that they had to jump out of the way of a speeding vehicle in the car park where a number of vehicles tend to congregate.

INC 546 07/06/18- Report from \_\_\_\_\_, Chepstow

Report of numerous vehicles wheel spinning and making noise in the car park. The caller stating that were making complaints of the noise to her and that it is an ongoing issue.

#### INC 596 06/06/18- Report from resident of Bank Street, Chepstow

Report of a large groups of youths playing football near to vehicles and the football hitting parked and unattended vehicles.

INC 9 03/06/18- Report from owner \_\_\_\_\_, Chepstow

Report of group of males playing football in the car park and doing doughnuts in vehicles. This was reported as happening after midnight.

INC 549 25/05/18- Report from resident Chepstow, Chepstow

Report of a group of youths playing football, shouting, swearing and speeding around the car park. residents have been complaining of the noise.

#### INC 507 24/05/18- Report from resident of Beaufort Square, Chepstow

Report of cars revving and driving in and out of the car park with their music blaring. They are also playing football, which is hitting resident's cars.

## INC 459 224/03/18- Report from resident Chepstow

Report of cars engines revving, beeping horns and loud music. Affecting the callers business as he runs a ...

#### INC 233 05/0318- Report from resident of Chepstow

Report of persons parked in vehicles in the car park that are smoking cannabis.

#### INC 5 28/01/18- Report from a resident of Chepstow

Report of nearly being run over in the car park as a number of vehicles were being driven around dangerously. This was reported just after midnight.

#### INC 168 08/01/18- Police generated activity

Driver of vehicle parked in the car park found by Police to be smoking cannabis.

### Appendix 4 – Proposal letter (General)

Dear To it May Concern

## **Public Spaces Protection Order Consultation**

The Safer Monmouthshire Group has received reports of anti-social behaviour caused by groups of people congregating in vehicles and around vehicles in several of MCC car parks in particular; Fairfield and Byefield Car Parks, in Abergavenny and Welsh Street and Leisure Centre car parks in Chepstow. The complaints have been quite specific in nature and focused around the activities of these individuals causing anti-social behaviour through noise from loud amplified music, loud exhausts, unnecessary sounding of the horn, screeching tyres and associated issues. These activities have given rise to concerns for those who use these areas on a daily basis and live in properties nearby. Despite continued efforts by partner agencies, the nuisance continues and shows no signs of stopping without legal intervention.

It is in this respect that I am writing to you today under the Anti-social Behaviour, Crime and Policing Act 2014 which allows for the making of a Public Spaces Protection Order in cases where the Local Authority feels that such action is justified to stop anti-social behaviour.

A Public Spaces Protection Order will not stop the lawful use of a car park. People who wish to use the restricted area will be able to continue to do so under the current terms of use. The Order will allow us to consider prosecution for anyone who is in breach of the prohibitions contained within the Order.

The prohibitions are listed below for your consideration;

- Prohibition of the playing of music emitting from any vehicle or by means of portable amplified device between the hours of 1800 and 0800 Monday to Sunday, inclusive, except with the express permission of the Council
- Prohibition of congregating and loitering in groups around (or in) one or more vehicles and engaging in behaviour which is likely to cause noise, harassment, alarm and distress between the hours of 1800 and 0800 Monday to Sunday, inclusive.
- No 'doughnutting', racing or other vehicle nuisance
- Mechanically propelled vehicles are not to be driven in an anti-social manner which may cause harassment, alarm or distress to other persons
- No person will engage in any activity which is offensive, anti-social, indecent or causes distress to any member of the public
- No person using the car park shall be in unlawful possession of controlled drugs or drugs paraphernalia, with the intent to supply or share.

In proposing to make a Public Spaces Protection Order, Monmouthshire County Council and Gwent Police are satisfied that the behaviours exhibited by some individuals in the car parks are having, have had or are likely to have a detrimental effect to the quality of life of those in the locality, is persistent in nature and the behaviours reported by members of the public justifies the restrictions imposed.

A consultation period will be open for twenty one days from the date of this letter during which time I would ask you to contact me should you have any queries or concerns about the restrictions of the Order or if you wish to confirm your support or object to the Order being made.

At the end of the consultation period a decision will be taken as to whether the making of the Order is in the public interest. Your views will be considered prior to a decision being made and will be

balanced against the need to stop any unacceptable behaviour for the safety and security of those who use the named carpark and surrounding area.

4. My only suggestion would be to remove the "with the intent to share" part from the possession of drugs paraphernalia if you feel you can justify it.

That way if we are searching under S23 for drugs then we can still seize and prosecute for possession of paraphernalia as a breach of PSPO but I think we would find it near impossible to

prove intent to share without one of their mates grassing them up or an officer witnessing them sharing.

- 5. Good morning Andrew, we have read through the consultation letter and the PSPO thoroughly now and have a few comments / questions: My answers in red.
  - 1. Its application to 18.00 to 08.00 Monday to Sunday would not include the activity during the afternoons that may occur on Sat / Sun and public holidays. Is it possible for any modification to the time window?

Although there is the occasional reference to daytime activity the over-whelming period of complaints are during the evening and early hours of the night. Also it could be argued that during the day time the adverse nature of the noise would have less of an overall impact. Items 5.3 to 5.6 are not time restrained. However, there will be room for manoeuvre before the final submission based on the feedback.

2. We all understand I think what 'doughnutting' means but would it be enforceable as an identified activity-perhaps this doesn't matter as the phrase after this does also include 'racing or other vehicle nuisance'.

As you say I believe we have most, if not all, acts of bad driving covered that could be construed in one category or the other.

3. I guess the fixed penalty of £100 cannot be increased a bit? I presume the level 3 ceiling is £1000 which is appropriate.

The maximum fixed penalty amount is set in the Act and this is the maximum. The alternative way of dealing with an offender is to report for process whereby a summons is issued to go straight to court. This can be used where a FPN has already been issued or in other circumstances where a FPN is deemed not appropriate.

4. I guess section 6.3 has to be there as it's probably standard jargon all these orders have to contain?

Yes just the small print. If we were making a condition that was unreasonable or was outside our legal power to impose, then a person would not commit an offence of failing to comply.

5. In 7.1, I don't know what the 'Restricted Area' is? It's saying you have to be 'in' the restricted area to appeal; if the restricted area is only the car park itself then people living around the car park are not in the area but that's fine as far as we are concerned as we don't want anyone to appeal against the order....!

The 'Restricted Area' is defined as the area to which these conditions apply and a map will be produced outlining the perimeter of the car park. The area inside the perimeter will be the 'Restricted Area'. This provides a person who lives <u>in the area</u>; or who <u>regularly</u> works in or visits the area to challenge the order once it has been made within the first six weeks. (The wording could have been a little clearer). I guess this is in case someone misses the consultation process and has something to say about the order. They can only challenge on the two grounds stated in 7.2. The challenge is made in the High Court.

Thanks again for giving us the opportunity to comment, my comments above are all. I or except number 1.

#### **RE: PUBLIC SPACES PROTECTION ORDER CONSULTATION**

Abergavenny Town Council, at their meeting on Wednesday 13<sup>th</sup> February, discussed the proposal to make a Public Spaces Protection Order (PSPO) covering all car parks in Monmouthshire.

The Town Council is concerned about the levels of anti-social behaviour in car parks in Abergavenny and welcomes the measures being taken to address these issues. However, councillors are concerned that tackling anti-social behaviour in one car park will result in the behaviour being transferred to another car park. Having a PSPO for all car parks will provide agencies with the necessary powers to take action.

#### **DRAFT**

Monmouthshire County Council ("the Council") in exercise of its powers under Sections 59, 60, 62, 63, 66, 67, 68 and 72 of the Anti-social Behaviour, Crime and Policing Act 2014 ("the Act") and all other enabling powers hereby makes the following order.

- The Order shall come into operation on XX XXXXXX 2019 and shall have effect for a period of 3 years thereafter, unless varied or discharged by further orders of the Council.
- 2. The Order relates to the geographical areas as defined edged red on the attached map, known as \*\*\*\*\*\*\*\*

  Car Park (referred to in this Order as "the Restricted Area").
- 3. The Order is made because the Council is satisfied on reasonable grounds that activities at the Restricted Area are having a detrimental effect on the quality of life of those in the locality, or it is likely that activities will have such an effect, and that the effect is, or will be, of a persistent or continuing nature and is, or will be, unreasonable and justifies the restrictions imposed by the Order.
- 4. In making this Order consultation has taken place with the Chief Constable, the Office of the Police and Crime Commissioner, relevant community representatives, the Town and Community Councils, and owners/occupiers of the Restricted Area (where relevant) and of neighbouring properties.
- 5. The effect of the Order is to impose the following prohibitions and requirements within any part of the 'Restricted Area'.
  - 5.1. Prohibition of the playing of music emitting from any vehicle or by means of portable amplified device between the hours of 1800 and 0800 Monday to Sunday, inclusive, except with the express permission of the Council
  - 5.2. Prohibition of congregating and loitering in groups around (or in) one or more vehicles and engaging in behaviour which is likely to cause noise, harassment, alarm and distress between the hours of 1800 and 0800 Monday to Sunday, inclusive.

- 5.3. No 'doughnutting', racing or other vehicle nuisance
- 5.4. Mechanically propelled vehicles are not to be driven in an anti-social manner which may cause harassment, alarm or distress to other persons
- 5.5. No person will engage in any activity which is offensive, anti-social, indecent or causes distress to any member of the public
- 5.6. No person using the car park shall be in unlawful possession of controlled drugs or drugs paraphernalia.
- 6. Section 67 of the Act applies to the prohibitions and requirements set out in paragraphs 5.1 to 5.6 of this Order, namely
  - 6.1. It is an offence for a person without reasonable excuse
    - a) To do anything that the person is prohibited from doing by paragraphs 5.1 to 5.6 of this Order
    - b) To fail to comply with a requirement to which a person is subject under paragraph 5.1 to 5.6 of this Order
  - 6.2. A person guilty of an offence under this section is liable under summary conviction to a fine not exceeding level 3 on the standard scale or by Fixed Penalty Notice of £100.
  - 6.3. A person does not commit an offence under this section by failure to comply with a prohibition or requirement that the Council does not have power to include in the Public Spaces Protection Order
  - 6.4. This Order does not prevent the taking place of community events organised by the Council

#### 7. Appeals

- 7.1. Any challenge to this Order must be made in the High Court by an interested person within six weeks of it being made. An interested person is someone who lives in the area; or who regularly works in, or visits any of the area. This means that only those who are directly affected by the restrictions have the power to challenge.
- 7.2. The right to challenge also exists where an Order is varied by the Council. Interested persons can challenge the validity of this Order on two grounds: 1. that the Council did not have power to make the Order, or to include particular prohibitions or requirements; or 2. that a requirement of the legislation was not complied with in relation to the Order.

# NOISE Nuisance Diary Sheet Guidance

If the individual responsible for the **NOISE** nuisance does not resolve the matter when it is drawn to their attention informally, then a formal approach may be necessary.

It is important to remember that the matter could eventually result in legal proceedings and it will be necessary to demonstrate the existence of a statutory nuisance. If the matter progresses to this stage it is possible that you will be required to attend court as a witness and the evidence you present will need to stand scrutiny.

The accompanying diary sheet will enable you to record details of the **NOISE** in a structured fashion and you will be able to refer to this when preparing a statement of witness.

The details you enter on to the record must be tidy, easy to read and without codes or abbreviations. The following points are particularly relevant:

#### **Date**

It is helpful not only to record the dates when the **NOISE** occurs but also those occasions when you are away from your home for extended periods e.g. on holiday. This will provide an indication of the length of time that you have to endure the alleged nuisance while at home and whether the problem is intermittent etc. Information must be recorded in date order and as it occurs – avoid entering details at a later date!

#### Time

Please indicate clearly whether the time is am or pm. Recording the NOISE must begin when it becomes noticeable because this will allow any patterns to be identified. However, just because you can hear a NOISE does not mean that it is a statutory nuisance. Please indicate, therefore, when the NOISE actually starts to interfere with the enjoyment of your property. In a similar fashion, please make a record of when the NOISE ceases to be an inconvenience.

#### **Duration**

This is the length of time each **NOISE** event has caused inconvenience. It may be of relatively short duration or could be for an extended period of time.

#### **Climatic Conditions**

If the NOISE you are experiencing appears to change depending on the weather, e.g. it may be worse when the wind blows from a certain direction, record the climatic conditions at the time the NOISE occurs.

#### Location

This is the location where the NOISE is heard. Is the NOISE detected inside or outside of your house, or both? In which rooms inside your house is the NOISE heard? Is the NOISE LOUDer in some rooms as opposed to others? Is the NOISE LOUDer outside your house or inside your house? Does it make any difference having the windows open or closed?

### Description of **NOISE** and its effect

It is important to describe the nature of the **NOISE** nuisance you are suffering and the reason why it is causing you irritation.

Describe the nature of the NOISE, for example can you hear mainly bass or is the pitch high? Please also indicate the effect the NOISE is having on you, for example does the NOISE mean you have to close the windows or does the NOISE disturb your sleep or mean you are unable to read or watch television?

#### Signature

The person who witnesses the problem must sign the record to confirm the accuracy of the details. If this person is different to the person who has made the complaint, then their relationship to the complainant must be explained and contact details provided. Such individuals can have a valuable role as witnesses in demonstrating the existence of a NOISE problem.

The record should be kept for the time specified. After this time, the record should be sent back to this office. It will however be necessary for you to keep an ongoing diary until the problem is resolved.

Should you require any additional diary sheets, contact this office.

Your assistance in completing and maintaining the record is essential if the problem is to be dealt with successfully. Without your cooperation, the local authority may not be able to take any action to resolve the problem.

If you have any difficulty completing this log sheet please contact the investigating officer who will try to suggest alternative methods for you to keep a record of the **NOISE** disturbance.



**FUNDING FORMULA.** 

MEETING: INDIVIDUAL CABINET MEMBERS DECISION

DATE: 13th MARCH 2019 DIVISION/WARDS AFFECTED: All

#### 1. PURPOSE:

The purpose of this report is agree changes to the funding formula for Mounton House Special School.

#### 2. RECOMMENDATIONS:

To agree to reduce the funding for Mounton House Special School by £275,000 as part of the budget setting for Monmouthshire County Council 2019-20.

#### 3. KEY ISSUES:

#### **Background**

- 3.1 The funding formula for schools is regularly reviewed for schools to ensure that the funds are distributed fairly.
- 3.2 The consultation document attached in appendix 1 identifies the issues with the current formula and the reasons to make the changes.
- 3.3 The formula for Mounton House Special School was last reviewed in 2015, at this stage there were 42 pupils in the school. This included 18 residential places.
- 3.4 At the time of writing the consultation document there were 21 pupils on roll, with one residential pupil. The number of residential pupils has increased to 2.
- 3.5 Of these pupils 5 are from Monmouthshire.
- 3.6 The current funding for the school is £1,559,952 with the latest forecast from the school indicating a surplus of £81,880.
- 3.7 This proposal will reduce the funding to £1,284,952. It will be the governing body to decide how to reduce the costs to balance the budget. While a number of staffing changes have taken place during this year, which will have a favourable impact on the budget there will be a requirement to consider all costs.
- 3.8 The consultation period is for 4 weeks and closed on 22<sup>nd</sup> February 2019 (noon).
- 3.9 The Headteacher has met with the CYP finance manager to discuss the proposal and to help identify areas of savings.
- 3.10 There have been 4 responses and these are shown in appendix 5.

#### 4. OPTIONS APPRAISAL

This option was put forward given the recent reduction in pupil numbers at the school. The alternative would be to reduce funding for all Monmouthshire schools via a formula change, however all other schools are not facing the same reduction in pupil number and therefore this proposal was considered the preferable one.

#### 5. REASONS:

Due to the reduction in pupil numbers this proposal seeks to reduce the funding for Mounton House Special School in line with this reduction.

#### 6. RESOURCE IMPLICATIONS:

There will be a saving of £275,000 which will not be re distributed to other schools, but will be used as a saving to offset the shortfall in the 2019-20 Monmouthshire County Council Budget.

#### 1. Background

- 1.1 The school budget forum reviews the funding formula for school regularly to ensure that the funding is distributed to schools in the fairest way.
- 1.2 Following a meeting of the School Budget Funding Forum on the 24<sup>th</sup> January 2019, members agreed to consult on the funding formula for Mounton House Special School.

#### 2. <u>Issues with current arrangements</u>

- 2.1 The current formula provides funding for both day and residential pupils attending the school. The current placement funding is 42, this includes capacity for 18 residential pupils.
- 2.2 Currently there are 21 pupils on role with 1 pupil being residential. Of these pupils 5 are Monmouthshire pupils.
- 2.3 The funding formula was last reviewed in 2015 this was following the reduction of the number of pupils on role at that time. At this time there were 42 pupils on role.

#### 3. Proposal.

- 3.1 The proposal is to change the formula to fund on a lower number of pupils to reflect the actual numbers on roll. This will equate to a reduction of £275,000.
- 3.2 Appendix 1 details the current and proposed funding, while the reduction has been assumed as a lump sum in emotional and behavioural difficulties, it will be the decision of the Governing Body as to where the savings are made. This is based on the funding for 2018-19.
- 3.3 The reduction in funding would not be redistributed to other schools it would be used as a saving to close the gap on the wider Monmouthshire County Council budget for 2019-20.
- 3.4 The local authority will work closely with the Governing Body to achieve the savings. All Monmouthshire policies will be followed and advice will be provided by employee services, finance and any other relevant officers.
- 3.5 The consultation closes noon on the 22<sup>nd</sup> February 2019. The consultation questions are listed below and a proforma to respond is attached in appendix 2.

#### **County Councillor's response:**

I have read the consultation and I agree with the proposals.

#### **Monmouth Comprehensive response:**

We agree with the proposed funding reduction to reflect the actual number of students accessing the Mounton House provision.

Consideration should be given to the longer term future of the Mounton House provision. It will still cost £1.2m each year for 21 students (1 residential) and only 3 are resident in Monmouthshire. The current designation for Mounton House is restrictive both in terms of facilities (male only) and conditions which calls into question its viability for in County placements. The Governors of Mounton House want to extend the admission conditions but it is not clear that this will bring it back into long term viability and large-scale remodelling of the building for a new start and wide-ranging admissions would be cost prohibitive.

#### **CYP Select Committee response:**

#### Purpose:

The purpose of this report is to seek the view of the CYP Select members regarding the consultation on the proposed changes to the funding formula for Mounton House Special School.

#### **Key issues:**

Background

- 1. The funding formula for schools is regularly reviewed for schools to ensure that the funds are distributed fairly.
- 2. The consultation document attached in appendix 1 identifies the issues with the current formula and the reasons to make the changes.
- 3. The consultation document details the list of consultees this includes all elected members.
- 4. The consultation period is for 4 weeks and closes on 22nd February 2019 (noon).
- 5. The Headteacher has met with the CYP finance manager to discuss the proposal.

3.6 At the time of writing this paper no responses have been received, however all responses up to the closing date will be included in the cabinet paper for the meeting on 6th March 2019.

#### **Member Scrutiny:**

The Children and Young People Finance Manager presented the report seeking the views of the Select Committee on proposals to alter the funding formula for Mounton House Special School. Following presentation of the report, questions and comments were invited. Members were informed that these would be added as consultation feedback.

- A Select Committee Member supported making the funding formula appropriate
  to the needs and requirements of schools but expressed concern that changing
  the formula would effectively remove £275,000 from the Education budget. It was
  accepted that there is a gap between the funding received by the authority and
  the costs of services; Children and Young People Directorate have to contribute
  towards this and various options have been considered. Formula funding of
  school budgets is based on pupil numbers; these have reduced at the school.
- In response to a query, it was confirmed that a formal response from the Governing Body has not yet been received.
- A Select Committee Member, in response to a question, was informed that
  income from out of county pupils is held centrally and this is has been reported as
  a budget pressure as numbers have reduced.
- Seeking clarification of the total funding, a Select Committee Member was informed that the school received funding of £1,559,000, centrally, £756,000 is recouped from other authorities leaving the net running costs of the school as £803,000. £275,000 for SEBD (Social Emotional and Behavioural Difficulties) has been removed from the funding as explained in the consultation report. It is anticipated that the out of county pupil income will be reducing to £350,000 because of reduced admissions.
- A Member expressed surprise that the number of pupils in the school are reducing and questioned if some pupils were being retained in mainstream schools with support. The Chief Officer explained that there had been a steady decline, adding that the restrictive profile of the school plus the impact of neighbouring authorities making their own provision is affecting admission numbers. He confirmed that proactivity on inclusion in mainstream is encouraged.
- A Select Committee Member asked about the numbers of out of county pupils and was advised that, next year there will be half as many as this year.

#### **Committee Conclusion:**

The Select Committee considered the recommendation to scrutinise and provide feedback. Upon being put to the vote, the following votes were recorded:

#### 1. PURPOSE:

That Cabinet approves the adoption of a High Street and Retail Rate Relief Scheme for 2019/20, in accordance with Welsh Government guidance.

#### 2. RECOMMENDATIONS:

That Cabinet agree to -

- implement a High Street and Retail Rate Relief Scheme for 2019/20, in accordance with the guidelines stipulated by the Welsh Government in Appendix One
- accept the funding award from Welsh Government and the conditions relating to the funding
- apply this relief directly to eligible ratepayer accounts, subject to State Aid limits
- delegate decisions for any appeals to the Chief Officer and Cabinet Member for Resources

#### 3. KEY ISSUES:

- 3.1 The Welsh Government have agreed to provide grant funding to continue the High Street and Retail Rate Relief scheme for 2019/20.
- 3.2 The High Street and Retail Rate Relief scheme is part of a package of measures Welsh Government have in place to support business. This includes the Small Business Rate Relief Scheme (SBRR), which provides properties with a rateable value up to £6,000 with 100% relief and properties with a rateable value between £6,001 and £12,000 with tapered relief. This relief is applied to up to two properties in each local authority.

- 3.3 The package also includes the Transitional Relief Scheme that was put in place following the 2017 revaluation. This is the final year of the scheme that provides tapered relief over a three year period to eligible businesses (relief of 75% in 2017/18, 50% in 2018/19 and 25% in 2019/20).
- 3.4 Both Small Business Rate Relief and Transitional Relief is automatically applied to qualifying business rate relief accounts.
- 3.5 The 2019/20 High Street and Retail Rate Relief Scheme is broadly similar to the 2017/18 and 2018/19 schemes. There are however two main differences:
  - Previous schemes have operated a two tier approach to the amount awarded. Under this year's scheme, these have been abolished with one maximum award of £2,500 introduced for all eligible ratepayers.
  - The 2019/20 scheme is not limited to high street premises and now includes all properties that meet the retail criteria regardless of where they are situated.
- 3.6 Full details of the 2019/20 High Street and Retail Rate Relief Scheme can be found in Appendix One. Summarised below are the key details.
- 3.7 The scheme provides support for eligible retail businesses by offering up to £2,500 discount per property to retailers occupying premises on 1<sup>st</sup> April 2019 with a rateable value between £6,001 and of £50,000.
- 3.8 The Retail Relief will be applied to the net bill after all other reliefs and discounts are applied. The maximum amount of this relief will be no more than the value of the net rate liability. Ratepayers that occupy more than one property are entitled to Retail Relief for each of their eligible properties, subject to State Aid limits.
- 3.9 This relief will be granted to businesses as a one off payment and is based on occupation as at 31<sup>st</sup> March 2019 (providing the same occupier continues to be in occupation on 1<sup>st</sup> April 2019). Where the Authority is retrospectively notified of a change in occupier, who is in occupation on 1<sup>st</sup> April 2019, the local authority can use its discretion in awarding this relief.
- 3.10 Properties that will benefit from the Retail Scheme will be occupied retail properties such as shops, restaurants, cafes and drinking establishments. To qualify for the relief the hereditament should be wholly or mainly used as a shop, restaurant, and cafe or drinking establishment. This is a test on use rather than occupation. Therefore, hereditaments, which are occupied but not wholly or mainly used for the qualifying purpose, will not qualify for the relief. Examples of eligible businesses can be found on page 3 of Appendix One.
- 3.11 Unlike previous years, the 2019/20 scheme is not limited to high street premises but will include all properties meeting the wider retail criteria.
- 3.12 Properties that are not considered to be eligible and are therefore excluded from the scheme are properties:
  - that are not occupied on 1<sup>st</sup> April 2019
  - that are being used wholly or mainly for the provision of services to visiting members of the public, as listed on page 4 of Appendix One
  - with a rateable value of more than £50,000

- that are not reasonably accessible to visiting members of the public
- that are owned, rented or managed by a local authority
- that are in receipt of mandatory charitable rate relief
- 3.13 It is for each local authority to determine how they wish to administer the scheme. The recommendation is for the Council to deem properties listed in the Welsh Government Guidance as being eligible or ineligible. As with last year, the Welsh Government believes that this relief can be directly applied to eligible ratepayers' bills.
- 3.14 As the Welsh Government have provided details of the 2019/20 Scheme earlier than in previous years, we plan to apply the High Street and Retail Rate Relief to our 2019/20 rate bills that will be issued towards the end of March 2019. If for any reason we are unable to provide this relief on these annual bills, the guidelines require the Authority to notify eligible ratepayers that they qualify for the relief and that their bills will be recalculated.
- 3.15 If Cabinet resolves to adopt the scheme, based on previous year's data, around 400 businesses will benefit from this additional relief.

#### 4. OPTIONS APPRAISAL

The details of the scheme are largely prescribed by Welsh Government. Should the Authority decide not to award this additional relief, this would have a detrimental effect on the County's small businesses.

#### 5. EVALUATION CRITERIA

Not applicable, see above.

#### 6. REASONS:

The Welsh Government has announced additional grant funding for Local Authorities to deliver the High Street and Retail Rate Relief Scheme, under Section 47 of the Local Government Finance Act 1988. It is for individual Authorities to adopt the scheme and decide when to grant relief.

#### 7. RESOURCE IMPLICATIONS:

The exact amount awarded will be determined once the Authority has accepted the arrangements and awarded the relief to eligible ratepayers. Provisional funding allocations have been provided by Welsh Government and are based on an estimated number of eligible hereditaments on the local rating list. The provisional funding for Monmouthshire is a maximum of £1.05m

Councils are required to sign a certificate of acceptance form and to provide Welsh Government with details of the amount of relief awarded by 3<sup>rd</sup> May 2019.

As in 2018/19, there is a small risk that should any relief awarded be deemed as not appropriate the costs will fall to the Council.

## Non-domestic Rates – High Street and Retail Rates Relief

#### **Guidance**

### About this guidance

- 1. This guidance is intended to support local authorities in administering the High Street and Retail Rates Relief scheme ("the relief") announced by the then Cabinet Secretary for Finance on 10 December 2018. This guidance applies to Wales only.
- 2. This guidance sets out the criteria which the Welsh Government will use to determine the funding for local authorities for relief provided to high street and retail properties. The guidance does not replace any existing non-domestic rates legislation or any other relief.

- 4. The relief is being offered from 1 April 2019 and will be available until 31 March 2020.

#### Introduction

- 5. This relief is aimed at high street businesses and retailers in Wales, for example shops, pubs, restaurants and cafes.
- 6. The Welsh Government will provide grant funding to the 22 Unitary Authorities to continue the High Street and Retail Rates Relief scheme to eligible ratepayers for 2019-20. The enhanced scheme aims to provide support for eligible retail businesses by offering up to £2,500 discount on the non-domestic rates bill per property, to retailers occupying premises with a rateable value of £50,000 or less in the financial year 2019-20, subject to State Aid limits.
- 7. This document provides guidance on the operation and delivery of the scheme.

#### **Section 1**

#### High Street and Retail Rates Relief

#### How will the relief be provided?

8. As this is a temporary measure, we are providing the relief by reimbursing local authorities that use their discretionary relief powers under section 47 of the Local Government Finance Act 1988. It will be for individual local authorities to adopt a scheme and decide in each individual case when to grant relief under section 47. The Welsh Government will then reimburse local authorities for the relief that is provided in line with this guidance via a grant under section 58A of the Government of Wales Act 2006.

#### How will the scheme be administered?

- It will be for local authorities to determine how they wish to administer the scheme to maximise take-up and minimise the administrative burden for ratepayers and for local authority staff. Subject to State Aid considerations set out in paragraphs 29 to 33.
- 10. Local authorities are responsible for providing ratepayers with clear and accessible information on the details and administration of the scheme. If, for any reason, an authority is unable to provide this relief to eligible ratepayers from 1 April 2019, consideration should be given to notifying eligible ratepayers that they qualify for the relief and that their bills will be recalculated.

#### Which properties will benefit from relief?

- 11. Properties that will benefit from this relief will be occupied high street business and retail properties such as shops, restaurants, cafes and drinking establishments, with a rateable value of £50,000 or less on 1 April 2019. More detailed eligibility criteria and exceptions to the relief are set out in paragraphs 15 to 19.
- 12. Relief should be granted to businesses as a one-off payment based on occupation as at 31 March 2019 (provided the same occupier continues to be in occupation on 1 April 2019). It is recognised that there may be some instances where a local authority is retrospectively notified of a change of occupier. In such cases, if it is clear that the occupier was in occupation on 1 April 2019, the local authority may use its discretion in awarding relief.

#### Level of support: up to £2,500

13. Eligible ratepayers will be retailers whose property has a rateable value between £6,001 and £50,000 on 1 April 2019-20. It is expected that retailers with a rateable value of £6,000 and below will receive full Small Business Rate Relief (SBRR), however it is left to the discretion of authorities to determine if there are properties not in receipt of SBRR that should be eligible for this relief.

- 14.Unlike previous years, the 2019-20 scheme is not limited to high street premises but will include all properties within Wales meeting the wider retail criteria.
- 15. It is intended that, for the purposes of this scheme, retail properties such as, "shops, restaurants, cafes and drinking establishments" will mean the following (subject to the other criteria in this guidance).

### Hereditaments that are being used for the sale of goods to visiting members of the public

- Shops (such as florists, bakers, butchers, grocers, greengrocers, jewellers, stationers, off-licences, newsagents, hardware stores, supermarkets, etc)
- Opticians
- Pharmacies
- Post offices
- Furnishing shops or display rooms (such as carpet shops, double glazing, garage doors)
- Car or caravan showrooms
- Second hard car lots
- Markets
- Petrol stations
- Garden centres
- Art galleries (where art is for sale or hire)

## i. Hereditaments that are being used for the provision of the following services to visiting members of the public

- Hair and beauty services
- Shoe repairs or key cutting
- Travel agents
- Ticket offices, eg. for theatre
- Dry cleaners
- Launderettes
- PC, TV or domestic appliance repair
- Funeral directors
- Photo processing
- DVD or video rentals
- Tool hire
- Car hire
- Cinemas
- Estate and letting agents

## ii. Hereditaments that are being used for the sale of food and / or drink to visiting members of the public

- Restaurants
- Drive-through or drive-in restaurants
- Takeaways

- Sandwich shops
- Cafés
- Coffee shops
- Pubs
- Wine Bars
- 16. To qualify for the relief a hereditament listed in (i) to (iii) should be wholly or mainly used as a shop, restaurant, café or drinking establishment. This is a test on use rather than occupation. Therefore, hereditaments which are occupied but not wholly or mainly used for the qualifying purpose will not qualify for the relief.
- 17. The above list is not intended to be exhaustive as it would be impossible to list all the many and varied retail uses that exist. There will also be mixed uses. However, it is intended to be a guide for local authorities as to the types of uses that the Welsh Government considers for this purpose to be high street and retail. Local authorities should determine for themselves whether particular properties not listed are broadly similar in nature to those above and, if so, to consider them eligible for the relief. Conversely, properties that are not broadly similar in nature to those listed above should not be eligible for the relief.
- 18. As the grant of the relief is discretionary, local authorities may choose not to grant the relief if they consider that appropriate, for example where granting the relief would go against the local authority's wider objectives for the local area.

### Types of hereditaments that are not considered to be eligible for High Street and Retail Rates Relief

- 19. The list below sets out the types of uses that the Welsh Government does not consider to be retail use for the purpose of this relief and would not be deemed eligible for the relief. However, it will be for local authorities to determine if hereditaments are similar in nature to those listed below and if they would not be eligible for relief under the scheme.
- i. Hereditaments that are being used wholly or mainly for the provision of the following services to visiting members of the public
  - Financial services (eg. banks, building societies, cash points, ATMs, bureaux de change, payday lenders, betting shops, pawn brokers)
  - Medical services (eg. vets, dentists, doctors, osteopaths, chiropractors)
  - Professional services (eg. solicitors, accountants, insurance agents, financial advisers, tutors)
  - Post office sorting office
  - Tourism accommodation, eq. B&Bs, hotel accommodation and caravan parks
  - Sports clubs
  - Children's play centres
  - Day nurseries
  - Outdoor activity centres
  - Gyms
  - Kennels and catteries
  - Show homes and marketing suites

#### - Employment agencies

There are a number of further types of hereditaments which the Welsh Government believes should not be eligible for the High Street Relief Scheme.

#### ii. Hereditaments with a rateable value of more than £50,000

It is recognised there are some retail businesses with rateable value above the £50,000 relief who will not be eligible for this relief. However, local authorities have the option to use their discretionary powers to offer discounts outside this scheme to such businesses if it is in the interests of the local community to do so.

## iii. Hereditaments that are not reasonably accessible to visiting members of the public

If a hereditament is not reasonably accessible to visiting members of the public, it will be ineligible for relief under the scheme even if there is ancillary use of the hereditament that might be considered to fall within the descriptions in paragraph 15 (i), (ii) or (iii).

#### iv. Hereditaments that are not occupied

Properties that are not occupied on 1 April 2018 should be excluded from this relief. However, under the Empty Property Relief scheme, empty properties will receive a 100% reduction in rates for the first three months (and in certain cases six) of being empty.

#### v. Hereditaments that owned, rented or managed by a local authority

Hereditaments that owned, rented or managed by a local authority such as Visitor Centres, Tourist Information shops and council run coffee shops/gift shops attached to historic buildings, are exempt from this scheme.

#### vi. Hereditaments that are in receipt of mandatory charitable rates relief

These properties already receive mandatory charitable relief which gives an 80% reduction in liability and authorities may also choose to provide discretionary charitable relief which can reduce the remaining liability to nil. As such, these properties will not be eligible for High Street Rate Relief.

#### How much relief will be available?

- 20. The total amount of government funded relief available for each property for 12 months under this scheme is up to £2,500. This relief can be provided in addition to SBRR and Transitional Rate Relief. High Street and Retail Rates Relief should be applied against the net bill after these two reliefs have been applied. Any hardship or discretionary relief awarded by the local authority should be considered by the local authority once all other rates reliefs have been awarded.
- 21. The eligibility for the relief and the relief itself will be assessed and calculated on a daily basis. The following formula should be used to determine the amount of relief to be granted for a particular hereditament in the financial year:

Amount of relief to be granted =  $A \times (B / C)$ 

Where:

A is the funding amount of £2,500

B is the number of days in the financial year that the hereditament is eligible for relief; and

C is the number of days in the financial year

- 22. When calculating the relief, if the net liability before High Street and Retail Rates Relief is £2,500 or less, the maximum amount of this relief will be no more than the value of the net rate liability. This should be calculated ignoring any prior year adjustments in liabilities which fall to be liable on the day.
- 23. Ratepayers that occupy more than one property will be entitled to High Street and Retail Rates Relief for each of their eligible properties, subject to State Aid de minimis limits.

#### Changes to existing hereditaments, including change in occupier

- 24. Eligibility for the relief will be calculated based on the circumstances of the property and ratepayer as at 1 April 2019. Changes to properties which occur after this date will have no impact on eligibility for this relief.
- 25. Empty properties becoming occupied after 1 April 2019 will qualify for this relief.
- 26. If there is a change in occupier part way through the financial year, after relief has already been provided to the hereditament, the new occupier will qualify for the relief on a pro-rata basis based on the remaining days of occupation using the formula in paragraph 21 of this guidance.

#### State Aid

- 27. State Aid law is the means by which the European Union regulates state funded support to businesses. Providing discretionary relief to ratepayers is likely to amount to State Aid. High Street and Retail Rates Relief will be State Aid compliant where it is provided in accordance with the De Minimis Regulation (1407/2013).
- 28. The De Minimis Regulation allows an undertaking to receive up to €200,000 of De Minimis aid in a three-year period (consisting of the current financial year and the two previous financial years). Local authorities should familiarise themselves with the terms of this State Aid exemption, in particular the types of undertaking that are excluded from receiving De Minimis aid, the relevant definition of undertaking and the requirement to convert the aid into Euros.
- 29. To administer De Minimis it is necessary for the local authority to establish that the award of aid will not result in the undertaking having received more than €200,000 of De Minimis aid. Note that the threshold only relates to aid provided under the De Minimis Regulations (aid under other exemptions or outside the scope of State Aid is not relevant to the De Minimis calculation).
- 30. Section 3 of this guidance contains a sample De Minimis declaration which local authorities may wish to use. Where local authorities have further questions about De Minimis or other aspects of State Aid law, they should seek advice from their legal department in the first instance.

### Sample paragraphs that could be included in letters to ratepayers about High Street and Retail Rates Relief for 2019-20

The Cabinet Secretary for Finance announced on 10 December 2018 that an additional £23.6 million of funding would be available to extend and expand the existing High Street and Retail Rates Relief scheme for 2019-20.

Relief of up to £2,500 will be provided to eligible occupied retail properties with a rateable value of £50,000 or less in 2019-20. Your current rates bill includes this High Street and Retail Rates Relief.

Awards such as High Street and Retail Rates Relief are required to comply with the EU law on State Aid¹. In this case, this involves returning the attached declaration to this authority if you have received any other De Minimis State Aid, including any other High Street and Retail Rates Relief you are being granted for premises other than the one to which this bill and letter relates, and confirming that the award of High Street and Retail Rates Relief does not exceed the €200,000 an undertaking² can receive under the De Minimis Regulations EC 1407/2013.

Please complete the declaration and return it to the address above. In terms of declaring previous De Minimis aid, we are only interested in public support which is De Minimis aid (State Aid received under other exemptions or public support which is not State Aid does not need to be declared).

If you have not received any other De Minimis State Aid, including any other High Street and Retail Relief you are being granted for premises other than the one to which this bill and letter relates, you do not need to complete or return the declaration.

If you wish to refuse to receive the High Street and Retail Rates Relief granted in relation to the premises to which this bill and letter relates, please complete the attached form and return it to the address above. You do not need to complete the declaration. This may be particularly relevant to those premises that are part of a large retail chain, where the cumulative total of High Street and Retail Rates Relief received could exceed €200,000.

Under the European Commission rules, you must retain this letter for three years from the date on this letter and produce it on any request by the UK public authorities or the European Commission. (You may need to keep this letter longer than three years for other purposes). Furthermore, information on this aid must be supplied to any other public authority or agency asking for information on 'De Minimis' aid for the next three years.

This means that it puts goods or services on a given market. The important thing is what the entity does, not its status. Article 2.2 of the de minimis Regulations (Commission Regulation EC/ 1407/2013) defines the meaning of 'single undertaking'.
