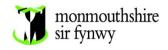

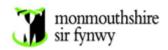

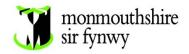

SUBJECT: CROESONEN S106 OFF-SITE RECREATION FUNDING

MEETING: CABINET

DATE TO BE CONSIDERED: 6th NOVEMBER 2019

### 1. PURPOSE

- 1.1 To agree the inclusion of capital funding in the 2020/21 Capital Budget;
- 1.2 To agree the allocation of grant funding to a community growing project.
  - 2. **RECOMMENDATION** that a grant of £24,669 (to include the £18,900 grant originally allocated to the allotments project in Mardy) be allocated to the Growing Space Group to undertake a community growing initiative at the Mardy Park Resource Centre and that this is funded by a corresponding contribution from the S106 balances held by the Council from the Croesonen Farm and Infant School sites.

### 3. KEY ISSUES

- 3.1 In February 2011 Cabinet considered a report on the allocation of £78,300 worth of off-site recreation funding from the Croesonen Farm and Croesonen Infants School Section 106 Agreements. At that meeting it was decided to allocate grants to ten local projects. There is no "spend by" date for the use of this money, but it was received by the Council in May 2009.
- 3.2 Of the ten projects awarded funding in 2011 nine were completed but one project, the provision of a 3G training area at Mardy Recreation Ground, was not able to proceed due to the applicant being unable to obtain the match funding required.
- 3.3 As a result of this, at its meeting in February 2016 Cabinet agreed to reallocate the £40,000 originally awarded to the 3G project to three other projects and to retain an unallocated balance of £6,000.
- 3.4 Two of the new projects awarded a grant in February 2016 improvements to the play area at Mardy Playing Field and the provision of some audio visual equipment at Llanddewi Skirrid Village Hall have been completed and the grant money spent.
- 3.5 The third project was the provision of new allotments on an area of land off Nantgavenny Lane in Mardy, for which a grant of £18,900 was awarded. The intention was for the local allotments association to lease the land in question from a local landowner and to use the grant money to establish approximately 20 new allotment plots.

- 3.6 However, the land intended to be used for the allotments was used for another purpose to help facilitate the new housing development on land at Deri Farm, which is one of the major residential allocations in the current Local Development Plan.
- 3.7 Both the local allotment association and Council officers have tried but failed to identify an alternative site for the allotments in the Mardy area.
- 3.8 A grant application has now been received from Growing Space, a group that works with the Council's provision at the Mardy Park Resource Centre. Their proposal is to install mains water and set up an irrigation system in the existing polytunnels and also to set up a water harvesting system. Raised beds will be installed and basic gardening tools purchased. A silent run generator will also be purchased to provide electricity to the training cabin.
- 3.9 The intention is to deliver horticultural therapy sessions to people with dementia, learning and physical disabilities, carers and young people. The project will also work with the families of those attending the provision and with local residents.
- 3.10 The resource centre is located approximately 500m from the site originally proposed for the new allotments at Nantgavenny Lane and the Growing Space proposal offers opportunities for local residents to get involved with horticultural activities at the site, as well as providing an important addition to the range of services already delivered at Mardy Park.
- 3.11 The Growing Space Group has a long standing involvement at Mardy Park and will manage the installation work and ongoing maintenance of the community growing initiative to ensure its longer term sustainability.

### 4.0 OPTIONS APPRAISAL

The options are to:

- 1. take no action and return the money to the developers with no additional or improved community recreation provision;
- 2. allocate the funding to the project proposed in this report;
- 3. allocate the funding on a different basis.

### 5. EVALUATION CRITERIA

Please see evaluation criteria set out in **Appendix A**.

### 6. REASONS

- To ensure the funding is available in the Council's capital budget in the 2020/21 financial year;
- 6.2 To ensure the Section 106 funding received from the developer is used effectively to enhance community recreation provision in the local area.

### 7. RESOURCE IMPLICATIONS

The off-site recreation funding from the Section 106 agreements in relation to the Croesonen Farm and Infant School sites was received from the developer in May 2009. Most of the projects offered grant funding have been completed and the money spent but there is a balance of £24,669 that remains to be spent. The proposal from Growing Space would utilise the unallocated balance and would create long term benefits at the Mardy Park Resource Centre for use by current and future service users and by the local community. Utilising the funding in this way will not impact upon the Council's capital budget.

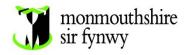

### 1. PURPOSE

- 1.1 To agree the inclusion of capital funding in the 2019/20 Capital Budget;
- 1.2 To agree the allocation of grants from the funding available.

### 3. KEY ISSUES

- 3.1 The Council has been working with a number of local organisations in recent months on projects to improve community sport and recreation facilities in Monmouth. A number of these have been successful in attracting external grant aid, but these require an element of match funding. Details of these projects are set out below.
- 3.2.1 Monmouth Leisure Centre and School Site the final element of the external works at the leisure centre site is the completion of the multi-use games area (MUGA), adjacent to the reconfigured car park. An analysis of usage of the MUGA has revealed that the main demand is for good quality football training facilities, particularly for the junior age groups. A bid was submitted for Welsh Government grant funding (a fund managed by the National Collaboration Group consisting of the FAW, RFU and Tennis Wales) to lay a 3G surface on the MUGA area. The project also includes erecting a

secure fence around the informal tennis court area that has been marked out on the school yard, so this can be used by pupils during the school day. Confirmation has been received that a grant of £46,640 has been awarded on condition that project is completed and the grant claimed by 31st March 2020.

The 3G resurfacing of the MUGA is one of the unfunded capital projects included in the MonLife investment strategy considered by elected members at the County Council meeting on 19<sup>th</sup> September. This project also makes good economic sense, as the increased use of the site for football training will help to contribute income to the centre in terms of secondary spending. The estimated cost of the project is £86,000 (although only £69,725 is eligible for grant-aid). It is therefore proposed to allocate a match funding contribution of £40,000 to ensure that the project can be delivered on time.

3.2.2 Monmouth Tennis Courts – Monmouth Tennis Club is a constituent member of the Monmouth Sports Association and it uses the three tennis courts located at the Monmouth Sportsground. There is a renewed interest in tennis in Monmouth and a demand for greater use of the courts – this is due mainly to the fact that there is a Level 4 tennis coach attached to the club who holds regular training sessions for club members and for members of the public that use the courts. However, the tennis courts are in quite a poor condition and they need to be resurfaced - for which there is no identified budget. The Council is currently responsible for maintaining the tennis courts.

In partnership with the club, Council officers submitted an application to Sport Wales in July for a grant to resurface the courts and to install a gate access system, which is an electronic platform developed by the LTA (Lawn Tennis Association). The grant application was partially successful, in that a grant was allocated for the gate access system only. The benefit of the gate access system is that it allows club members and member of the public to book courts online. It also means that because the courts are secure, each individual that books a court has to pay for court usage every time a booking is made. On this basis, the club can deposit money accrued from court usage into a fund (in line with the LTA sinking fund calculator model) that will be sufficient to cover the cost when the courts need resurfacing in 8 to 10 years' time. The benefit of this arrangement is that responsibility for maintenance and resurfacing of the courts will transfer from the Council to the tennis club.

The cost of resurfacing the courts is £40,000 and it is proposed that funding of £35,000 is allocated to this project, with the club providing a match funding amount of £5,000. The club is also match funding for the gate access system.

3.2.3 Monmouth Football Club Stand – Monmouth Town FC is one of six football clubs in the county that play in the top three tiers of the FAW football pyramid in Wales. As a result of changes in the structure of the football pyramid and the facility requirements at different levels of the structure, Monmouth Town needs to have in place a covered stand with seating for 100 spectators. If clubs can't meet the facility requirements then the result is that they will be demoted to the next level down in the pyramid.

The Council has previously allocated grants to four clubs to enable them to meet the league requirements, namely Abergavenny Town FC (£20,000), Chepstow Town FC (£15,000), Goytre FC (£19,285) and Undy Athletic FC (£73,232). This has enabled the clubs to continue to play at their respective levels of competition.

The cost of the new stand at Monmouth is £43,242 and the club has been successful in being awarded a grant of £33,200 – it is recommended that a grant of £10,000 is allocated to the club as a match funding contribution.

3.2.4 **Monmouth Allotments** – the only allotment site in Monmouth is located on that part of the village green situated between the A449 and the River Wye. There are 70 allotment holders (some plots have been divided into smaller units) and the site is in quite an isolated position, so there are problems with site security and the plots are affected periodically by an infestation of rabbits.

The allotment association applied for a grant towards this project from the Section 106 funding that was available back in 2014 but its application was unsuccessful, falling one point short of being offered a grant. The association's application scored 16 points in the site assessments and all applications scoring 17 or more were awarded a grant.

The problems associated with the lack of a suitable stock-proof fence are still being experienced and it is proposed to allocate a grant of £25,000 to enable this provision to be made. This will allow the day to day management of the site to be transferred over to the allotments association.

- 3.2.5 Chippenham Mead Play Area the play area at Chippenham Mead has been the subject of a number of reports considered by elected members over the last three years. There is an established budget available to relocate the play area subject to the necessary consents being granted, but additional costs have been incurred in submitting the planning application and the preparations made for the submission of a Welsh Government consent application. These include costs to commission and implement the recommendations of a detailed tree survey. In order to protect the existing level of budget for design and installation of play equipment, it is recommended that a sum of £10,000 is allocated to this project.
- 3.2.6 Rockfield Central Open Space and Play Area the central open space at Rockfield serves a large number of dwellings on the existing development and will also be the main open space to serve the additional dwellings that have been approved on the Rockfield Road West development. It is proposed to extend the existing play area on site to include more play equipment to meet the identified shortfalls and to incorporate a family seating area also to create a community growing space alongside the existing play area.

In a recent play area assessment the Rockfield site at the central open space has been assessed as being "adequate" and requires investment to bring it up to a "good" standard, with better levels of provision consisting of more inclusive and educational play items. It is proposed to allocate a sum of £29,000 to facilitate this provision.

### 4.0 OPTIONS APPRAISAL

The options are to:

- 1. take no action and return the money to the developers with no additional or improved community recreation provision;
- 2. allocate the funding to the projects proposed in this report;
- 3. allocate the funding on a different basis.

A comparison of benefits and risks is set out at **Appendix A**.

### 5. EVALUATION CRITERIA

### 6. REASONS

- 6.1 To ensure the funding is available in the Council's capital budget in the 2019/20 financial year;
- 6.2 To ensure the Section 106 funding received from the developer is used effectively to enhance community recreation provision in the local area.

### 7. RESOURCE IMPLICATIONS

The original off-site recreation funding of £985,000 from the Wonastow development was directed to part fund the cost of the new swimming pool at Monmouth Leisure Centre. However, because the developer contributions were linked to the Welsh House Price Index, additional funding of £149,000 has been realised from the Wonastow site. It is recommended that this surplus additional funding is used to fund the proposals outlined in this report.

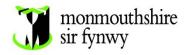

SUBJECT: PENPERLLENI S106 OFF-SITE RECREATION FUNDING

MEETING: CABINET

#### 1. PURPOSE

- 1.1 To agree the inclusion of funding in the 2019/20 and 2020/21 Capital Budgets;
- 1.2 To recommend the allocation of grants from the funding available.

#### 2. **RECOMMENDATIONS** that

- a budget of £127,191 be created in 2019/20 to fund the following projects and that this is funded by a corresponding contribution from the S106 balances held by the County Council from Section 106 Agreements in relation to the development of land to the south of School Lane, Penperlleni and land to the rear of Pleasant Retreat, Star Road, Goytre (Finance Codes N610 and N565);
- 2.2 grants in the sums shown below be allocated to the following seven projects:

2.3 the remaining S106 balance of £82,572 be uploaded into the 2020/21 capital budget and used for the improvement of recreation and play facilities at Goytre Playing Field;

#### 3. KEY ISSUES

- 3.1 The development of land to the south of School Lane, Penperlleni and to the rear of Pleasant Retreat, Star Road in Goytre was approved subject to three separate S106 Agreements. Under the terms of those agreement the Council has received S106 off-site recreation contributions of £209,763 to be used within a five mile radius of each site.
- 3.2 In May applications for funding were invited from local organisations and eight applications were received. These are listed in the table at **APPENDIX B** and more detailed comments on each project are set out in **APPENDIX C**.

- 3.3 Each of the applications has been assessed and, of the eight applications received, seven have demonstrated clear outcomes in line with the Council's corporate objectives. The eighth application is for the construction of a multiuse games area (MUGA) at Goytre Playing Field, which is located in the centre of the village adjacent to the village hall and the main village play area. The playing field is in the ownership of the County Council and the proposed MUGA application has been submitted by Goetre Fawr Community Council. The community council is proposing to lease the area of land for the MUGA from this council and to take on future management and maintenance responsibilities for the new facility.
- 3.4 The population of the village is growing due to recent housing developments and the community council has carried out some local consultation, which has identified a shortage of facilities in the village for older children, teenagers and young adults. However, the cost of a formal floodlit MUGA is in excess of £120,000 and there is no business case to support such a provision in this location. There is a formal floodlit MUGA located approximately two miles away, adjacent to Little Mill Village Hall and there is existing capacity for additional bookings at that facility.
- 3.5 When requests for S106 funding of this magnitude have been received previously, the Council has asked for a satisfactory, detailed business plan to be submitted providing evidence of sustainability and confirmed future usage. This was done most recently in Magor and Undy in relation to proposals submitted by the local football club and the local community council there.
- 3.6 It is possible that in Goytre an informal MUGA provision could be made to meet the identified needs of young people and a report has also been received recently identifying the need for investment to upgrade the existing village play area, also located on the playing field.
- 3.7 On this basis, it is recommended that the remaining balance of £82,572 is allocated towards the improvement of recreation and play facilities at Goytre Playing Field and that officers work with the community council to develop detailed proposals for the use of this funding. If, as a result of those discussions, a formal floodlit MUGA is still proposed then this should be made subject to the submission of a satisfactory detailed business plan.

#### 4.0 OPTIONS APPRAISAL

The options are to:

- 1. take no action and return the money to the developers with no additional or improved community recreation provision;
- 2. allocate the funding to the projects proposed in this report;
- 3. allocate the funding on a different basis.

#### 5. EVALUATION CRITERIA

#### 6. REASONS

- 6.1 To ensure that sufficient funding is available in the Council's 2019/20 and 2020/21 capital budgets to meet the cost of the recommendations;

#### 1. PURPOSE:

**1.1** The purpose of this report is to make recommendations to Cabinet on the Schedule of Applications for the Welsh Church Fund Working Group meeting 5 held on the 19<sup>th</sup> September 2019 and meeting 6 held on the 24<sup>th</sup> October 2019.

#### 2. RECOMMENDATION:

2.1 We resolved that the following grants be awarded as per the schedule of applications.

#### SCHEDULE OF APPLICATIONS CONSIDERED 2019/20 - MEETING 5.

1. St Mary's Church Hall, Caldicot requested £4,500 in funding for the replacement of broken fire doors that do not meet current fire regulations.

Recommendation: £3,000 was awarded to assist in providing essential safety equipment for this community asset.

2. St Cenedion's Church, Rockfield, requested £1,500 to assist in providing two benches for the church graveyard for visitors and mourners to rest and reflect as no provision currently exists.

Recommendation: £750 was awarded to assist in providing facilities that can be utilised by visitors to the graveyard.

.3 Homemakers Community re-cycling requested £1,500 to assist in installing a sewage system in the homemakers industrial unit and replace an effluent tank in the interests of long term viability of the project and consider the H&S aspects in relation to members of the public and staff.

Recommendation: £1,000 was awarded to assist in funding this community re-cycling project that benefits residents throughout Monmouthshire.

4 Clybiau Plant Cymru Kids' Club), requested £2,684 of funding to deliver 14 'Playing Out with Elements' Workshops for children and play workers with Out of School Childcare Clubs in Monmouthshire. These are activities based upon the elements of 'air, earth, fire and water' to stimulate children's play in an external environment.

Recommendation: The application was deferred for further information.

5 Individual requested £500 for a contribution to a 'Foundation degree'

Recommendation: £500 was awarded to assist an individual in pursuing a life enhancing qualification.

**6 Shirenewton and Mynydd Bach Illumination,** requested £360 for the purchase of 100 high visibility vests as a Health & safety measure for use by participants in the extravaganza as the event is held in the dark.

Recommendation: £180 was awarded to assist in providing Hi-Viz vests as a Health & Safety feature as the event is held on an open public highway

**7 Pontypool Ski Racing,** requested £984 for the purchase of radios for the health & safety of members where blind spots on the ski scope could result in accidents if communications are not instantly available to control the numbers coming down the slopes

Recommendation: £492 was awarded to assist in providing radios for Health & Safety reasons for the control and safety of Monmouthshire residents that are members of 'Pontypool Ski Racing' club

**8 Individual** requested £500 for a contribution to a PhD course in the 'History and Philosophy of Science'

Recommendation: £250 was awarded to assist an individual in pursuing a life enhancing qualification

**9 The 'Patients Voice'** requested £500 to establish a Community Organisation that represents the community at the local Health Centre and strengthens their marketing ability to reach more patients

Recommendation: £250 was awarded to assist in enhancing the communication between patients and staff at a local Health Centre in Magor.

#### SCHEDULE OF APPLICATIONS CONSIDERED 2019/20 – MEETING 6.

1. The Cornfield Project, Portskewett requested £1,500 required for a SUDS (sustainable drainage survey) survey to enable the construction of £46,332 stone dust path (funding secured) that has recently been introduced as a construction regulation.

Recommendation: £1,100 was awarded to assist in providing an essential sustainable drainage survey to enable construction of a community asset.

2. Rockfield Village Life Community Project, Rockfield, requested £900 for the repair / restoration of the Rockfield War Memorial stone cross as it has fractured and is being held together by metal support banding.

Recommendation: The application was deferred as further information is requested.

.3 Caldicot Rugby Club Under 10's requested £1,000 to purchase tackle bags, rugby balls and a team kit for 25 participants.

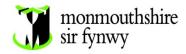

#### 1. PURPOSE:

1.1 To present the draft 'Vision Monmouthshire 2040: Economic Growth and Ambition Statement' following the conclusion of the 'Economies of the Future' analysis and a period of consultation with Members and the local business community.

1.2 The purpose of the 'Vision Monmouthshire 2040: Economic Growth and Ambition Statement' is to set the economic ambition for the county. The Statement will be followed by a more detailed 'Monmouthshire Business Growth and Enterprise Strategy' and accompanying Inward Investment Prospectus. These set of documents will work alongside the replacement Local Development Plan (LDP), in identifying suitable employment sites and premises, to enable existing businesses to grow and to attract inward investment from new businesses in key growth sectors. The replacement LDP will also seek to increase the availability of housing sites to provide differing residential products, to enable higher rates of jobs per dwelling.

#### 2. RECOMMENDATIONS:

2.1 That Cabinet approves the draft 'Vision Monmouthshire 2040: Economic Growth and Ambition Statement'. (Appendix A).

#### 3. KEY ISSUES:

- 3.1 Monmouthshire is experiencing a once in a generation opportunity to reconsider its future direction. Monmouthshire's unique border county location, the Council's decision to participate in the Cardiff Capital City Region (CCR) City Deal, and the UK Government's decision to remove Severn Bridge Crossing tolls in 2018, all present a rare chance for Monmouthshire to become a key economic growth area in the CCR.
- 3.2 In order to capitalise on these opportunities and address our economic issues at a county level, research was commissioned in December 2017, to help the Council build on its current 'Monmouthshire Business Growth and Enterprise Strategy (2014-2020) and identify a new strategy that is future ready. The research considered the priorities and actions detailed in the current Strategy and identified economic opportunities and growth sectors that will provide jobs for our citizens now and in the future. The research also considered the centricity of Monmouthshire in terms of its proximity to the English borders of the South West, including Bristol and Gloucester and the West Midlands on its north-eastern border, whilst also identifying the supporting housing and commercial infrastructure that will be required to facilitate identified economic growth sectors and inform the replacement LDP.
- 3.3 Specifically the research focused on:
  - The most appropriate growth sectors that will provide the 'Economies of the Future' for Monmouthshire:

- The provision of a detailed observational study of the accommodation and locational needs of the identified growth sectors;
- An assessment of the suitability and deliverability of existing employment sites as identified by the LDP;
- Identification of locational criteria for additional employment, retail and housing sites;
- An indication of the skills sets that will be required to address the growth sector needs
  and whether it is feasible for Monmouthshire citizens to meet these needs or whether
  the County needs to look to attract labour from elsewhere, if so where?;
- An assessment of whether current population levels can sustain the economic growth required in the county;
- Potential inward migration required to develop and sustain the identified growth sectors;
- Potential for a new settlement that can be put forward as options for consideration in the replacement LDP process;
- Modelled scenarios and associated ambition targets, to include current and predicted geodemographic segmentation analysis;
- The additional infrastructure required to service the changing demographic and economic landscape over and above residential and commercial property;
- An assessment of the identified economic and population impact on existing retail sectors, taking account of the 'Monmouthshire Retail Expenditure Forecasts Update 2016' with a view to identifying potential growth and development opportunities for the county; and
- The impact of inward migration on the indigenous population and house prices and the mitigation that would need to be built in to seek to offset any negative impact.
- 3.4 In concluding the research key strengths, challenges, weaknesses and opportunities were identified as detailed in the Options Appraisal in Section four of this report.
- 3.5 The subsequent draft 'Vision Monmouthshire 2040: Economic Growth and Ambition Statement' aligns with the vision of Monmouthshire's Corporate Plan namely: 'Helping to build sustainable and resilient communities that support the well-being of current and future generations'. The ambitions and priorities have been identified as follows:

#### Monmouthshire:

- A dynamic place to do business
- A credible place to invest
- An incredible place to live, visit and stay

#### **Our Economic Growth and Ambition Statement priorities:**

- To raise the profile of Monmouthshire as a key investment opportunity for the private sector;
- To lay the ground rules for an economic environment which enables businesses to land and expand and provide sustainable employment opportunities for local people;
- To attract funding and investment to Monmouthshire to attract the right conditions for 'an inclusive economy' – Equitable, Sustainable, Stable, Participatory, Growing; and
- To set an ambition which is sensitive to the landscape to ensure Monmouthshire remains an incredible place to live, visit and stay.

- 3.6 The ambition and priorities will be guided by four aims:
  - Aim 1: A Productive Monmouthshire A dynamic place for businesses to grow and invest
  - Aim 2: A Healthy and Happy Monmouthshire An incredible place to live
  - Aim 3: A *Prosperous Monmouthshire* A great place to thrive
  - Aim 4: A Welcoming Monmouthshire An amazing place to visit and stay
- 3.7 Success in achieving the aims and priorities will be assessed as follows:

# 4. EQUALITY AND FUTURE GENERATIONS EVALUATION (INCLUDES SOCIAL JUSTICE, SAFEGUARDING AND CORPORATE PARENTING):

4.1 An Equality Impact Assessment has been undertaken (Appendix B) which demonstrates that the detail contained in the draft 'Vision Monmouthshire 2040: Economic Growth and Ambition Statement' demonstrates compliance with the five well-being ways of working, supports the well-being goals and concludes that associated activities are expected to have a positive impact on all groups and people with protected characteristics.

#### 5. OPTIONS APPRAISAL

- 5.1 Since the production of the Monmouthshire Business Growth and Enterprise Strategy in 2014, the regional economic landscape has changed significantly. There is therefore a strong desire to consider how to best place the county to capitalise on these significant economic development opportunities, hence the development of the 'Vision Monmouthshire 2040: Economic Growth and Ambition Statement'.
- 5.2 As the Council is currently producing a replacement LDP, it made sense to undertake joint research to ensure that the future LDP and the proposed Economic Growth and Ambition Statement are data driven. This data will enable both the Planning and Economic Development Services to take intelligent decisions, based on modelled scenarios of future growth sectors and future skills needs, to facilitate the Council in identifying significant potential growth and development opportunities for the county.
- In concluding the research key strengths, challenges, weaknesses and opportunities were identified as detailed in Table One below. Table Two that follows details a risk analysis of what may happen if no action is taken:

6.1 The 'Vision Monmouthshire 2040: Economic Growth and Ambition Statement' sets out our vision, ambition and priorities. The Statement is a pre-cursor to the more detailed

Monmouthshire Business Growth and Enterprise Strategy and Investment Prospectus which will follow in 2020/2021 after a further period of research and consultation.

Comments received have included:

#### Members on the 14th February 2019

- The report recognises all of the correct issues. However, concern was expressed whether the Authority has enough ambition with regard to establishing solutions for the issues identified.
- Only 3% of the County is built on. However, 80% of that 3% is located within the south of the County. Therefore, for the people living in Monmouthshire, the idea of further building in areas where the majority of the housing already exists is a concern.
- The key to further development is the housing mix. More community land trusts need to be investigated. A different priority needs to be given to how the Authority sells its assets so that priority is given to the wellbeing of future generations over capital receipts.
- A lot of industrial land has been lost to housing development within the County. There is a need to balance future commercial development alongside the need for housing provision, in particular, affordable housing. Town centre sites could be investigated as possible areas to provide affordable housing.
- Concern was expressed with regard to the potential for urban sprawl spreading from towns and impinging on villages. Infrastructure and the existing service capacity is struggling to cope. It was considered that the aim should be towards achieving internal employment opportunities along housing provision.

#### Business community feedback has included:

- "Have a proactive marketing and sales effort"
- "Reinforce our market research into the requirements of both specific mobile companies and existing companies already in the county"
- "In 'Growth for good', good is the purpose, not growth".
- "Infrastructure as well as houses". "Beware of killing the golden goose -- too much development and change can destroy why people want to live, visit and work here.
- "The business rates system has failed....business rents adjustments are also needed for business survival"

- "The crucial job creation process within development has been too often neglected. To rebuild it will require serious investment"
- "Over the last ten years, full employment has depended on a huge increase in selfemployment. For start-up businesses based on internet use, there is huge unmet demand for affordable office space, whether shared or exclusive".
- "There is much in the presentation that suggests that the Statement should lead to a more successful economic development policy than has been evident in recent years. The great weakness is that it gives no indication that the necessary substantial increase in resources (staff, expertise, incentives, etc.) will be available to deliver success. Without a much more proactive and interventionist approach, Monmouthshire will be out-gunned by other parts of the region and the UK".

### **Foreword**



In 2014. I presented our Monmouthshire Business Growth and Enterprise Strategy which outlined our ambitions and ideas to help support business growth and build enterprise capacity in the County. Since then we have assisted more than 400 businesses: established our self-service business website www.monmouthshire.biz: refocussed our Youth Enterprise team to deliver a wider range of programmes to develop the employment potential of Monmouthshire's young people; continued to deliver a range of innovative rural development projects; supported the expansion of digital and mobile phone infrastructure and established a new Community and Partnership Development Team working in our communities and with our businesses to help take their ideas forward.

However, a lot has changed in five years, not least the establishment of the Cardiff Capital Region City Deal and the abolition of the Severn bridge tolls, so we need to think towards the future and what we will do to help build sustainable and resilient communities that support the well-being of current and future generations.

Our Vision Monmouthshire 2040 Economic Growth and Ambition Statement sets out our aspiration to raise the profile of Monmouthshire as a dynamic place to do business and a credible place to invest. We want to lay the ground rules for an economic environment which enables business to land and expand, providing sustainable employment opportunities for local people. We want to attract investment and funding which will generate the right conditions for an 'inclusive economy' - one that is equitable, sustainable, stable, participatory and growing. We want to ensure that our economy flourishes in a way that is sensitive to the landscape, to ensure that Monmouthshire remains an incredible place to live, visit, stay and invest.

Over the consultation period of this Economic Growth and Ambition
Statement, I have been heartened to see how passionate our business community remains in making business in
Monmouthshire a success. I've also been heartened by my fellow Councillors, who have maintained a keen interest in supporting enterprise and job creation.

Monmouthshire County Council wants to continue to create an environment that is open for business, an environment that nurtures new start-ups and enables existing businesses to expand, an environment that takes the future of its entrepreneurs seriously.

Working in tandem with the emerging replacement Local Development Plan, this statement illustrates the county's vision for Business and Enterprise in Monmouthshire – we very much look forward to working in partnership with you to help Monmouthshire thrive and prosper long into the future.

# Monmouthshire has a competitive economy with excellent potential for growth

Monmouthshire is an incredible place to do business; a credible place to invest.

It is the most competitive economy in Wales after the capital city of Cardiff and is best placed for growth per capita (UK Competitiveness Index 2019). Its residents are also among the best qualified in Wales.

county is geographically well connected, in a key strategic location with wiable centricity and excellent road infrastructure. Unusually, it is a rural county which enjoys close proximity to the high growth areas of Cardiff, Bristol and the Midlands and is only a 45 minute drive to Cardiff and Bristol airports.

Monmouthshire is currently outperforming the Cardiff Capital Region in terms of growth in tourism revenue and jobs.

2.24m visitors came to Monmouthshire in 2018 contributing £218.93m to the local economy and supporting 2,989 FTE jobs. FTEs and spend per visitor day also showed greater growth in Monmouthshire between 2017 and 2018 than the Wales average (STEAM 2018).

Visitors enjoy spectacular views from the 1,000 miles of public footpath (33% of the land is a protected environment) and award winning food and drink in the 'Food Capital of Wales'. Its beautiful landscape and heritage also make it an incredible place to live, with both Monmouth (2014) and Chepstow (2019) cited in the 'Sunday Times Best Places to Live' listing.

Monmouthshire is a key partner in the Cardiff Capital Region City Deal, the largest City Deal in the UK. The County Council has had notable involvement in the delivery of its first initiative - the establishment of an Advanced Compound Semi-Conductor Cluster. With the recent abolition of the Severn bridge tolls, Monmouthshire's relationship with the Bristol City Region is also strengthening.

Monmouthshire already has a strong core of agri-food, tourism, manufacturing, digital and tech businesses. This success can be built on to generate growth in a spectacular setting. The main driver of tourism revenue is accommodation. The county already has award-winning

hotels, (including The Angel Hotel in Abergavenny, ranked as the best hotel in Wales and one of the ten best hotels in the UK by the Best Hotel Guide 2020); Country Houses, B&Bs, guesthouses and camping and glamping sites. There are identified opportunities however for further hotel development, especially in the south of the county, to capitalise on the potential of the recently opened International Convention Centre Wales in Newport and the links between business events and inward investment.

# Monmouthshire's economy needs to grow to help build sustainable and resilient communities that support the well-being of current and future generations

Whilst Monmouthshire's economy is performing well, as the 2nd most competitive place in Wales, the county also needs to perform well on a UK basis if it is to provide for our future generations, because:

Monmouthshire's population is ageing. With a median age of 48, Monmouthshire has the oldest population in the Cardiff Capital Region. Current predictions suggest that by 2036, 36% of the county's 93,000 population will be over 65;

- Improved work opportunities are needed to attract and keep more young people in Monmouthshire;
- Monmouthshire residents who work in the county earn gross average salaries of £25,360 per year compared to out-commuters who earn on average £32,416 per year;
- Monmouthshire is a desirable and expensive place to live. The average house price is £307,000 which is the highest in Wales. Affordable houses are in short supply, with 2021 households on the housing waiting list (January 2019);
- The availability and quality of employment sites and premises is limiting growth;
- A wider range of career opportunities in Monmouthshire will help the environment by reducing carbon emissions from cars in a county that currently has 40% of residents out-commuting for work.
- The beautiful landscape and challenging topography of Monmouthshire has resulted in digital deprivation levels of 12.5% compared to 3-4% for the rest of the Cardiff Capital Region.

#### Our population

Unless we reduce our median age there will not be enough employed residents to support our wider population and public services.

#### Our young people

Unless we attract a broader range of employment opportunities, we will continue to turn out fantastic, well alified young people who will have to leave Monmouthshire to earn a living.

#### **Our economy**

Unless we provide quality employment sites and premises our existing businesses may need to move out of county to grow and opportunities to encourage new business start-ups will be limited. Without action, our population will age, making the county less attractive to investors and businesses.

#### **Our environment**

Unless we provide adequate public and active transport options, broadband infrastructure and employment opportunities, our out-commuting rates and carbon emissions will continue to rise and the environment will continue to suffer.

#### Our housing stock

Unless we address the need for affordable and varied housing stock the average age of Monmouthshire residents will continue to increase and our younger population will continue to struggle to get on the housing ladder.
