

No members of the public were present.

#### 4. SACRE Terms of Reference for Agreed Syllabus Conference (see link)

The Head of Service: Achievement & Extended Services introduced the report to consider the SACRE Terms of Reference for an Agreed Syllabus Conference. The new curriculum will require the alignment of a new agreed syllabus for delivery in Monmouthshire schools from 1st September 2022.

An Agreed Syllabus Conference must be arranged following a procedure set by Welsh Government to collectively agree a syllabus that is then ratified by Council. The membership of the Agreed Syllabus Conference is also clearly set out in guidance. The timeline for the process was provided.

Considering the Amended Terms of Reference (Options 1 and 2) it was suggested that the following amendment should be made:

- Such Christian and other religious denominations as, in the opinion of the authority, will appropriately reflect the principal religious traditions in the area, together with a place for a group who hold ~~non-religious beliefs~~ “non-religious philosophical convictions”. It is recognised that there will be occasions when the interests of efficiency override the requirement for directly proportionate representation (13 members)

The Monitoring Officer agreed with the adjustment in wording for consistency with the Education Act 1996 as amended and suggested that no further definition of non-religious philosophical convictions is made.

It was commented that the SACRE is currently lacking in representation from other principal religious traditions. It was agreed that the change from SACRE to SACs will provide an opportunity to seek representation from other principal religious traditions on the SAC. In the interim, once the terms of reference are approved, letters can be sent to add individuals to the Agreed Syllabus Conference. It was noted that there is also the option to co-opt advisers.

The report also includes proposals for teacher representation and Option 1 would continue to allow professional associations to make nominations but when it is not possible to secure representation and vacancies are outstanding, approaches to headteachers will be permitted. It was commented that s31 of the Education Act 1996 mentions teacher associations and approaching headteachers would be a move away from this. The Monitoring Officer suggested it was reasonable and proportionate to move away to achieve the overarching aim of the legislation. It was confirmed that it has been difficult to secure representation via the teacher associations and it would be possible to take nominations from headteachers to the associations for their approval.

A Member asked about representation of non-religious philosophical convictions referring to the wide range of these and whether approaches should be made for representation, and queried what changes to the RVE guidance the Church in Wales and Catholic Church are proposing. The Member commented that the Legislative Summary refers to a range of religious beliefs and links it to European case law. The new legislation still specifies Christianity and principal religions as represented in Wales (changed from UK) whilst the range applies to non-religious philosophical convictions. It is important to identify the representation that will aid us to shape the syllabus.

It was confirmed that the Church in Wales has a group of practitioners working on the RVE guidance and that will shortly be available online. A presentation can be provided at a future meeting. It closely aligns to the Welsh Government guidance.

The RVE Adviser added that all the advice that has been provided and other authorities are following is to be as inclusive as possible.

Considering non-religious philosophical convictions, the Monitoring Officer suggested trying to achieve a balance providing the example that Humanism as a non-religious philosophical conviction counteracts religious beliefs whereas the specificity of single issue convictions (e.g. veganism, climate change) can include religious belief. An explanation of how representation has been identified will provide transparency.

Option 1 was approved.

#### **5. Agreed Syllabus Conference - Timeline**

An explanation of the steps and timeline for an Agreed Syllabus Conference (ASC) was provided.

A query was raised about the numbers that can be involved in an ASC and it was confirmed that there was no restriction.

#### **6. Schools Update**

The RVE Adviser provided an update as follows:

- School have been advised that GCSE RE/RS has been added to the list of subjects that will have advance information (general topic areas, certain questions) in addition to the extra 25% reduction in the assessed content. Queries can be addressed to the RVE Adviser.
- WASACRE is developing professional learning for RVE based on the RVE guidance. A team of ten practitioners will be given 9 full days to create the resources before the end of the summer term. Online modules and related resources will be included.

#### **7. WASACRE Business**

It was noted that the term of office of Mrs. S. Gooding on the WASACRE Executive Committee is coming to an end. C.C. L. Brown expressed an interest in the vacancy and read out her personal statement.

The three groups voted in breakout rooms and ratified the nomination of C.C. L. Brown.

Mrs Gooding congratulated C.C. Brown on her nomination and said that she had enjoyed her term on the WASACRE Executive Committee.

The Chair , on behalf of SACRE, thanked Mrs Gooding for undertaking the role for the last three years.

**1. Declaration of Interests**

No declarations of interest were made.

**2. Public Open Forum**

No members of the public were present.

**3. To consider consultation responses and agree the content of the Agreed Syllabus with a recommendation to full Council to approve.**

The SACRE thanked consultees for the responses received.

It was noted that schools were grateful to receive the draft in a timely manner. It was observed that some concerns were raised in discussion with schools regarding the phrasing/tone of the

document which could be interpreted as at variance with the freedom that schools are encouraged to embrace to develop a bespoke curriculum noting that practitioners don't always have time to read the document.

It was commented that the reason for highlighting the comments in the agreed syllabus is that the legal summary in the Welsh Government Guidance is incorrect. It should state that "the religious traditions in Wales are in the main Christian while taking account of the teaching and practices of the other principal religions represented in Wales" and that "a range of non-religious philosophical convictions are held in Wales" and that the only change from the 1996 Act is that Wales replaces Great Britain. The Welsh Government document makes clear that the curriculum is bespoke and non-prescriptive. It is SACRE's obligation to ensure that the agreed syllabus aligns with legislation. In the legal summary, the emphasis on new elements draws attention from the elements that are staying the same. It was suggested that the section under consideration could be added as an appendix or to a different section but decided to retain the section in its original position.

The Pupil Voice responses were warmly received and it was queried if these could be included as an appendix.

The importance of communicating well with practitioners was stressed noting that highlighting the above points is drawing attention away from the syllabus.

It was noted that a practitioner will go to the Hwb for the curriculum, then the agreed syllabus commenting that if these mirror each other, there will be no issue. It is well known within the profession that teachers teach mainly Christianity while also taking account of other principal religions.

It was confirmed that many authorities in Wales have their agreed syllabus in place and are adopting the Welsh Government RVE guidance. A few have not yet got an agreed syllabus in place.

It was agreed that an explanation is needed to explain the concerns about the legal summary. Training on the document can be provided to schools and this will highlight the concerns and issues on the legal aspects to provide clarity.

It was suggested that bracketed points are added as follows:

- the religious traditions in Wales are in the main Christian while taking account of the teaching and practices of the other principal religions represented in Wales (this is a continuation of the Education Act 1996);

and

- that a range of non-religious philosophical convictions are held in Wales (this is an addition as part of the Curriculum for Wales 2022).

It was agreed that use of the Pupil Voice submissions would be subject to the permission of contributing schools being obtained. It is also important to be certain we have taken account of the views expressed before inclusion as additional material. As there were submissions from two schools only, it was discussed that all schools could be surveyed.

It was suggested that the inclusion of the example of man-made climate change should remain as an example of a belief that can be held by people of all faiths or none. This would also reflect that the Council has declared a climate emergency.

It was agreed that the section on post 16 would be reworded to say "Therefore RVE is now optional for these learners. However, this does not prevent individual schools with Sixth Forms from timetabling RVE for all students, if they wish to."

It was agreed that additional clarification would be added to the Complaints section.

Links to material on the websites of the Church in Wales and Roman Catholic faith (to follow) will be added.

Professional development will be the main focus and support for schools and teachers in designing their curriculum.

It was noted that a covering report will be required to present the Agreed Syllabus to Council.

Each Group deliberated and a vote was conducted with one vote per group:

All Groups voted for the agreed syllabus as presented plus the amendments agreed in the meeting today.

#### **4. To confirm the minutes of the previous meeting**

The minutes of the previous meeting on 26<sup>th</sup> April 2022 were confirmed as an accurate record subject to the addition of apologies for absence from Nick Pryor.

#### **5. Next Steps**

It was noted that comments were received that the consultation period was short. This was acknowledged noting that some consultees were able to respond within the limited timescales bearing in mind the need to progress the syllabus for implementation in schools in September.

A comment from Humanists UK has been addressed by the addition of some additional wording to clarify that Humanism is a non-religious philosophical conviction.

Actions were confirmed as:

- Taking note of G. Edward's comments and alter/amend the Humanist reference accordingly;
- It was discussed that it may be better to delay circulation of a Google form to all schools in Monmouthshire.
- The legal section will remain the same with the addition of brackets to explain what is new and what has stayed the same.
- Add clarification to the Complaints section
