

The public house is a two storey detached property on the main road of Gilwern a small residential village on the boarder of Abergavenny. The Brecon Canal flows past the rear of the public house. The public house on the ground floor has a main entrance with porch, bar area, kitchen, toilets and storage shed. The upper level acts as the residential premises for the tenants. The beer garden to the left of the premises is accessible from the canal, the main road pavement and side door to the bar. The plan of the premises is shown in this document.

Felinfoel Brewery Co Ltd is the Premises Licence Holder for this venue, the current licence was granted on the 4th November 2005. The Designated Premises Supervisor (DPS) named on the licence as the responsible person for running the public house was replaced by Mr Keith Wright in December 2013. The problems surrounding this premises commenced on the 30th December 2013 since Mr Wright became DPS.

This review is made following 5 local residential properties making numerous complaints and attending a public meeting to discuss the Bridgend Inn with Monmouthshire County Council staff. The complainants aren't willing to come forward because they fear retaliation. In total the Licensing Section has received 22 complaints, issued 5 warnings of a possible review and held 5 meetings with the Premises Licence Holder. To assist in highlighting these matters the events are shown in the summary of events table.

The licensing section has not received any complaints regarding the other two public houses in Gilwern over the last year, therefore the problems aren't widespread throughout the village.

Objective of Review Application

As the Licensing Enforcement Officer and a Responsible Authority under the Licensing Act 2003. I feel the Premises Licence Holder and Designated Premises Supervisor (DPS) have received sufficient warnings through two warning letters, five meetings and numerous emails. We have attempted to work with Felinfoel Brewery Co Ltd and Mr Keith Wright to improve the management of the premises and reduce the crime and disorder through antisocial behaviour and public nuisance connected with the premises. In accordance with section 11.10 of the guidance it states;

"Where authorised persons and responsible authorities have concerns about problems identified at premises, it is good practice for them to give licence holders early warning of their concerns and the need for improvement, and where possible they should advise the licence or certificate holder of the steps they need to take to address those concerns. A failure by the holder to respond to such warnings is expected to lead to a decision to apply for review. Co-operation at a local level in promoting the licensing objectives should be encouraged and reviews should not be used to undermine this co-operation"

Despite our efforts to work with the premises licence holder the venue has not improved with regards to crime and disorder or public nuisance. The supporting documents clearly show how problems escalated at the premises when Mr Keith Wright became DPS. Numerous complaints have been received anonymously. These complainants are not willing to publically voice their complaints because they fear retaliation. The Licence Holder stated Mr Wright is scheduled to leave the premises on the 23rd June however I have not received an application to vary DPS, therefore I recommend the removal of the current DPS to improve the management and overall control of the premises. To assist with the prevention of crime and disorder I also recommend an additional condition be attached to the premises licence, namely:-

"CCTV is installed and working. Recording the inside and outside areas of the premises to the satisfaction of the Police and Licensing Authority. Recordings will be made available for a minimum of 28 days to the Police and Licensing Authority upon request. If the CCTV equipment fails, the Police and Licensing Authority will be informed as soon as possible and immediate steps will be taken to put the equipment back into action. A notice will be displayed at the entrance to the premises advising that CCTV is in operation."

I believe CCTV should be installed to safeguard future tenants and customers due to the amount of violent incidents reported. CCTV may also act as a deterrent to prevent crime and disorder around the premises. Currently the premises has cameras showing the outside area only and as outlined in this document it is always very difficult for Monmouthshire County Council or the Police to view the footage within 7 days before the footage is erased.

As a Licensing Enforcement Officer I recognise a public house can act as a location for socialising and can bring communities together. I would not like to see the venue close, however I would like to ensure people living in the area do not live in fear of crime and disorder and public nuisance from the public house and its customers.

The recommendation to remove the current DPS will not result in the premises closing but will be helpful towards improving the management of the premises. Mr Keith Wright announced he has a scaffolding business and therefore the public

house isn't his only source of income. The Premises Licence Holder also has the right to retain staff currently employed by the DPS should the DPS be removed and a new person is given the position.

If the review is successful I feel the community surrounding the premises would benefit from better management and will have reassurance of extra security with CCTV in place monitoring the premises should the CCTV condition above become attached to the premises licence. Some residents have suggested they are considering selling their property because they can't sustain the amount of antisocial behaviour and public nuisance from the Bridgend Inn and its customers.

The licensing section has not received any complaints regarding the other two public houses in Gilwern over the last year, therefore the problems aren't widespread throughout the village.

Dear Samantha,

Further to your telephone conversation with __earlier today about the Bridgend Inn, please find below our account of the events that happened on Saturday night.

21:00 pm - We arrived home to the hum of music coming from the beer garden and beer garden was full of customers being rowdy. Rowdy behaviour mostly rather than music noise.

22:30 pm - Music has really ramped up now and can hear thudding baseline inside the house and lots of people shouting and swearing.

23:00 pm - Went to bed and tried to ignore noise and get to sleep. However, despite having our bedroom window soundproofed we can still hear loud music and people shouting at the top of their lungs in the beer garden. It seems that the entire pub's customers have congregated in the beer garden for the evening rather than spending time inside.

At 00:05 am - With the music and shouting/rowdiness still at a high volume, we now decide to call the police. Police ask if we want them to attend or just log the incident in records. We ask that they please attend to get the music turned off so that we can get some sleep tonight. Police told us we will have a bit of wait til they attend so we decide to sleep with the radio on in our room to try and drown out the music and shouting outside. Eventually fell asleep.

2:00 am - Woken up by a series of loud bangs outside in the street. My husband looked out the window and saw 10-15 pub customers running down Back Road. Then we saw that the windows and door had been smashed in at and the windows also smashed at our longer and where a man was shouting "Fuck off, Fuck off!" to someone repeatedly, so loudly that his voice became strained.

2:00-3:45 am - Pub customers continuing to congregate in beer garden and in the street. By 3:00 am most customers have left, with the last customer leaving the premises at approx 3:45 am. Several of the customers leaving the pub at these times were sounding their car horns. As the car horns are sounded upon leaving the premises every weekend, it makes it easy for us to note the times that they leave. I find it hard to believe that the pub adheres to its licensing time when customers are continuing to hang around for several hours after "closing time". They must be getting served alcohol into the early hours of the morning.

Yesterday morning, a blue car wing-mirror has been found lying on the pavement, I would suggest this is also related to Saturday night's criminal damage. Although Sunday evening was a quiet night by the pub's standards, the behaviour of the customers still falls below a standard of decency with shouting and swearing in the beer garden until approx 22:30/23:00 pm. You'd think shame would've kept them quiet and well-behaved after the previous night's shocking events.

Finally, we have other logs from previous night's events in April at the pub, which we are just sorting out at the moment. We will email you with these in due course. We would appreciate privacy and your discretion in this matter as we have witnessed now what happens when these people find out you have complained against them and we're worried for our safety.

On Sunday night loud music was playing until 11.45 and groups of people visible in the beer garden, drinking. It was clear that the they were still being served drinks. I tried to photograph this but the result is not clear. My neighbour has offered me a better camera but I'm, not sure of the legality of this (?). I went to bed at midnight and there were still many people at/in the pub at this time but the front door was closed.

A neighbour told me there was a fight at the pub well after 1am and I find it hard to believe that people would still be there at this time if there was no alcohol being served.

I spoke to another neighbour yesterday (Monday) who said that he had been in the pub but left at 10.30pm as 'it was clear what was going to happen (the fight)'.

We received a letter from the brewery whereby they state that they take their responsibilities seriously however this was signed by the same person who I initially contacted who told me that it was NOT their responsibility as they merely rented the place out to those who were. It doesn't give me much confidence in his sincerity I'm afraid.

Thank you all for attending the meeting on Tuesday 24th June 2014 to discuss the Bridgend Inn, Gilwern.

The meeting was arranged to discuss the breach of licensing condition in relation to the use of the beer garden, this was witnessed by PC Hilton and Leigh Beach (Licensing Enforcement Officer) on the 13th June 2014.

The condition states: Beer Garden will be closed at 22.00hrs

On the 13th June 2014, PC Hilton and Leigh parked outside the premises at 22.00hrs and witnessed between 25-30 customers sat outside in the beer garden. They then returned to the premises around 22.20hrs and the customers were still in the beer garden the officers then entered the premsies and spoke with the person serving behind the bar (Keith Wright DPS was not on the premises and the bar person did not have a number to contact him).

An email was then received from Keith Wright (DPS) that night at 23.57hrs:-

hi Samantha , this keith landlord ,I am not happy with the police turning up at 9.58 pm on Friday taking photos of people still in the beer garden ,, I am trying my best to get them inside the pub ,but I have been threaten on number of occasions ,my trade in the pub is gone down hill fast and why is people aloud to drink outside the beaufort pub in gilwern after 10.30 pm ,,,why aint they told ,,,I will be speaking to feinfoel brewery Monday morning ,,,police entering the pub with attitude towards customers ...we need another meeting to sort this out ,,it is a joke ,,, I am fed up of it

It seems as if Mr Wright is struggling to maintain control of the premises and that the complaints have intensified since he became the DPS in December 2013 and I understand that Dominic will be discussing our meeting with him and will report back to us with the outcome of that meeting.

It must also be noted that Huw is still in constant contact with one of the noise complainants who unfortunatley is unwilling to make a statement at this time due to the fear of reprisal.

In the meeting Dominic confirmed that the alterations to the windows and doors have been carried out and highlighted the alterations on the plan of the premises.

Linda also stated that any further breaches of licensing conditions may result in a prosecution being brought against Felinfoel Brewery or a review of the premsies licence.

Dear Samantha,

Just an update to keep you informed about happenings with the pub since the agreed changes.

Friday 27th - customers were rowdy from mid-pm onwards (I had a visitor and her 1-year-old in the house at the time who commented on the loud swearing we could hear). That night, at 23.30 pm we were disturbed by a domestic in the beer garden between a drunk man and woman. Loud shouting and swearing could be heard, and a woman sobbing. Then another woman screamed "Get f**king back in here now!". We went to bed only to be woken up at 02:30 by drunks leaving and being rowdy outside, one was carrying a plastic bag full of bottles of beer.

The weekend of 20th/21st/22nd was much worse - whole weekend was v rowdy. Customers arriving constantly tooting car horns. There were people using the beer garden well after the agreed cut-off of 22:00, with constant rowdiness and men shouting v On Saturday, there were constantly cars arriving and leaving noisily after 23:00 pm, with customers greeting each other loudly and shouting and swearing in the garden. At 23:19 another huge argument broke out in the beer garden, with what sounded like a drunk man and woman constantly shouting vile language and screaming at each other. We closed all of our windows but we could still hear every word. It died down again and we went to sleep. We were then woken up around 01:30am by the same man arguing in the beer garden; this man was screaming and swearing so loudly his voice had become hoarse. Customers eventually left (again, very noisily) about twenty minutes later.

Did a spot check take place over these two weekends?

I don't think it's helped that they've had all the doors to the pub wide open each weekend, allowing people to move in/out freely and the sound inside to carry. Perhaps if they could shut the doors it might help, otherwise what was the point of having brand new soundproof windows and doors installed...

Huw Owen keeps contacting but it would appear Environmental Health are completely powerless unless we attend Court which we aren't prepared to do for obvious reasons______

Just a quick update on events at the Bridgend Inn. Last night was another noisy night with anti-social behaviour.

We were disturbed by two taxi vans emptying into the pub at around midnight. An hour later at around 1am there was shouting outside. Then at 03:20 am we were woken again by more customers leaving the pub rowdily, swearing and heading down the street. The police were called (log 125) to report the breach of license and shouting/swearing. In the morning there were plant pots found smashed on the road further down the street.

In addition to this, last weekend there was music played Friday, Saturday and Sunday night at a high volume with customers leaving 00:45 on Sunday night who were then hanging around the street outside our house. This understandably concerned us due to the recent spate of vandalism from pub customers.

It is clear the license holders are continuing to show no respect for the license conditions and have no intention of running the pub reasonably despite the recent meetings.

I would be grateful if someone could look into this matter.

Hi Samantha,

Quick email about Friday night's events at the Bridgend Inn - another troublesome night. I think the recordings speak for themselves (taken from inside our bedroom). The beer garden was full all night and noisy, and the night ended in violence between two customers with several other customers getting involved, which we witnessed and called the Police who subsequently attended. We heard a man admitting to the Police that there had been trouble. The customer also kicked one of the cars outside the pub. This is all on the first recording which we took around midnight.

The second recording is of another argument which later broke out that kept us awake, at around 1am. You'll hear one male voice in particular, shouting and swearing at the top of his voice. His voice is very distinctive and he's the biggest troublemaker in the pub every weekend. After speaking to residents, it would appear that this man works at the pub and looks after the place in the licensee's absence. If this is the attitude of staff of the pub then how can we expect the customers to behave themselves?! You can also hear car horns beeping upon leaving around 1:00 am.

My neighbour texted me at midnight asking if we were also listening to all this like was and that was seething they had woken up, so it's clear all the residents here are sick of this now. This neighbour in particular is relying on us to report these events as no longer going to because has been a victim of vandalism from pub customers so this person will be unknown to you, but I think should be counted as another complainant.

I'd appreciate if these recordings are kept confidential because there are voices

Regrettably, yet again I'm having to write to you about the Bridgend Inn. Last week was a bad week.

Wednesday night was rowdy with the beer garden still full at 22:15, we could hear the music inside our bedroom. All the pub's doors were wide open which didn't help. The rowdiness was still going on at 22:45. Thursday was much the same, with customers leaving the beer garden noisily, shouting/screaming/swearing at 22:50 and again at 23:30.

Saturday night was the worst though - ending in a 2am wake up call for me (a
I needed this like a hole in the head....!) People were arguing, shouting and swearing in the beer garden at
23:35, one irate man screaming "Fuck off fuck off" repeatedly. Then I heard someone really lose it and he literally
roared as loud as he could, then screamed "JUST FUCK OFFFFF!!" and more slamming doors. Ten mins later, a large
number of customers spilled into the beer garden, more rowdiness ensued/foul language shouted etc. More people
were turning up and going into the pub (I could hear them greeting each other as they were so loud).

At 00:20 there was still constant shouting and rowdiness in beer garden, and 00:44 more whooping/jeering/shouting. At 1am there were customers singing and shouting in the street leaving the beer garden, playing music loudly on a mobile phone, followed by more aggressive angry shouting in the beer garden from the regular guy we always hear. Crowd of people shouting and whooping like a pack of hyenas in the beer garden, with foul language being shouted and raucous laughter. I eventually fell asleep until I was woken at 1:50 am by a large number of customers spilling into the beer garden and loud music suddenly kicking out - this could be heard inside my bedroom. There were men and women shouting/screaming amongst background noise of a LOT of customers still in the pub. The landlord & landlady were present all weekend. I recorded the 1:50am noise on my mobile after it woke me, I'll attach in a separate email for you to have a listen.

On Sunday there were still noisy customers in the beer garden at 22:15 pm.

I know it's a lengthy process of following protocol but this has been going on since April 2013 now, and formal complaints began in December 2013/January 2014. It made my a misery due to lack of rest and this time it has done the same again sadly. The last owner of our house was a single man in his 50s who lived mostly at his girlfriend's house therefore the noise wouldn't have affected him, hence no previous complaints.

So please could you tell me if we are anywhere near a solution in this matter? If it looks like the licensees are there for the long haul and nothing can be done to sort them out then I'd rather know, as I would then put my house on the market and try to move on.

Hi Samantha,

Further to our phone call just now, sorry just realised that I typed you an email about this weekend but never sent it.

Sat night there was a private party at the Bridgend, noise was horrendous from opening time (though I accept drunk people are going to be noisy until 10pm in the beer garden, or even 11pm by law). However it was still going on at 23:40 which is when I called the Police to log the incident under ref 606-11/10/14. I asked the police not to attend to get the music turned off in case anyone vandalises my house while I am home alone. They finally gave up around half midnight. All evening the music was ear-splittingly loud with constant shouting and screaming in the beer garden. We can usually avoid the noise to a certain extent in the kitchen which is at the back of our house, but not on Saturday.

I'm purposely staying up late at night in my kitchen just surfing the net these days to try and get away from the noise, sleep is impossible so no point going to bed.

The lack of sleep is really starting to get me down.

On Friday night I was disturbed intermittently by customers hanging out in the beer garden then leaving in dribs and drabs from 12:30 am up until 3:00 am when the last customers left (noisily), hanging around in the street chatting loudly. Also, last week my neighbour took CCTV footage at about 9pm of a drunk customer falling against his car as he was too drunk to stand, before getting in and driving home with a passenger in tow. hasn't gone to the police as doesn't want to get involved, but said the Police wouldn't be interested anyway as they would have to catch the drunk driver there and then not from CCTV the following day.

I look forward to an update after the meeting with all the responsible authorities.

here's a quick outline of Saturday night.

I went to bed at 9:30pm hoping for an early night before getting to but got no sleep because the beer garden was full of customers the entire evening, it was noisy from 9:30pm until 2:25am when the last customers left. Every now and then it would die down for short periods and go quiet, but then beer garden would soon fill up again, lots of rowdy antisocial behaviour etc. After speaking to a neighbour it would seem all doors were left open throughout the evening which must've encouraged customers to continue using the garden.

I called the police at roughly just after 11pm when the noise showed no signs of calming down. I then called the police again at 1:30am after being disturbed by a drunk man and woman arguing and being violent in the street. They were shouting and screaming and from the conversation overheard would appear the man was on his way to "fuck someone up" and she was trying to stop him. After calling her some names, he then grabbed her by the throat or hair (can't remember) and threw her to the ground in the street opposite my house. At this point I rang the police as I thought things were going to get nasty. I cannot stress to you enough how frightening incidents like this are to me as

There is a pattern where these people start drinking early in the day, then continue until after licensed hours and then end up getting aggressive and violent in the street near our houses. It's still fresh in my mind the incidents of last year when s' houses were vandalised and I'm worried this could happen to me. After the incident in the street, the drunk couple went back into the pub and then came back out later on arguing noisily again, this time with a crowd of people with them, all breaching the peace in the street outside the pub. If you check the CCTV it should show the couple leaving the pub and then going back in after their altercation.

If the licensing hours could be reduced that would help. Although having said that, not sure it would really as the owners seem quite happy to flout the laws after they've played ball for a few weeks.

Spoke to my neighbour who told me about a police car and then police van turning up New Years Eve around 1:30 am and making some arrests, while the rest of the customers ran off in the street. I can't confirm this though as I didn't see it.

We're all quite keen to get together for the residents' meeting that has been talked about, I think there are potentially six different households that would be able to take part, discretion is obviously paramount and people would be too afraid to attend something locally so it would need to take place away from the locality, possibly at the council offices?

Just following on from last night, the noise finally finished just after 2:00 am. Here's a quick chronology of the night....

22:25 - Can hear the noise from inside kitchen with all doors and windows closed. Called Police, beer garden full of people, loud music from inside the pub, doors sound open but cannot verify.

23:27 - From my bedroom can still hear constant shouting and rowdy antisocial behaviour, loud music, whooping and shouting outdoors. People entering the pub at this time greeted with lots of shouting, wailing, jeering. A man shouts "just open the fucking door!" to someone outside in a car ticking over. Customers in beer garden, loud music from inside the pub. Looked and saw that door to premises is WIDE open which accounts for why noise is particularly bad.

23:29 to 00:00am - More drunken, aggressive shouting outdoors. Shouting is now raucous. Large crowd of men chanting "WHO ARE WE, WHO ARE WE, WHO ARE WE" top of their lungs - very frightening. Customer noise reached ridiculous levels at this time, just men permanently shouting/roaring at the top of their voice, unintelligible shouting.

1:26 - Loud thudding music and customer noise can still be heard, shows no sign of stopping.

With reference to the above outlet, I do feel that making additional CCTV facilities a condition of the licence a disproportionate response.

We are of the opinion that all the problems outlined are directly related to the lack of the tenants management controls at the outlet.

I am not aware of these problems existing prior to this particular tenancy.

After us taking our ultimate sanction of terminating the tenancy, I feel we have addressed the root cause of all concerns.

It is likely that the outlet will remain closed for an extended period whilst an more suitable tenant is identified.

This situation will have a severe financial impact and the additional cost of a CCTV system upgrade will significantly add to this.

Of course, if the previous problems persist after the commencement of the new tenancy, we would introduce the CCTV upgrade at that point.

I would welcome any guidance you could give on the above.

Environmental Protection Act 1990 Complaint of noise from Bridgend Inn

Further to my telephone conversation with Mrs Wright. I write to confirm that a complaint has been made to this Section of an alleged noise nuisance from rowdy behaviour of customers in the beer garden area particularly during late evening hours and also loud music in recent weeks on Friday/Saturday nights.

As discussed, noise monitoring has not been undertaken to date. However, you will appreciate that Officers of this Section will have to investigate any further complaints in order to determine whether or not a statutory nuisance is being caused. Such investigations may include, at some time in the next 6 months, the installation of noise monitoring equipment in the complainant's home.

I can advise that there is no specific definition of what constitutes a statutory noise nuisance, but clearly the nature, duration, frequency and loudness of the noise are some of the essential factors to be considered. Where a nuisance is substantiated, a Notice is served under the provisions of the above Act, to require its abatement and prohibit its recurrence, contravention of which is an offence.

I therefore request, that if there are any grounds for the allegation, that you take the appropriate steps to prevent a recurrence of any nuisance.

I enclose a guidance leaflet which I trust you will find of use.

With regards to your correspondence re the Bridgend Inn dated 15th May 2014, I would like to enlighten you with the following issue should there be any further review.

Whilst I appreciated the letter from the brewery and the intended changes to the management of the public house I would like to point out that the letter was personally delivered by the tenants but not in the manor that you intended. I believe that some residents, like me, may have felt intimated when confronted with the letter by your tenants and asked, "Do you have a problem with the pub?".... What are people likely to say in this situation? I also understand that one resident was verbally abused and accused when issued with the same letter.

Whilst I notice double glazing has been installed to the pub and some efforts have been made by the tenants to eliminate the noise from the pub during unsociable hours, it has been observed on quite a few occasions that the new rules to ensure that the noise under the shelter, on the street benches and in the back yard after 10pm is not always adhered too with shouting, screaming and bad language clearly heard especially on Friday, Saturday and Sundays. On two occasions at least since your letter there have been altercations in the main street outside the pub and down Main Road during the early hours of the morning. The first being Saturday 21st June at 01.00hrs where a woman was being very verbal and aggressive toward a man in the middle of the road between the pub and shop opposite. The latest on the 26th July with disturbances all evening, and then after hours with two mini bus taxis dropping at least a dozen people off at the pub around 12.20am, then further disturbances with people finally vacating the pub noisily at 3am.

Cars are still speeding away from the premises in a 30mph zone over the pedestrian crossing, down Main Road and Back Road. I do confirm that music heard outside the premises is now very infrequent since your management review, and may only be when staff are left to manage the pub in the tenants absence such as at weekends.

Whilst all efforts have been made to tidy and paint the premises, I wonder if the tenants are actually suitable and committed to applying, enforcing and setting examples to make the premises hospitable for all visitors to the area. It appears to become a private 'club' for the friends and personal acquaintances of the tenants during the weekends and on these occasions shouting and obscene language can be heard in the beer garden and in the street; not the example that should be set by your tenants or even encouraged and to be heard by the general public. I feel sure that respectable visitors to the area especially those with families do not frequent the place for very long and I know that many close residents and neighbours to the pub are reluctant to frequent the premises.

RE: The Bridgend Inn, Gilwern

I am writing to you, as promised, following our meeting at the pub on Wednesday 1st October 2014.

At that meeting we discussed ongoing issues at the pub and you confirmed that, as far as you were aware, there were no new incidents to report. I discussed my previous meetings with the licensing authorities and made you aware that not having CCTV footage available for future reported incidents is unacceptable.

We discussed the new CCTV system, which you confirmed had now been installed and was fully operational. You confirmed that it would allow for 14 days' worth of recording to be held on file and I advised you to ensure that after 14 days you should ensure that the recordings were saved to another data storage device so that footage would be available for an extended period of time. I confirmed that I would make Samantha Winn at Monmouthshire County Council licensing department aware that the new CCTV system was operating fully.

We then discussed your plans for a party on the coming Saturday, the 4th October, which you explained was for your daughter's birthday, although they would be leaving the pub earlier on that evening.

Finally I confirmed to you that, should there be any further incidents at the pub that could not be clearly shown to be unrelated to the pub entirely I would be left with no option but to give you notice to leave the premises under the terms of your tenancy agreement.

RE: Licensing Act 2003 – Bridgend Inn, 49 Main Road, Gilwern, Abergavenny, Monmouthshire.

I refer to my telephone conversation with Mr Dominic Rowley on Wednesday the 13th May 2015. Mr Rowley stated that the Designated Premises Supervisor (DPS) Mr Wright intends to surrender his contract with your company and his position as DPS. Mr Rowley also stated that he intends to change the venue into more of a restaurant/food outlet with an alternative DPS.

As previously discussed at meetings held with a representative of your brewery there has been continual crime and disorder, public nuisance and alleged beaches of conditions at the premises. At the meeting held on 23rd April 2015, the Authority stated that they may carry out a Review of the premises licence with a recommendation that the DPS be removed and that the requirement to have CCTV at the premises to be a condition of the premises licence. During my conversation with Mr Rowley on the 13th May he felt a CCTV condition would not be required, as he believes the new DPS should be given a chance to alleviate the current problems.

However, we still feel that a CCTV condition should be attached to the premises licence. At present CCTV is recording outside the venue for 7 days only. We have experienced problems viewing the CCTV and difficulty downloading the footage. As such we feel the following condition should be added to your licence:-

"CCTV is installed and working to the satisfaction of the Police and Licensing Authority. Recording the inside and outside areas of the premises. Recordings will be made available for a minimum of 28 days to the Police and Licensing Authority upon request. If the CCTV equipment fails, the Police and Licensing Authority will be informed as soon as possible and immediate steps will be taken to put the equipment back into action. A notice will be displayed at the entrance to the premises advising that CCTV is in operation."

The DPS has indicated he will submit his resignation as stated above, however we do not have a definitive date to confirm when Mr Wright will leave the premises or cease to be the DPS. Whilst we support appointing a new DPS we have no evidence that the new person you intend to appoint will improve the management of the premises.

There has been a number of complaints against the venue that give rise to concern. Therefore, we feel it is essential for CCTV to become a condition of the licence to prevent further crime and disorder and to gather essential evidence either to prove or disprove further complaints as and when required.

The variation of your licence to include the above CCTV condition can be carried out by means of a minor variation application and as such I have enclosed an application form for this purpose.

Can you please confirm within 14 days of the date of this letter the leaving date for Mr Wright and if/ when you intend to apply for the minor variation.

I am writing to you following your letter of 15th May, regarding the ongoing situation at the Bridgend Inn in Gilwern.

We take the behaviour of our tenants very seriously and firmly believe that a good pub needs to be at the heart of its community and not at loggerheads with local residents. For that very reason we have taken a course of action that will lead to the tenant leaving the premises on Tuesday 23rd June 2015, which is well before the end of the legally required notice period of 6 months. The action we have taken will undoubtedly leave the pub closed for a period of time while we search for a new tenant. Whilst regrettable, we believe that this action is required in order to bring the situation to a close and is simply the right thing to do.

In light of our decision to pursue this action, the implications it will have for Felinfoel Brewery as well as detailed consultations with our company's licensing solicitors, we have decided not to apply for a minor variation regarding internal CCTV.

We are fully committed to searching for a quality operator who will be able to trade the pub successfully within the terms of the licence and who will look to welcome all the members of the local community.

Should there continue to be issues relating to neighbourhood complaints once we have a new tenant on site we will, as a matter of course, reconsider things once again but I am confident that with the right operator the pub can be an asset to the community in Gilwern.

I am a serving Police Constable with Heddlu Gwent Police and am currently stationed at Abergavenny Police Station.

On Saturday 24th January 2015 I was working a tour of duty from 16:00 until 03:00 hours.

At 00:30 hours on 25th January 2015 I attended to The Bridgend Public House, Main Road, Gilwern, Abergavenny as a result of a call to police reporting a noise disturbance at the premise.

I attended in company with PC 83 BEAUMONT- FIELDING, upon our arrival there was no noise,

I noted that the Public House was still open and there were numerous people within some of whome were drinking at this time.

We then left the area however at 01:17 hours there was a further call stating that there was a male and female fighting at the location.

At 01:40 hours there was a third call linked to the Public House this call again relating to a male and female fighting.

I arrived at the BRIDGEND INN at 01:51 hours, on this occasion was in company with PC 83 BEAUMONT FIELDING and PS 33 VIRGO.

I walked into the side beer garden and was met by two females who were heavily intoxicated and they stated that they were awaiting a taxi.

I then walked in to the bar via the side entrance, the door was open and the lights were all on within, the pub appeared to be open at this time.

There was male behind the bar, who identified himself as the bar staff, I asked to speak with the licensee, this male stated that he wasn't available and that it was him who was in charge and who was responsible for locking up.

At this time there were four males sat at the bar, they were all under the influence and all had pints of alcohol in their hands.

PC Hilton and I to his residential property above the public house. I cautioned Keith WRIGHT at 14:02hrs for a suspected a breach of licensing conditions.

I asked "Do you understand the caution?"

He said "yes."

Keith WRIGHT informed me that Dominic ROWLEY was running late and we agreed to start.

Keith WRIGHT "VIV who kicked off over the weekend was the nominated DPS."

PC Hilton explained to Keith WRIGHT that he is able to authorise other people to sell alcohol however the DPS named on the Licence always has overall responsibility.

PC Hilton asked "Do you know the name of the person you nominated to run the pub in your absence?"

WRIGHT replied "I only know him as VIV, he walked in here and dragged his girlfriend into the street and hit her as you will see on the CCTV"

We agreed to view the CCTV and walked to the CCTV room. Keith WRIGHT searched through the recordings as Dominic ROWLEY from Felinfoel Brewery Co Ltd joined us with Jayne WRIGHT. I cautioned ROWLEY at approximately 14:12hrs for a suspected breach of licensing conditions and asked if he understood the caution. He said "Yes that's fine"

The CCTV footage showed a man running up the road and approach the pub.

WRIGHT identified this male as VIV the male entered through the unlocked front door at the recorded time of 01:12hrs on the 25/01/2015. The male identified as VIV exits a minute later with two females, he pushes one and drags another female into the road and forcefully puts her on the ground of the main road.

another male exits the pub and stands aside, looking on. The violent male VIV then dragged a female to the opposite side of the road outside a residential property, again the female is forced to the floor. VIV walks back to the pub and enters the beer garden with the other male.

I requested to see the beer garden CCTV but no footage was available for this area. Keith WRIGHT said "They went in the garden to cool down."

We all made our way to another room and sat down. Keith WRIGHT confirmed he was away in a caravan that weekend in Carmarthenshire.

I asked "If VIV entered after hours to drag his girlfriend out, who was running the bar that evening?"

Keith WRIGHT said "Tommy WRIGHT was running the bar, 24 years of age. VIV wasn't working because he was babysitting"

I asked "did you explain the licence to Tommy?"

Keith WRIGHT replied "Yes I have, time and time again."

I asked "Do you have any CCTV showing inside the premises?"

Keith WRIGHT said "I did, but the two cameras inside the pub are broken"

Jayne WRIGHT said the pub was closed on time but they couldn't get the girl out because she was paralytically drunk.

I asked "Why did the male enter at 1:10hrs when the pub should have been closed and why did it take 40 minutes after hours to eject her?"

Keith WRIGHT said "I was away and when I came back the pub was locked, it looked like we had no problems....I then found out this happened, but it was closed"

PC HILTON said "I received information from a police officer that there were people sat in the beer garden at 00:30hrs"

Keith WRIGHT said "I think the Police arrived but did not enter."

Jane WRIGHT said "That was probably them trying to get her away"

I asked "Why was the girl served alcohol on the premises if she was paralitically Drunk?"

Jayne WRIGHT said "The staff told me she didn't have many drinks here"

PC HILTON asked "Could you find out the full name and details of VIV?"

Jayne WRIGHT "I know his name is Nathan VIVEASH he has a personal licence with Monmouthshire"

ROWLEY and Keith WRIGHT both said they are finding it difficult to keep people out of the beer garden after 22:00hrs.

PC HILTON said "it's your responsibility to comply with the condition attached to the Licence. Do you have signs advertising the beer garden needs to be closed at 22:00hrs?"

Jayne WRIGHT said "Yes there are signs on the beer garden door"

I conducted a premises risk assessment (appendix a) it highlighted the poor management of the premises. Keith WRIGHT was unaware of what his licence enabled him to do other than sell alcohol until midnight and play music. He did not know what Late Night Refreshment was. I asked if he used Challenge 21 as the underage drinking policy. Keith WRIGHT replied "what's that?"

nominated as responsible to run premises in his absence. The person nominated to run the premises in his absence was not in control because he was babysitting. The male nominated as responsible entered the premises to assault a female and breach the conditions. I concluded the risk assessment with no confidence in the current DPS or management team and I do not feel the Licence Holder made necessary steps to prevent the breach of licensing conditions. The meeting ended, I walked with PC Hilton down stairs to the public house area, VIVEASH approached us and asked "should I rip up this personal licence"

PC HILTON replied "No don't rip it up"

VIVEASH replied "I'm sorry for what I did"

I made note of his full name and personal licence details issued by Monmouthshire County Council, Mr Nathan Lee VIVEASH, licence number PLH977
