# Secretary's Report

---

This report marks the completion of the second year of the current LAF from its first meeting on 25 January 2017. The forum has continued to operate below the statutory minimum during the year. However the forum's meeting in November formed part of a very well attended all day workshop on the Rights of Way Improvement Plan and related issues.

The more formal approach to the LAF agenda's, reports and meetings has continued this year and has been successful in focussing the LAF activities. However workload pressures within the appointing authority has meant the LAF has only met on two occasions during the year.

During the past year the forum met on 20 February 2018 at Monmouth and 21 November 2018 also in Monmouth.

The LAF members continue to contribute to the resolution and development of countryside access issues and policy in Monmouthshire.

We are very grateful for their voluntary input and for the experience and advice they provide and their commitment to the work of the forum.

# The Year reviewed

---

These are some of the issues where the LAF have advised and been consulted:-

## 1. RoWIP Review

The forum has considered the RoWIP Review in February to review the assessment of the delivery of the current ROWIP and in November to consider issues arising from the ROWIP assessment and consultation, including the Rights of Way Improvement Plan Condition of the Network and Opportunities Assessment Report 2017/18 and Outdoor Disability & Health Assessment (previously circulated).

A well-attended workshop considered the following:

- a) Wellbeing Outcomes and Service Priorities
- b) The extent to which local rights of way meet the present and likely future needs of the public
- c) Enforcement Priorities
- d) Bridge replacement prioritisation
- e) Other matters arising or of concern.

The workshop results help inform the Council's formal decision to proceed with a review of the ROWIP. They will also inform the consultative draft and associated policy development.

The RoWIP review is likely to continue to be the main focus of the LAF's work over the coming year. The LAF Secretary will ensure the LAF is appropriately briefed and involved.

## 3. Prioritisation

The forum has further reviewed the current approach to prioritising claims for Definitive Map Modification Orders, the legal process by which the Definitive Map and Statement can be modified.

## 4. Consultations

There have been no substantive consultations during the period.

## 5. Projects and funding

We have received updates on the options for a new delivery model for the future delivery of Tourism, Leisure, Cultural & Youth Services (TLCY), including countryside services, countryside access sites and rights of way.

We have received an update on the Lower Wye Valley Catchments Green Infrastructure and Natural Flood Management Project, a joint MCC and Wye Valley AONB project supported by grant aid from Natural Resources Wales.

## Future Work Programme

---

The forum's future work programme for 2019/20 is primarily to continue to advise in respect of the Rights of Way Improvement Plan Review which will progress during the year and to respond as appropriately to any additional consultations that may arise. It remains as approved by the LAF on 7 September 2017 (see below)



# Role of the Forum

---

The Countryside and Rights of Way Act 2000 requires local authorities and National Parks, to establish Local Access Forums (LAFs). These forums advise Natural Resources Wales (NRW), local authorities and National Park authorities on ways in which local access can be improved.

The statutory purpose of LAFs is to advise on the improvement of public access to land for the purposes of open-air recreation and enjoyment of the area in which they are established. LAF's must have regard to the needs of land management, natural beauty, flora, fauna, and geological and physiographical features.

The following bodies must have regard to any relevant advice given by the LAF: National Park authority, the highway authority, Natural Resources Wales, Welsh Government and, for matters relating to defence or security, the Secretary of State.

The forums must have a balance between:

- Users of access land and local rights of way; and
- Landowners and occupiers of access land and land with rights of way.

People with other interests especially relevant to the area will also be represented.

The Regulations specify there should be between 12 and 22 members, including the Chair and the Deputy. In addition the Chair may invite other individuals and organisations to observe and give advice.

Members are appointed by the Appointing Authority the local Highway Authority or National Park Authority. Monmouthshire County Council is the appointing authority for the Monmouthshire LAF which covers the administrative County of Monmouthshire outside the boundary of the Brecon Beacons National Park. It includes the Wye Valley Area of Outstanding Beauty within the county.

Within the area there are Registered Commons and 1657 Kilometres of registered Public Rights of Way. There is in addition a substantial length of County Unclassified Roads, the responsibility of the Highway Section, many of which are un-surfaced.

Monmouthshire County Council and the Brecon Beacons National Park Authority have a Delegated Responsibility Agreement covering most aspects of the management of Public Rights of Way within the National Park.
