Good Morning Both

We have received a request to waiver the block day street trading consent fee for The Hood Memorial Hall. The applicant has stated the below when asked to consider a waiver for the fee;

All proceeds from the fete will go towards raising funds for the Hood Memorial Hall which is a registered charity (registration number 524336 at the Charity Commission). This fee would outweigh the charges paid for by the traders and would represent something like 20% of the net funds we could reasonably expect to raise at the event (and the amount we expect to raise is at some risk given we do not know how well the event will be attended given the coronavirus pandemic). As we are a local community charity, with all funds raised ploughed back into the maintenance and development of the Hood Memorial Hall and its grounds and other local causes, we believe the council should consider our request for an exemption

The next event is being held on Saturday 4th September 2021, the next Licensing & Regulatory committee date is 14th September 2021. Therefore, could I request this is sent to the Chair & Vice Chair of the Licensing & Regulatory Committee to be considered for the event on Saturday 4th September 2021? I will then submit a report to the

Licensing & Regulatory committee with regards to a waiver for the fee for future events of the same nature on 14th September 2021.
