THIS DECLARATION FORM MUST BE COMPLETED BY ALL COUNCILLORS AND RETURNED TO THE MONITORING OFFICER WITHIN 28 DAYS OF YOUR ELECTION OR APPOINTMENT TO OFFICE, AND WITHIN 28 DAYS OF ANY CHANGE TO YOUR INTERESTS.

ADVICE TO COUNCILLORS:

The law and the Council's Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

(There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).

This form enables you to record those interests, or to show that you have no such interests to declare.

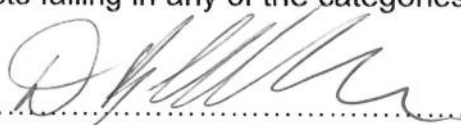

5. Details of any contract for goods, services or works made between your authority and you or a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in (4) above;

6. Details of any land in which you have a beneficial interest and which is in the area of your authority;

7. Details of any land where the landlord is your authority and the tenant is a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in (4) above;

8. Details of any body to which you have been elected, appointed or nominated by your authority;

9. Details of any —

- (a) public authority or body exercising functions of a public nature;
- (b) company, industrial and provident society, charity, or body directed to charitable purposes;
- (c) body whose principal purposes include the influence of public opinion or policy;
- (d) trade union or professional association; or
- (e) private club, society or association operating within your authority's area,
in which you have membership or hold a position of general control or management;

10. Details of any land in your authority's area in which you have a licence (alone or jointly with others) to occupy for 28 days or longer;
