#### Revised Social Justice Strategy – Policy Coherence

- Consider the **application of a number of social justice guiding principles** to proposed activities (possibly forming the basis of a pledge or charter):
  - Co-production /participation;
  - Equity
  - Page Reducing disadvantage;
  - Inter-generational justice (including Ageing Well, CYP and future generations)
- **Provide policy coherence** for individual targeted actions plans i.e. Tackling Poverty and Inequality; Food Development Action Plan; Homeless Transition: Phase Four - Mental Health/Well-being/Social Isolation and Digital Inclusion, Phase Two Community Support Network;
- Integrate with Equalities Plan and Colleague Community Volunteering Framework



# The PSB is evolving: Adopting a place based approach to partnership working

- Build on overwhelming response of community action and participation during the pandemic;
- PSB leading a relational place based, multi-agency support structure that both challenges and inspires the best outcomes for our communities;
- Supporting area based working for prevention and early intervention;
- PSB to provide governance and direction to steer the place based teams, comprising of multi-agency staff from across the PSB partners organisations;
- Staff to work in a networked/virtual way becoming part of the place based area teams across the county, working to a mutually agreed hyper local delivery plan






#### Tackling Poverty & Inequality Action Plan

• Aim: We will work together to promote equitable prosperity in Monmouthshire and wherever possible to prevent our citizens experiencing poverty.

We recognise that, despite our efforts, there will be points in people's lives at which they experience financial hardship. When this does occur we will come together to provide support to make that experience as brief, as infrequent and as manageable as possible. We will help people to emerge from that experience with greater levels of resilience.

#### What do we mean by 'poverty'?

Joseph Rowntree Foundation definition: 'When a person's resources (mainly their material resources) are not sufficient to meet their minimum needs (including social participation).'

Statistical definition: households with income below 60% UK median.




### Tackling Poverty & Inequality Action Plan

- Priorities:
- Employability skills and employment support
- Children and Young People
- Mental health / emotional support / coping skills
- Tackling the effects of inequality
- Crisis prevention: helping people to access support at earliest opportunity, and support to navigate available offer






#### Tackling Poverty & Inequality Action Plan



- E.g. structural issues such labour market opportunities, welfare provision, cost of housing (This is where we seek to lobby, influence – and sometimes disrupt)
- E.g. in-county transport, Shared Benefit Service, housing support, Rural Development Programme, FSM Strategy (our role is to connect and enable, provide services efficiently)
- E.g. Community Development/ social capital building, Flying Start / Acorn, Community Learning, Community Psychology Service, community centres, Community Focused Schools, community car schemes, Fare Share (creating the conditions in which people can be supported and thrive)
- E.g. work coaches, Communities 4 Work+, budgeting support, food banks, individual mental health support, Skills@Work, Housing Support Gateway (joined-up, wrap around support)

- Number of households below 50% and below 60% GB median income (statistical definition of poverty)
- Number of people in receipt of Universal Credit: in employent and not in employment
- Rumber of Housing Gateway Referrals
- Natural wave of live applications on housing register
- Number of food bank vouchers issued by MCC
- Because we also know that poverty is fundamentally a qualitative experience, we will also work with our communities to develop storytelling and narrative that captures the lived experiences of those living in and on the edge of poverty in our county.






#### Purpose

- To build sustainable, local economic growth through the provision of support for local food businesses and sharing of intelligence to help boost local procurement opportunities and create more jobs;
- To improve diversity and usage of land for food production to improve selfsufficiency whilst conserving and enhancing our natural resources;
- To consider how food is produced, packaged, distributed and disposed of in order to reduce waste, energy consumption and increase recycling and composting; and
- To improve food security and the health and wellbeing of Monmouthshire residents through increasing the availability of fresh, local, affordable produce.

- Increase in no. of local food suppliers regularly supplying produce to  $\mathop{\rm MCC}_{\neg}$  ;
- $\mathbb{B}^{\mathbb{N}}$  crease in MCC local food procurement from 20% to 25%;
- Establishment of a strategic Monmouthshire Food Partnership;
- No. of school children engaged in reducing school food waste;
- No. of MCC catering staff trained in 'scratch' cooking
- Reduction of food waste by 10% in schools
