That Cabinet consider a capital outturn spend of £40.03m against a revised budget of £40.98million, after proposed slippage of £17.5 million, resulting in a net underspend of £951k. That Cabinet consider and approve the £17.5m capital slippage recommended (detailed in appendix 2), paying attention to those schemes described in para 3.3.6 where slippage has been requested by the service manager but is not being recommended to slip (£198k). That Cabinet considers the use of reserves proposed in para 3.4.1, That Cabinet supports the apportionment of general underspend in supplementing reserve levels as described in para 3.4.3 below, i.e.: Priority Investment Fund £570k
