	distance route between London and Fishguard via Reading, Bath, Bristol,	
	Newport, Swansea, Carmarthen, Tenby, Haverfordwest and St.David's a	
	distance of 432 miles) runs through the south of Monmouthshire between	
	Chepstow and Magor and that there is approximately a one and half mile	
	stretch of that cycle route, (which is traffic-free and therefore family friendly)	
	between Rogiet and Undy which is in such a deplorable condition that it is	
	virtually impossible for an adult cyclist to cycle upon and is he further aware	
	that it is entirely impossible for a child cyclist and a wheelchair user to use the	
	path because the finished surface is so rough and covered with what appears	
	to be broken bricks and building materials that have simply been spread	
	across the surface and is he also aware that this section of the NCR 4 is	
	probably, without exaggeration, in the worst condition than any of the 432	
	miles entire length of this major cycling route and that SUSTRANS the cycling	

	charity organisation has received numerous complaints about the condition of this path and what is he prepared to do to rectify the problem and restore the surface of this very popular cycle/pedestrian/wheelchair path to a condition "fit for purpose"?
