## **PURPOSE:**

The purpose of this report is:

To advise the Cabinet Member of the results of the consultation on Draft Supplementary Planning Guidance (SPG) on Renewable Energy and Energy Efficiency (REEE) to support the policies of the Monmouthshire Local Development Plan (LDP) and a Draft Planning Advice Note on Wind Turbine Development: Landscape and Visual Impact Assessment (LVIA) Requirements.

To seek the Cabinet Member's agreement to formally adopt the SPG and Planning Advice Note.

#### **DECISION:**

To formally adopt the Draft REEE SPG as SPG to support the Monmouthshire LDP.

To formally adopt the Draft Planning Advice Note on Wind Turbine Development: LVIA Requirements as an advice note to assist in the determination of planning applications for Wind Turbine Schemes.

#### **REASONS:**

Under the Planning Act (2004) and associated Regulations, all local planning authorities are required to produce a LDP. The Monmouthshire LDP was adopted on 27 February 2014 and decisions on planning applications are now being taken in accordance with policies and proposals in the LDP. The REEE SPG provides further explanation and guidance on the way in which the relevant policies of the LDP will be implemented.
