This report marks the completion of the third year of the current LAF from its first meeting on 25 January 2017. The forum has continued to operate below the statutory minimum during the year. However the forum's has continued to contribute to the Rights of Way Improvement Plan, including considering the responses to public consultation and the proposed final plan.


The more formal approach to the LAF agenda's, reports and meetings has continued this year and has been successful in focussing the LAF activities. Workload pressures within the appointing authority has meant the LAF has met on three occasions during the year.

During the past year the forum met on 10 July 2019 in Usk, 19 November 2019 in Monmouth and 22 January 2020 in Usk also in Monmouth.

The LAF members continue to contribute to the resolution and development of countryside access issues and policy in Monmouthshire.

We are very grateful for their voluntary input and for the experience and advice they provide and their commitment to the work of the forum.

The Year reviewed

These are some of the issues where the LAF have advised and been consulted:-

1. RoWIP Review

The forum has considered the RoWIP Review, including the pre-consultation draft in July and the results of the public consultations in November 2019 and January 2020, and the proposed post consultation draft of the Countryside Access (Rights of Way) Improvement Plan in January 2020, prior to its proposed consideration by the Council's cabinet in February 2020.

Implementation of the new RoWIP including the preparation of a RoWIP delivery plan is likely to continue to be the main focus of the LAF's work over the coming year. The LAF Secretary and the Countryside Access Manager will ensure the LAF is appropriately briefed and involved.

2. Consultations

The LAF has responded to consultations on the Brecon Beacons RoWIP, the Wye Valley AONB Management Plan and a proposed road traffic order on Glynwood Road (Cross Farm to Fairoak) Tintern.


We have received updates from the Chair and Vice Chair and the Countryside Access Manager from the LAF Chairs joint meetings, including on the progress of Welsh Government's proposed legislative changes.

3. Projects and funding

We have received updates on the options for a new delivery mode, now established as MonLife, for the future delivery of Tourism, Leisure, Cultural & Youth Services, including countryside services, countryside access sites and rights of way.

We have received updates on various externally funded programmes and projects and the recruitment of the new LAF.

We have also received an update on progress on the Lower Wye Valley Catchments Green Infrastructure and Natural Flood Management Project, a joint MCC and Wye Valley AONB project supported by grant aid from Natural Resources Wales.



Role of the Forum

The Countryside and Rights of Way Act 2000 requires local authorities and National Parks, to establish Local Access Forums (LAFs). These forums advise Natural Resources Wales (NRW), local authorities and National Park authorities on ways in which local access can be improved.

The statutory purpose of LAFs is to advise on the improvement of public access to land for the purposes of open-air recreation and enjoyment of the area in which they are established. LAF's must have regard to the needs of land management, natural beauty, flora, fauna, and geological and physiographical features.

The following bodies must have regard to any relevant advice given by the LAF: National Park authority, the highway authority, Natural Resources Wales, Welsh Government and, for matters relating to defence or security, the Secretary of State.

The forums must have a balance between:

- Users of access land and local rights of way; and
- Landowners and occupiers of access land and land with rights of way.


People with other interests especially relevant to the area will also be represented.

The Regulations specify there should be between 12 and 22 members, including the Chair and the Deputy. In addition the Chair may invite other individuals and organisations to observe and give advice.

Members are appointed by the Appointing Authority the local Highway Authority or National Park Authority. Monmouthshire County Council is the appointing authority for the Monmouthshire LAF which covers the administrative County of Monmouthshire outside the boundary of the Brecon Beacons National Park. It includes the Wye Valley Area of Outstanding Beauty within the county.

Within the area there are Registered Commons and 1657 Kilometres of registered Public Rights of Way. There is in addition a substantial length of County Unclassified Roads, the responsibility of the Highway Section, many of which are un-surfaced.

Monmouthshire County Council and the Brecon Beacons National Park Authority have a Delegated Responsibility Agreement covering most aspects of the management of Public Rights of Way within the National Park.






