## 1. PURPOSE:

- 1.1 To seek approval to extend three Public Spaces Protection Orders (PSPO) in respect of Bailey Park, Abergavenny; Abergavenny Lower, Abergavenny and Monmouth Town, Monmouth in Monmouthshire.

## 2. RECOMMENDATIONS:

- 2.1 To approve the extension of Public Spaces Protection Orders in respect of Bailey Park, Abergavenny; Abergavenny Lower and Monmouth Town in Monmouthshire.
- 2.2 That the three PSPOs which are due to expire 20<sup>th</sup> October 2020, be extended for a further three years to 20<sup>th</sup> October 2023.

## 3. KEY ISSUES:

### 3.1 Key Issues - Bailey Park

- 3.1.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Bailey Park connected to the consumption of alcohol. The boundary of the park is identified on the attached map at **Appendix A1**.
- 3.1.2 Due to these issues a Designated Public Place Order (DPPO) was imposed in September 2008 by the Licensing Committee of Monmouthshire County Council.
- 3.1.3 The order provided the police with powers to deal with persons in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.
- 3.1.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20<sup>th</sup> October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, when they would convert into a PSPO. This current order is due to expire in October 2020.

3.1.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB in Bailey Park between 2018 and 2020. Gwent Police Logs data are attached at **Appendix A2**.

### 3.2 Key Issues – Abergavenny Town, Abergavenny

3.2.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Abergavenny Town connected to the consumption of alcohol. The boundary of the area concerned is identified on the attached map at **Appendix B1**.

3.2.2 Due to these issues a Designated Public Place Order (DPPO) was imposed in September 2008 by the Licensing Committee of Monmouthshire County Council.

3.2.3 The order provided the police with powers to deal with persons in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.

3.2.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20<sup>th</sup> October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, when they would convert into a PSPO. This current order is due to expire in October 2020.

3.2.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB in Abergavenny Town between 2018 and 2020. Gwent Police Logs data are attached at **Appendix B2**.

### 3.3 Key Issues – Monmouth Town, Monmouth

3.3.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Monmouth Town connected to the consumption of alcohol. The boundary of the area concerned is identified on the attached map at **Appendix C1**.

3.3.2 Due to these issues a Designated Public Place Order (DPPO) was imposed in October 2008 by the Licensing Committee of Monmouthshire County Council.

3.3.3 The order provided the police with powers to deal with persons in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.

3.3.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20<sup>th</sup> October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, when they would convert into a PSPO. This current order is due to expire in October 2020.

3.3.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB Monmouth Town between 2018 and 2020. Gwent Police Logs data are attached at **Appendix C2**.

#### **4. REASONS:**

- 4.1 Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 states Local Authorities have the responsibility to make a Public Spaces Protection Order providing two conditions are met:
- 4.2 The first condition is that –
- (a) Activities carried out in a public space within the authority's area have had a detrimental effect on the quality of life of those in the locality, or
  - (b) It is likely that activities will be carried on in a public place within that area and they will have such an effect.
- 4.3 The second condition is that the effect, or likely effect, of the activities –
- (a) Is, or is likely to be, of a persistent or continuing nature;
  - (b) Is, or is likely to be, such as to make the activities unreasonable, and,
  - (c) Justifies the restrictions imposed by the police.
- 4.4 A Public Spaces Protection Order is an Order that prohibits specified activities taking place in a restricted area.
- 4.5 Not to extend the PSPOs would mean that the orders will expire on 20<sup>th</sup> October 2020 and will be discharged, that would undoubtedly give rise to the return of the problems within the localities, to the detriment of the local communities.

#### **5. RESOURCE IMPLICATIONS:**

- 5.1 The Community Safety Officer will work with Gwent Police and community partners as part of the substantive role to issue the Public Spaces Protection Orders and Gwent Police will enforce the Order through their usual policing practices.
- 5.2 Should the Order be granted, there is a requirement for signage to be erected outlining the conditions of the Order. The cost of signage will be met from the Community Safety existing budgets.

#### **6. WELLBEING OF FUTURE GENERATIONS IMPLICATIONS (INCORPORATING EQUALITIES, SUSTAINABILITY, SAFEGUARDING AND CORPORATE PARENTING)**

#### **7. CONSULTEES**

- 7.1 Under the Anti-social Behaviour, Crime and Policing Act 2014, no consultation was required in 2017 to convert the DPPO into the PSPO as no objections had been raised in the preceding three years of the order. From the 20<sup>th</sup> October 2017 they were treated as PSPO's.

- 7.2 Under the Act, at any point before expiry, the council can extend a PSPO by up to three years if they consider it is necessary to prevent the original behaviour from occurring or recurring.
- 7.3 Consultation has taken place with the Chief Officer of Gwent Police for the concerned areas in order to establish the necessity of continuing with the restrictions, and they have confirmed their agreement to the extension of the PSPO.
- 7.4 In addition consultation was also carried out with the community in the effected areas in a slightly curtailed way due to COVID-19 restrictions, via a questionnaire circulated on social media platforms. This extended from 10<sup>th</sup> August – 17<sup>th</sup> September 2020, a period of five weeks.
- 7.5 The below statutory partners and other identified stakeholders were emailed advising of the proposal and invited to provide feedback as part of the consultation. These include:
- Chief Constable, Gwent Police
  - Police & Crime Commissioner (PCC)
  - County Councillor, Priory, Castle, Grofield and Drybridge Wards
  - Gwent Police, Abergavenny and Monmouth local policing teams
  - MCC – Senior Management Team
  - MCC Car Park Manager
  - MCC Head of Operations
  - MCC Head of Legal
  - MCC Head of Public Protection
  - Abergavenny and Monmouth Town Council Clerks
- 7.6 The local police support the continuation of the restrictions imposed by the PSPO's in their current format.
- 7.7 The draft PSPO's are attached.

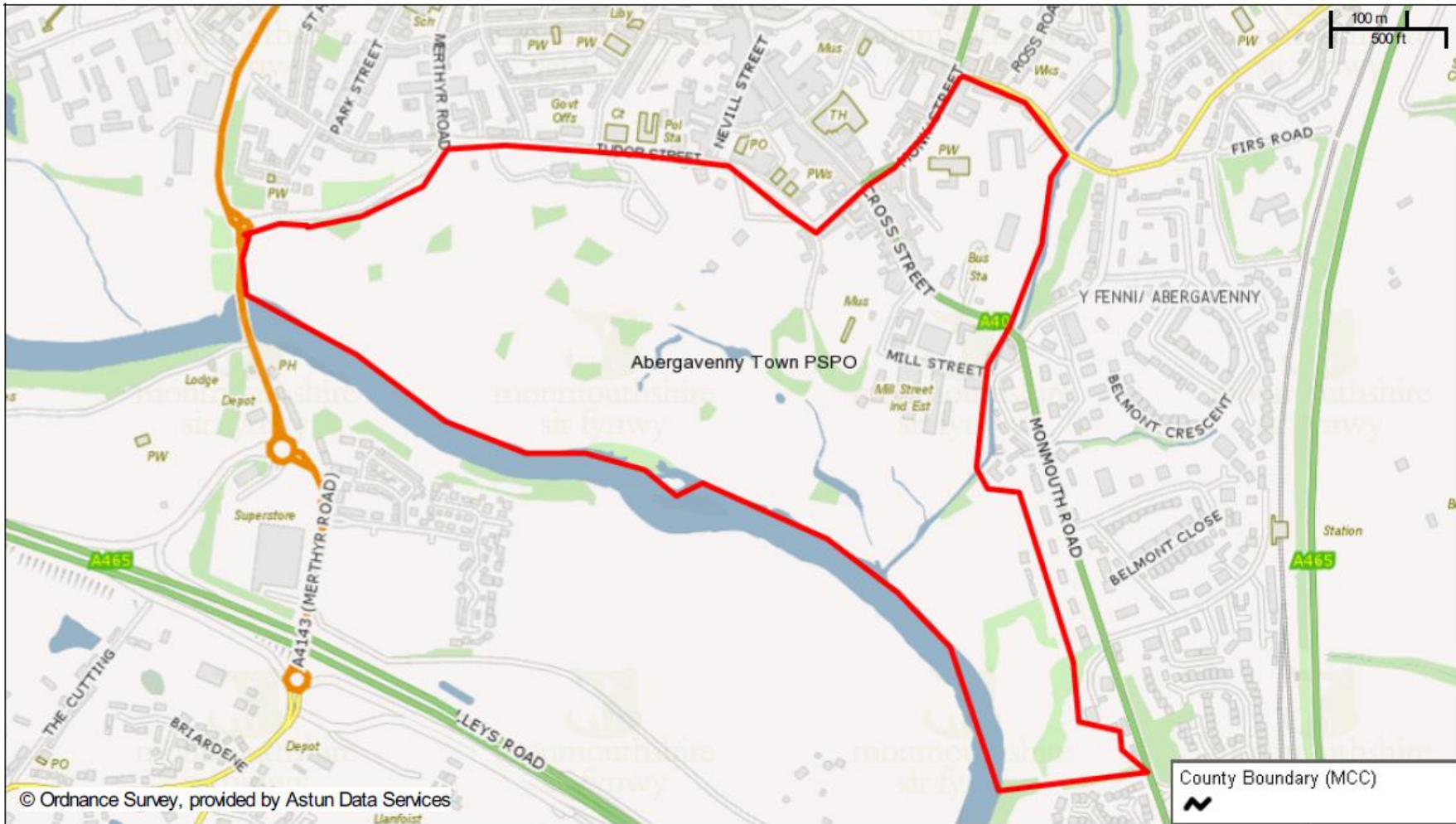

Local officers have also received complaints via email from concerned members of the public regarding alcohol/drugs use in the park grounds. Below is a list of recent emails regarding Bailey Park.

10/09/2020	Complaint from local resident to Bailey Park stating that they have attended at the park on numerous occasions in the last 12 months especially after a Friday and Saturday night and located bottles and beer cans strewn all over different areas of the park. The sensory garden and the football stand seems to be where the youths congregate and has located a small 1 inch polythene packets which they believe to have contained some sort of drug. The picnic tables in the sensory garden are have been used for drug taking with the tops having been scorched. Numerous residents are always telling them that parties are being held as late as 2 am in the mornings.
11/09/2020	Complaint vi email from local resident concerned about alcohol and drug consumption in Bailey park. This is associated with a lot of littering and on occasion's vandalism. Anything that be done to lessen the problem would be appreciated.
09/09/2020	Complaint via email stating the area near the main gates, near to the Bailey pub, is a regular area for alcohol parties. The ground is covered in bottles tins discarded from the huge drinks drugs sessions.
09/09/2020	Complaint via email that there is evidence of alcohol being used in the park due to large amount of beer bottles/cans strewn around.

### Regarding Bailey Park: PC 1926 Elliot Morgan - Abergavenny Police Station

Local Community Support Officers have been actively engaging with the local residents to the park conducting door to door and attending park meetings.

CSO Parker recently attended the Friends of Bailey Park meeting on 3<sup>rd</sup> September where concerns raised regarding the youths returning and gathering in the bandstands drinking alcohol and the litter being discarded on the floor.

Door to door in the local area conducted by local Community Support Offices on 09/09/2020, in total stopping at 21 properties who backed on to the park in Park Lane and Park Avenue. Nine of these residents stated they were not aware of any issues. The remainder of the residents all raised concerns regarding youths congregating on the grandstand late at night consuming alcohol, with many entering the park to continue drinking when the local public houses close. Residents said this was having a detrimental impact on their lives as loud music and shouting continues until around 2am. There was also concerns raised regarding drug use and the noise of vehicles around the park.

The PSPO provides the police with an additional power to prevent ASB and punish those who repeat offend following numerous warnings. Following one member of the group being issued with a ticket for breach of PSPO, others do not return as has been seen in the neighbouring Fairfield car park where there is currently a PSPO. Recently there were concerns from local residents regarding vehicle ASB, as a result, those repeat offenders have been issued with FPNs and they have not returned. Therefore, the PSPO is crucial in preventing a detrimental impact on the local and wider communities that we serve.

#### **Regarding Abergavenny Lower: PC 1926 Elliot Morgan - Abergavenny Police Station**

As is evident from the table (Appendix B2) there has been a constant stream of calls over the period 24 months relating to drink related ASB. There was a spike in related issues during the coronavirus lockdown as groups of people attended the Castle Meadows area for parties during the good weather. Often requiring police attendance to disperse them. The PSPO was a crucial tool in dispersing these people and preventing further groups congregating.

The PSPO provides the police with an additional power to prevent ASB and punish those who repeat offend following numerous warnings. Following one member of the group being issued with a ticket for breach of PSPO, others do not return as has been seen in the nearby Fairfield car park where there is currently a PSPO. Recently there were concerns from local residents regarding vehicle ASB, as a result, those repeat offenders have been issued with FPNs and they have not returned. Therefore, the PSPO is crucial in preventing a detrimental impact on the local and wider communities that we serve.
