## 1. PURPOSE:

- 1.1 The purpose of this report is to make recommendations to Cabinet on the Schedule of Applications for the Welsh Church Fund Working Group Meeting 1 held on the 23<sup>rd</sup> June 2022.

## 2. RECOMMENDATION:

- 2.1 We resolved that the following grants be awarded as per the schedule of applications.

### SCHEDULE OF APPLICATIONS CONSIDERED 2022/23 – MEETING 1.

1. **Llangwm Baptist Chapel**, requested £5,000 for the replacement of the Chapel windows

Recommendation: £1,500 awarded to assist in the replacement of the chapel windows

2. **Raglan Baptist Church** requested £10,000 for urgent and essential repairs to this grade II listed Church, replacement of windows and re-pointing of the walls.

Recommendation: £1,500 awarded to assist in the replacement of the windows on this historic community asset.

3. **Caldicot Events Committee**, requested £2,000 for the purchase of Walkie Talkie Radios and Cases

Recommendation: No award was made; request was made for further detailed information and re-application.

4. **St Arvans Church**, requested £2,400 required to enable the Dormer windows of the Church to be repaired and re-painted

Recommendation: £650 awarded to assist in providing for the cost of paint for essential repairs and conservation work to this historical church

5. **Tintern Recreation Centre & Village Hall** requested £5,000 to assist in redeveloping and renewing of the outdoor playground and community garden in Tintern Village Hall.

Recommendation: £1,500 awarded to assist in providing for the purchase of new equipment for the renovation of this tourist / community leisure asset.

6. **St Peter's Church, Llanwenarth Citra**, requested £1,750 for in the provision of a hearing loop system in the church to enable the inclusion of the hard of hearing into all events held within the church

Recommendation: £1,500 awarded to assist in installing a hearing loop system to enable the inclusion of all parishioners.

7. **Parish Church of St Stephen's and St Tathan's, Caerwent**, requested £3,000 for the repair / replacement of the north porch roof on this 15th Century Church that is unstable

Recommendation: £2,000 awarded to assist in funding the renovation of the north porch roof of this 15<sup>th</sup> Century Church.

7. **St Michael's Church Llanfihangel ystern-Llewern**, requested £2,000 for emergency remedial action to remove the church bells from the dangerous bell tower framer, investigation and further action identified for their re-instatement.

Recommendation: £1,000 awarded to assist in funding the renovation of the bell tower frame.

### 3. **OPTIONS APPRAISAL**

Options available to the Committee are driven by the information supplied by the applicants.

### 4. **EVALUATION CRITERIA**

No evaluation criteria are applicable to the grant awarded by the trust.

## 1. PURPOSE:

The purpose of this report is to highlight to Councillors an area of Monmouthshire that does not have a designated secondary school catchment area, and make recommendations for remedial action.

## 2. RECOMMENDATIONS:

- 2.1 To note the content of this report, which highlights an area of Monmouthshire without a designated English Medium Secondary School catchment area
- 2.2 To agree that the affected area should be placed into the catchment area for Monmouth Comprehensive School for the reasons identified in this report
- 2.3 To agree to write to Welsh Ministers seeking their approval to vary the published admission arrangements for the academic year 2022/23 onwards.

## 3. KEY ISSUES:

### Background to Secondary School catchment areas

- 3.1 Monmouthshire County Council is the admissions authority for all community schools within the county. With this brings responsibility for the admission arrangements that apply for each of our community schools, including the designated catchment areas.
- 3.2 Catchment areas in Monmouthshire form a significant part of the Council's admission arrangements for the following reasons:
  - They assist in the planning for the provision of school places, enabling us to monitor and track demand within designated areas to ensure that the number of school places is sufficient
  - They form a key part of the local authority's oversubscription criteria, where there are more applications for a school than there are places available,

ensuring that those residing within the catchment area for a school are afforded priority.

- They form part of the criteria for assessing eligibility for free home to school transport, which is currently awarded to the nearest or catchment school if the distance criteria is met (1.5m Primary and 2m Secondary)

### Secondary catchment review 2018

- 3.3 In 2018, Monmouthshire County Council undertook a review of secondary school catchment areas, specifically focussing on the catchment area for King Henry VIII and Monmouth Comprehensive Schools. The aims of this catchment review were:
- To address some areas of the county which did not fall within the catchment area for a Monmouthshire school.
  - Where possible, to align Primary and Secondary School catchment areas to support transitional arrangements.
  - Where possible, to address areas whereby the catchment school is not necessarily the nearest school.
  - To seek to address any imbalances within existing school catchment areas to ensure robust arrangements for the planning for school places.
  - To review school catchment areas through the ongoing development of school reorganisation proposals.
- 3.4 The areas of Usk, Goytre and immediate surrounding areas were identified as a priority for review as they did not have a designated secondary catchment area for a school within the county. The catchment for Usk, Goytre and immediate surrounding areas had been in place prior to Local Government reorganisation in 1996, and therefore the designated secondary school catchment area was Caerleon Comprehensive School. This status impacted significantly on the families within the area and their ability to both secure and access school places within Monmouthshire.
- 3.5 Following an extensive consultation exercise undertaken in 2018, the Council agreed to implement amendments to the catchment areas for King Henry VIII and Monmouth Comprehensive School, more specifically:
- the catchment area for Goytre Fawr Primary School was aligned to King Henry VIII Comprehensive School
  - the catchment area for Usk Church in Wales Primary School was aligned to Monmouth Comprehensive School



3.6 The amendments identified under 3.5 were implemented as part of the September 2020 admission arrangements, and has since brought the following benefits to affected residents:

- increased opportunities to secure a secondary school place within Monmouthshire
- enabled free home to school transport to a Monmouthshire secondary school
- helped to secure robust transitional links between primary and secondary schools, keeping cohorts of pupils together.

Why the need to vary the determined admission arrangements?

3.7 The catchment review undertaken in 2018 resulted in almost all areas of Monmouthshire falling within the catchment area for a Monmouthshire Secondary School. However, the areas of Tredunnoch, Llanhennock, Llandegveth, Llansoar and Llangybi were not amended as part of this review and therefore Caerleon Comprehensive School remained catchment for these areas. The reasons for this decision were:

- The affected areas form part of the catchment area for Charles Williams Primary School, which is situated in Newport City Council and feeds into Caerleon Comprehensive School. It therefore made sense to recognise and support the existing transitional links.
- The close geographical proximity to the Newport boundary meant that Caerleon Comprehensive School appeared overall to be the parental preference for families within the area, based on existing trends.
- The option of placing the affected area into the catchment area for a Monmouthshire secondary school would result in significantly increased travelling distances for the young people residing within the area.

3.8 The Councils amended catchment area was implemented for September 2020. Unfortunately, since this time, Newport City Council have undertaken their own review of secondary school catchment areas and have implemented an amended catchment area for Caerleon Comprehensive School, which now stops at the Newport City Council boundary. This decision has left the areas of Tredunnoch, Llandegveth, Llanhennock, Llansoar and Llangybi without a designated catchment for an English Medium secondary school.

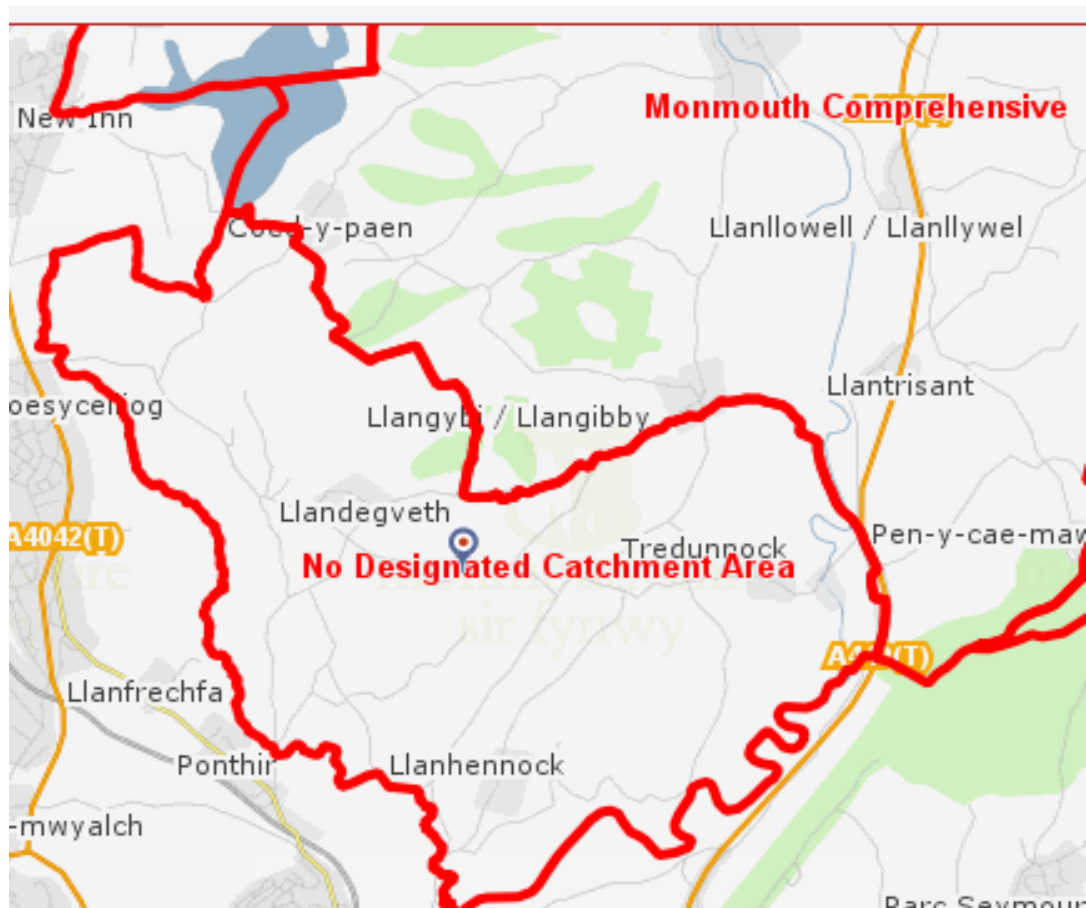
3.9 The significance of this position is that:

- Children residing within this area are no longer afforded priority for school places at Caerleon Comprehensive School, as it is no longer the designated catchment school. Due to regular oversubscription at Caerleon Comprehensive

School, there is a significant risk that affected children will be unable to obtain places at Caerleon Comprehensive School going forward.

- As the affected area does not form part of the catchment area for a Monmouthshire secondary school, there is currently no priority afforded to affected children in order to obtain school places in county.
- The home to school transport policy for secondary age pupils provides transport to the catchment or nearest (suitable) school over a distance criteria of 2 miles. As things stand, a secondary school within county can neither be considered as nearest or catchment, and therefore children from this area will not be able to obtain free transport to any secondary school in county.

3.10 The affected area is illustrated on the map below. In line with the criteria identified within the current School Admission and Transport policies, families residing within this area are now at a disadvantage when it comes to obtaining school places and receiving transport assistance.



### Proposals

3.11 The School Admission Arrangements for the academic years 2021/22 and 2022/23 have been published, which results in the affected area being left without a designated

catchment area for an English Medium Secondary School. However, in line with section 2.20 of the School Admissions Code Wales (July 2013), published admission arrangements can be varied with approval of Welsh Ministers in set circumstances, for example, “where there has been a major change of circumstances”.

- 3.12 In light of the above, it is proposed that an application is made to Welsh Ministers proposing that the catchment boundary for Monmouth Comprehensive School is extended into the affected area with effect from September 2022.

Projected number of pupils affected

- 3.13 The table below identifies the number of children that are currently residing within the affected area and therefore do not currently have an English Medium secondary catchment School. The numbers identify the children that will transition from primary to secondary school between September 2021 and September 2027.

It is recommended that Monmouth Comprehensive School is considered to be the new catchment school for the affected area. Whilst the school often finds itself in a position of oversubscription, we do not anticipate an in catchment pressure for those transitioning from primary to secondary school, meaning the above numbers can be absorbed should parental preference require, and applications are made by the relevant closing dates.

#### 4. OPTIONS APPRAISAL

Consideration has been given to the various options available to resolve the current position:

**Option 1** Do Nothing and maintain the status Quo of having no designated secondary school catchment

The preferred option is option 2, as this supports the original aims of our catchment review undertaken in 2018, which was to firstly provide Monmouthshire families with a Secondary school catchment inside of the County, and secondly to establish catchment areas that support transitional links between Primary and Secondary Schools.

## 5. REASONS:

The Council has a responsibility to provide access to school places for all young people who reside within the County.

Following the decision made by Newport City Council to remove the affected area from the catchment area of Caerleon Comprehensive School, there is no longer a secondary catchment designated to the families residing within that area.

The status quo means that the families within the affected area are more disadvantaged than other families across Monmouthshire who have a designated secondary catchment, as they do not currently receive priority for places at any Secondary School and are not eligible for free home to school transport to any Monmouthshire Secondary School.

The proposals outlined within this report will reinstate an equitable position for the affected families, and enable introduction for the academic year 2022/23, pending approval of Welsh Ministers.

## 6. RESOURCE IMPLICATIONS:

The costs associated with this proposal purely relate to the impact on home to school transport. The historic position has been that, in the vast majority of cases, free Home to School Transport has been provided to Caerleon Comprehensive School as both the nearest and catchment school for the affected area.

The decision implemented by Newport City Council will now result in a reduction in the number of young people obtaining places at Caerleon Comprehensive school, as they are no longer afforded priority as in catchment applicants. The consequences of such are that the Local Authority will need to provide transport to an alternative school at an increased distance to that of Caerleon Comprehensive, which will increase home to school transport costs.

The Passenger Transport Unit have been consulted during this review process and have confirmed that the proposals to establish Monmouth Comprehensive School as the new catchment school for the affected area would be most financially efficient option when compared to the other 3 secondary schools within the County. This is due to having existing transport links to Monmouth Comprehensive which could be adjusted to accommodate the young people residing within the affected area.

The estimated additional costs associated with providing the children affected with free home to school transport to Monmouth Comprehensive School over the next 5 academic years are:

The above has been calculated on the assumption that the existing vehicle would need to increase in size from a 4 seater to 8 seater in September 2022, and then to a 16 seater in September 2024.

The costs provided by the Passenger Transport Unit are estimates based on current rates and do not factor in the anticipated increases in contract prices, for example, due to rising fuel prices.
