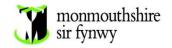

## 1. Apologies for Absence / Introductions

Apologies were received from members: John Askew, Sylvia Fowles, David Smith and Mark Storey. It was also noted that Ruth Rourke, MCC and Sarah Tindal, NRW have also sent their apologies. **AU** welcomed members to the meeting. Members and observers introduced themselves.

#### 2. Declarations of Interest

There were no declarations of interest.

## 3. <u>To confirm and sign the minutes of the Monmouthshire Local Access Forum meeting of 26 April 2022 (Attached).</u>

The minutes of the meeting of 26 April 2022 were accepted (proposed by AU and seconded by IB).

### 4. Membership update (Secretary)

The secretary explained that following the local elections Cllr Ben Callard had been nominated by the County Council as the appointing authority's representative on the forum. Cllr Callard introduced himself to members.

## 5. Improvement Sub-Group membership (Secretary)

Following the decision at the April meeting to establish an improvement sub group to help focus the countryside access teams work with communities, including the new community links officer post, nominations had been sought and so far **SL** & **PM** had expressed an interest. It was noted further members would be required and agreed that terms of reference be drawn up and circulated.

## 6. <u>Natural Resources Wales updates (Bob Campbell, Senior Officer Land Management, South East Wales Operations)</u>

**RC** provided an update of NRW's land management and forest operations. A large programme of ash die back management was underway but despite this every effort was being made to keep rights of way available. The exceptionally hot weather had raised the fire alert level to high and so there were concerns about the possible consequences. **RC** explained the contact methods for issues, including unauthorised off-road vehicle activity, and the importance of logging any incidents as this both helps direct responses and provides the intelligence to inform future planning and prioritisation of fire and police responses.

RC referred to some pilot work being undertaken in Caerphilly to help gather better information and assess rights of way furniture on the forest estate. NRW were keen to work with local residents and local groups to explore different ways of future improvements. A new "natural" playground was being procured at Whitestone, in the Wye Valley, and local consultations being undertaken. There are long term aspirations to look at an education shelter and toilets. Finally RC provided information on the forest operations programme primarily focussed on managing tree diseases, including of larch and ash die back. It was noted there was some degree of flexibility depending on contracts let.

Members asked several questions, including the funding available to tackle ash die back, the use of timber from felling and replanting. **RC** explained the prioritisation of urgent tree works on a safety basis, likely impact on roads, rail and rights of way. Most timber was being put into the market in the normal way with some retained for biodiversity reasons. Maps were available of felling areas. Replanting varied from a diverse mix, to some commercial softwood replacement, and allowing natural regeneration. The potential impact on access was noted and **RC** reaffirmed that NRW was very conscious of the potential impact of forest operations.

### 7. Countryside Access Improvement Grant Projects and Update (Report Attached)

The secretary updated the forum on changes, including the welcome appointment to the new Community Links Officer post and the proposals for Welsh Government's Access Improvement Grant. This would form the basis for a three year programme running to 24/25, as set out in the accompanying report to the forum.

Two funding conditions; the existence of a functioning local access forum and a Rights of Way Improvement Plan (ROWIP) being in place; come into being from 23/24 but in each case Monmouthshire is compliant.

In addition the Wye Valley AONB unit is accessing Welsh Government's Sustainable Landscapes, Sustainable Places grant scheme which can support complementary access projects.

Members supported the proposed schemes, with particular support for the proposal to allocate a budget across each year to support materials for local community volunteer groups.

### 8. Gwent Regional Access Group update (meeting on 14 July 2022) (Chair & Members)

AU reported on the recent meeting. It was unfortunately poorly attended by non-officers. It was noted that only Monmouthshire and Brecon Beacons National Park currently have an active local access forum and an updated ROWIP. However the opportunities to develop unified standards and share best practice across Gwent were identified. These would be explored as the regional project develops.

## 9. Dates of future meetings.

The forum agreed that the Secretary will endeavour to arrange the next meeting in October, with a following meeting in Jan 2023. Prior to the next meeting the secretary will co-ordinate any response deemed appropriate to Welsh Government's consultation on the Sustainable Farming Scheme proposals.

AU thanked members for their attendance.

#### 1. PURPOSE:

1.1 To update the Forum on progress since the appointment of the Community Links Officer and to propose terms of reference for the improvement subgroup.

#### 2. **RECOMMENDATION:**

2.1 To note progress to date and to approve the terms of reference for the improvement sub-group.

#### 3. BACKGROUND:

- 3.1 As a result of the 22/23 budget process a new permanent Community Links Officer post has been added to the Countryside Access Team. This full-time post was established to enable community volunteering, by leading on working with volunteers, local path care groups, friends groups, community councils and others to help facilitate volunteer and community input to resolving outstanding issues. The aim is to support both practical volunteer and community tasks and facilitate group's independent involvement. To support the role a community links project forms part of the 2022-25 Access Improvement Grant proposals. Tom Arnold started in this post in August 2022 and will provide an update on his work to date.
- 3.2 The 26 April 2022 meeting of the LAF approved the establishment of an improvement sub-group to support working with local communities to identify future improvements and it is now timely to establish that to support the Community Links Officer's work. Draft terms of reference are appended. To date two members have expressed an interest in joining this group, other members are also invited.

#### **Draft terms of reference**

- 1. The sub-group is established as a committee of the Local Access Forum in accordance with the Terms of Reference for the Monmouthshire Local Access Forum.
- 2. As agreed at the Local Access Forum meeting on 26 April 2022 the improvement sub-group's purpose is to assist in the implementation of the Countryside Access Improvement Plan, including:
  - a. Helping in the identification of routes for improvement
  - b. Assisting in working with local communities to assess these improvement opportunities
  - c. Assist in monitor and identify the benefits of schemes within communities
  - d. Assist in engaging with local path groups, community councils and others to facilitate volunteer engagement in resolving issue
  - e. Assist in formulating funding bids
  - f. Consider and prepare responses on the Local Access Forum's behalf to improvement proposals including consultations under forestry / farming schemes
- 3. The membership of the sub-group is open to any member of the Local Access Forum and to any other individuals who would assist in the sub-group's work.
- 4. The appointment of non LAF members to the sub-group will be subject to approval by a simple majority of the full Local Access Forum,
- Any additional sub-group members who are not Local Access Forum members will nevertheless be expected to adhere to the requirements on Local Access Forum members set out in the approved Terms of Reference for the Monmouthshire Local Access Forum.
- 6. The Chair of the sub-group will be a LAF member and agreed amongst the group's members and subject to approval by the Local Access Forum's Chair
- 7. The appointing authority will provide support to the sub-group, primarily through liaison with the Community Links Officer and the Public Rights of Way Officer.
- 8. The sub-group's Chair will be responsible for recording the group's considerations and reporting progress, and any issues requiring a decision, to the Local Access Forum on a regular basis.

9. The duration of the sub-group is at the discretion of the Local Access Forum and will end at the end of the Local Access Forum's period of appointment. The sub-group may be re-established, and any non LAF members reappointed, by the new Local Access Forum.

### 1. PURPOSE:

1.1 To update the Forum on progress of the Gwent Green Grid Partnership (GGGP) regional access strategy.

### 2. RECOMMENDATION:

2.1 To note progress

#### 3. BACKGROUND:

- 3.1 The Gwent Green Grid Partnership (GGGP) is a collaborative project funded through Welsh Government's RDP ENRaW programme developing and delivering a common approach to managing green infrastructure, including the countryside access network, planning, and delivering improvements to support community well-being. It is managed by a collaboration of local authorities, led by Monmouthshire CC, working with Natural Resources Wales and other partners. Further information is available <a href="here">here</a>.
- 3.2 The programme strands include access; to prepare a strategic access plan identifying missing links and areas where improvements are needed in the countryside access network both regionally and locally to enable people to lead active healthy lifestyles, provide economic opportunities and expand, where possible, the network available to cyclists and horse riders.
- 3.3 Following a tender process Lepus Consulting were appointed in November 2022 to prepare a Green Corridors Strategic Access Plan for Gwent. The project objectives are:
  - a. Deliver a strategic access plan for the Gwent region identifying key opportunities and management strategies
  - b. Produce a Green corridors strategic delivery plan and costed projects. The plan is programmed for completion by the end of May 2023
- 3.4 The outputs include the identification of missing links and areas where improvements are needed to access the countryside and green spaces, both regionally and locally to create deliverable action plans, including seeking to identify opportunities for effective collaboration across local authority borders.

- 3.5 To assist this process a workshop session is planned in February with the Gwent Access Group volunteers to assist in identifying key links across Gwent. Details of the workshop will be circulated shortly.
- 3.6 In addition an invitation to tender will shortly be published for a public rights of way design guide for Gwent. This will update our existing Monmouthshire design guide, adding in additional furniture and including relevant legislation and local policy updates.

# NRW Access Reform Advice: Briefing Update, December 2022

This briefing note is to update internal and external stakeholders about NRW's work to provide advice to Welsh Government for their Access Reform Programme (ARP).

## **Summary**

NRW is providing support to Welsh Government's ARP through the provision of advice, the development of options for potential reforms to recreational access, including both legislative and non-legislative approaches. Up to March 2023 NRW will focus on the following areas of work: Enforcement of Dogs on Leads and responsible recreation actions and supplementing previously submitted advice, such as for the reviews of open access mapping.

## **Background**

The Access Reform Programme consists of proposals to revise access legislation. Following its 2017 consultation about the reforms, Government grouped the proposals as follows:

- Group 1 reform proposals that were considered uncontroversial by stakeholders
- Group 2 reform proposals requiring more detailed consideration and advice
- Group 3 reform proposals related to access to inland waters (not considered within this briefing)

For 2021/22, Welsh Government has asked NRW to deliver advice about the following Group 1 legislative reforms:

- Countryside and Rights of Way Act (CRoW Act) open access mapping reviews
- Local access forum (LAF) roles and responsibilities
- Enforcement of dogs on leads

And NRW also provided some supplementary advice to Welsh Government about some detailed issues within the Group 2 reform areas.

For 2022-23 Welsh Government have confirmed they will not be able to proceed with the primary legislation due to a lack of available time during this Seneddd term. In the mean-time NRW is taking forward non-legislative recommendations for Welsh Government, in a developing learning and piloting phase of the programme. This years work will focus on two areas of advice: A) Dogs on Leads and B) actions supporting responsible recreation.

## A) Enforcement of Dogs on Leads Advice

The 'Advice & Recommendations Paper: Dogs on short fixed-length leads in the vicinity of livestock at all times of year' was submitted to Welsh Government (WG) in March 2022.

Welsh Government's policy intent for this work is for legislative requirements and supporting actions for:

Dogs to be on a short, fixed length lead in the vicinity of livestock at all times of the year. In all other circumstances they will be subject to "effective control", a legally defined term already used in England under Schedule 2 paragraph 6A of the CRoW Act. Exceptional circumstances relating to safety and the protection of nature conservation will be identified and guidance provided by the access code\*.

[\*WG will be considering its preferred way forward for an appropriate access code following on from the ARAG advice.]

The enforcement of dogs on leads in Wales and England is part of legislation currently before the UK parliament. NRW is therefore working to implement a number of non legislative recommendations that will support WG's aims for enforcement of dogs on leads, together with the relevant parts of the UK legislation in Wales:

- Guidance must improve clarity and consistency of messaging across all land with public access and livestock to the general public and to landowners.
- There is an opportunity to utilise a Behavioural Insights (BI) evidence-based approach to identify where and how effective messaging for improved dog control in the countryside around livestock could be implemented. By collaborating with partners such as Natural England this would also expand on Countryside Code BI work already undertaken.
- To improve compliance, on-site signage should be as effective as possible, taking into account BI approaches and evidence, outlining what the requirements are for dog control in the vicinity of livestock and the possible outcomes of incidences.
- Messaging within guidance could outline increased penalties (set out in UK Bill) that would be incurred for dogs worrying and attacking livestock.

## **Behavioural Insights - Dogs on Leads**

The work is to develop a Behavioural Insights (BI) based approach and associated activities to support NRW and WG in promoting responsible recreation with dogs in the countryside across varying types of access. It will identify how best to achieve positive behaviour change to reduce the incidences of livestock worrying (and events of disturbance to other vulnerable wildlife where recreation and conservation co-inside).

A Behavioural Insights approach is based upon three main principles:

1. Non-conscious decision-making processes. Despite a myriad of guidance, best practice, things that we know we should do – we fall back on habits, short cuts,

- and 'work arounds' with regards to the processes and structures in place to get our jobs done on a day-to-day basis.
- 2. The setting of our behaviours the characteristics of our immediate environment greatly influence our actions the impact of this is that it draws us back into default habitual behaviours.
- 3. Behaviour, distinct from awareness, attitudes, or intentions. Basically, we frequently fail to act upon good intentions.

## **Proposals**

- Work with NRW's BI lead specialist to identify approaches to carrying out BI based work and to achieve project proposal outputs. This will include scoping and procuring work to be commissioned externally.
- Carry out a brief in house literature review and analysis to refine the key issues, challenges and opportunities, already obtained through ARP work, to focus further BI intervention work. Other available BI literature within scope will be assessed alongside. This initial work will form the basis for developing a project brief and procurement for trialling selected target behaviour intervention options.
- Work with a commissioned BI supplier to develop an approach for exploring trial and intervention methods that seek to improve behaviours and reduce dog worrying incidents. This would upskill staff and stakeholders in BI approaches relevant to each target behaviour.
- Implement chosen interventions for trial and measure successes or failures of these (after pilot phase). In-turn, this would inform future decision making on the ground and within policy decision making. This would also hopefully add to existing tools for land managers and other stakeholders promoting responsible dog walking.

## B) Responsible Recreation

Responsible recreation was a cross-cutting theme relevant across all reform areas. Specific responsible recreation advice was provided as part of the ARAG report for Group 2 access reforms in 2021/22 and was also part of NRW's considerations within the advice for Group 1 reforms in 2022/23 (and especially those that related to 'Dogs on Leads').

Within the ARAG report, the recommendation was made that "WG should fund a national responsible recreation information and education campaign that utilises behavioural insights".

<sup>1</sup> This was mirrored in the Dogs on Leads reform area, of which a proposal for such work has been put forward separately.

Responsible recreation is relevant to all access reforms within the ARP. There has been strong support across sectoral interests for taking forward reform measures that support more responsible recreation.

Additionally, during 2020, concerns arose around Covid-19 lockdown measures and the lifting of restrictions with many more people choosing to access the outdoors. This led to considerable pressure on some sites where outdoor access and recreation is a predominant reason to visit.

For 2022/23 NRW is therefore taking forward a series of projects under the umbrella of the Countryside Code whilst delivering on recommendations made through the ARP to support responsible recreation.

## Aims of project proposal

- Develop a strategic approach to promoting responsible recreation across Wales, delivering against WG's ARP objectives and recommendations.
- Influence visitors and users of the countryside to understand and follow the Countryside Code by means of promoting messages to desired target groups.

## **Responsible Recreation Activities for 2022/23**

- 1. Create a strategic promotion plan including monitoring and evaluation of the reach of the Countryside Code since its refresh in 2021.
- 2. Seek to work with a bilingual speaking social media influencer to reach younger age groups.
- 3. Create engaging and captivating social media video content with the aim of again reaching younger age groups.
- 4. Work in partnership with NE to update the Code's branding guidelines (already in existence and produced by NE) and review the overall digital design of the Countryside Code images.
- 5. Contribute toward and develop promotional Countryside Code material for face-to-face events, shows and circulation.

## 1. PURPOSE:
