Briefing Note on B4245 Active Travel route

- 1.1 This briefing note is to update the Severnside Area Committee on progress with the proposal for providing an active travel path adjacent to the B4245 between Undy and Rogiet. This follows the publication of the outline business case or Welsh Transport Appraisal Guidance Stage 2 (WelTAG2) which identified a viable and preferred route along the B4245, in favour of alternative routes which were considered as part of this appraisal process, and which run south of the B4245 and along what is locally known as the old Ash Path.
- 1.2 The section of the B4245 between Undy with Caldicot does not have a continuous foot or cycle path. In 2007 an Active Travel path was provided between Caldicot and Rogiet and has been well used for walkers and cyclist who may not have previously made this as an active travel commute. This has led to the call for an extension of the path connecting up Rogiet with Undy.



- 1.3 The provision of an active travel link between Undy and Rogiet will offer the community a safer route for walking and cycling between these communities and helps to reduce costs and pollution associated with other forms of travel as well as meeting the health agenda for encouraging people to take more exercise. The 2021 Census indicates that Magor and Rogiet has a high proportion (63.7%) of working-age residents. This demonstrates a target population who are likely to travel regularly to commute and therefore would directly benefit from improved access to Caldicot and Severn Tunnel Junction Railway Station.

- 1.4 In 2010 an outline design and feasibility assessment was carried out however owing to difficulties with funding this project was not progressed despite several bids being made to Welsh Government for Safe Routes in the Community funding. Fortunately, funding was secured earlier this financial year from the Burns Commission and from WG Active Travel funds to review the previous plans and complete detailed design proposals in accordance with the WelTAG guidance.
- 1.5 This Stage 1 and 2 study confirmed a preferred route running alongside the B4245, supported by stakeholders and the local community following consultation on the various options.
- 1.6 The next stage, having identified this preferred option, is to complete a detailed design of the route and take it up to pre-contract stage. The design will consider elements such as ecology, land take, geotechnical study, drainage (incl. SAB approval), street lighting design and connections to existing active travel routes or destinations at either end of the scheme.
- 1.7 The proposals have been widely consulted as part of the WelTAG process on the outline business case and additional consultation and workshops are planned for the detailed design of the preferred route. The Severnside Area Committee's comments on the alignment and detailed design would be welcomed and contribute to the consultation process as part of this stage of the project. Wider public consultation on the detailed design is proposed in coming weeks.

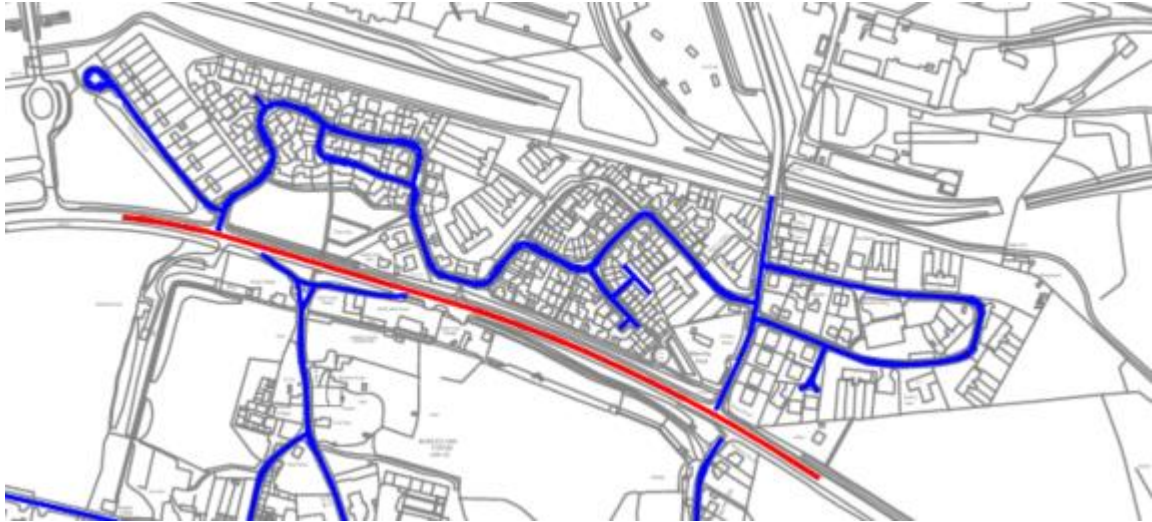
Briefing Note on September 2023's Wales-wide speed limit change and proposed exception orders

- 1.1 In July 2022, the Senedd passed legislation that will mean the default speed limit on 'restricted roads' becomes 20mph from 17th September 2023. A restricted road is one with a compliant scheme of regular street lighting: you will probably recall when being taught to drive that in built up areas with regular street lighting, the speed limit is 30mph even if there are no signs. On 17th September, throughout Wales that changes to 20mph.
- 1.2 Welsh Government has set out a set of criteria that Councils can use to identify restricted roads that should remain at 30mph rather than become 20mph. To implement this, Highways Authorities must assess roads against the criteria and if applicable, must put an Exception Order on place so that on 17th September the road remains at 30mph and does not become 20mph. The Welsh Government will be doing the same exercise for trunk roads.
- 1.3 Within the Severnside Area, only one new Exception Order is proposed, which is on the existing 30mph stretch of the A48 through Caerwent. The purpose of this note is to brief the Severnside Area Committee on this proposal and discuss any feedback that you might have.
- 1.4 Exception Orders will be subject to a formal statutory consultation process later in 2023, as per any Traffic Order.
- 1.5 Please note, this does not change the recent decision to revert part of the B4245 and part of Caldicot Road in Caldicot to 30mph, with a part time 20mph section by Durand Primary School at school start and end times. That decision stands and is due to be implemented on the ground by the end of March 2023.

A48 CAERWENT 30 MPH EXCEPTION

- 1.6 Reasoning for Exception
 - Strategic A class route with an existing 30 mph speed limit.
 - Limited residential properties **fronting** the A48, criteria needed is to be above 20 properties per km.
 - Distance between junctions of 20 mph side roads greater than the 100m criteria.
 - No educational establishment entrances within a 100m walk, so can maintain at 30 mph.
