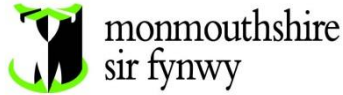

1. PURPOSE:

- 1.1 This report seeks Cabinet Member approval to proceed with several Traffic Regulation Orders throughout Monmouthshire. The Traffic Orders under consideration are listed under section 2 of this report.
- 1.2 The proposed Orders were advertised in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996.
- 1.3 If significant unresolved objections arise from the consultation, a public inquiry can be held to reach a decision. However, in this instance, it is considered that a public inquiry is not required. It is recommended that all the proposals proceed with the Traffic Orders made as detailed in section 2.

2. RECOMMENDATIONS:

- 2.1 It is recommended to not hold a public inquiry, and to proceed to approve and implement the proposed orders identified below:
 - 2.1.1 A Prohibition of Waiting at Any Time on Woodstock Way, Caldicot
 - 2.1.2 A 7.5T Weight Restriction on Mill Lane, Caldicot.
 - 2.1.3 A Prohibition of Waiting and Loading at Any Time on Wonastow Road Industrial Estate West, Monmouth.
 - 2.1.4 A Prohibition of Waiting at Any Time on Wyesham Avenue, Monmouth.
 - 2.1.5 A Prohibition of Waiting at Any Time on Wyesham Road and Highmeadow, Monmouth.
 - 2.1.6 A Limited Waiting Disabled Persons Parking Place on Hardwick Terrace B4293, Chepstow.
- 2.2 It is further recommended that the proposed order identified below be approved and implemented, with the extents of the order being subject to an insubstantial modification resulting in a less onerous arrangement than that originally proposed, as detailed in drawing 2205 REV B.
 - 2.2.1 A Prohibition of Waiting at Any Time on Wyesham Avenue, Monmouth.

3. KEY ISSUES

- 3.1 Monmouthshire County Council has received various requests and concerns from stakeholders and community representatives to introduce various Traffic Regulation Orders in the below named localities. A review of the concerns raised at each location listed below has been undertaken by officers and in accordance with government guidance and regulations. The proposals are intended to improve road safety for all highway users and

resolve issues at each location. A summary of the key issues for each location can be found below and these form the basis for the reasons for making the Order.

3.1.1 Prohibition of Waiting at Any Time - Woodstock Way, Caldicot

To enhance pedestrian safety at the high-traffic junction of Woodstock Way and Mill Lane, Caldicot, the Woodstock Way Active Travel Scheme proposes installing controlled pedestrian crossings. These crossings are essential for safe passage, especially with significant pedestrian movements near Caldicot School and the Leisure Centre.

However, parked vehicles near crossings can obstruct sightlines, endangering pedestrians and drivers. Therefore, to eliminate these obstructions and create a safer environment, a prohibition of waiting at any time order is proposed in the vicinity of the new crossings. This will ensure clear visibility and allow both motorists and pedestrians to navigate the area with greater confidence.

3.1.2 7.5T Weight Restriction - Mill Lane, Caldicot

The proposed pedestrian and cycle infrastructure, including the redesigned junction with signalised crossings and shared use paths at the junction of Woodstock Way and Mill Lane, requires careful management of vehicle types and sizes. The new road geometry will make it unsafe for HGVs to turn from Mill Lane onto Woodstock Way where there is a reduced turning radius.

To ensure the safety of pedestrians and cyclists, a 7.5T weight restriction is proposed. This will protect the new infrastructure, reduce hazards, and support the scheme's goal of creating a safer environment for active travel by preventing large vehicles from performing inappropriate turning manoeuvres whilst maintaining clear sightlines.

3.1.3 Prohibition of Waiting and Loading at Any Time - Wonastow Road Industrial Estate West, Monmouth

Residents and local representatives have raised concerns about safety issues on Wonastow Road Industrial Estate West, particularly regarding vehicles, often HGVs, that are frequently double-parked. This practice creates physical and visual obstructions, hindering traffic flow and posing safety risks.

To address these concerns and improve road safety, we propose implementing a Prohibition of Waiting at Any Time and a Prohibition of Loading at Any Time order. These restrictions will prevent vehicles from stopping, parking, or loading on the road, ensuring a clear and unobstructed passageway.

By implementing these restrictions, we aim to enhance road safety, improve traffic flow, and protect vulnerable road users by reducing the risk of accidents and collisions caused by obstructed visibility and limited manoeuvrability.

3.1.4 Prohibition of Waiting at Any Time - Wyesham Avenue, Monmouth

The Council has received a road safety concern from the local elected representative on behalf of residents of Wyesham Avenue. The concern relates to a specific section of the road where the implementation of a 'no waiting at any time' restriction is proposed.

The narrow carriageway width and the road's geometry, combined with the presence of parked vehicles, are causing difficulties for emergency service vehicles and refuse collection vehicles to access properties along this section of Wyesham Avenue. The carriageway is insufficiently wide to accommodate both parked vehicles and the safe and unimpeded passage of these essential vehicles.

Therefore, to ensure the safe and timely access of emergency services and refuse collection vehicles to properties along this section of Wyesham Avenue, a prohibition of waiting at any time is proposed.

However, given the substantial number of objections received from residents residing in the immediate vicinity of the proposed order, it is instead recommended that the extents of this order be reduced to only encompass the narrow access road leading to this location. This modification would effectively address the issue detailed above, while preserving on-street parking availability for residents.

3.1.5 Prohibition of Waiting at Any Time - Wyesham Road and Highmeadow, Monmouth

The Council has received a road safety concern from a local elected representative on behalf of concerned residents. Vehicles parked on Wyesham Road and Highmeadow are forcing other road users, including motorists and pedestrians, to cross into the opposing lane of traffic to circumvent the parked vehicles. This manoeuvre places these users directly in the path of oncoming traffic. The restricted forward visibility for vehicles traveling in both directions, exacerbated by the steep gradients at this bend, significantly increases the risk of head-on collisions involving vehicles and other road users.

Therefore, to mitigate these risks and improve road safety, a prohibition of waiting at any time is proposed for this location.

3.1.6 Limited Waiting Disabled Persons Parking Place - Hardwick Terrace B4293, Chepstow

Currently, a disabled parking bay exists on Hardwick Terrace. However, it has been reported that this bay is frequently misused, with vehicles often left parked for extended periods.

To ensure the bay remains accessible to those who genuinely need it, the authority proposes introducing a limited waiting time restriction. This means that during the hours the restriction is in effect, vehicles can only be parked for a maximum of 3 hours, aligning with the restrictions on other disabled bays in Chepstow Town Centre. This measure aims to prevent misuse and improve accessibility for disabled individuals who rely on these designated spaces.

4. EQUALITY AND FUTURE GENERATIONS EVALUATION (INCLUDES SOCIAL JUSTICE, SAFEGUARDING AND CORPORATE PARENTING):

- 4.1 The Prohibition of Waiting proposals aim to support improvements to the safety of highway users and ensure the free flow of traffic along the highway network. The introduction of waiting restrictions, will encourage more appropriate parking practices and support guidance provided in the Highway Code and Traffic Management Act.
- 4.2 The 7.5T Weight Restriction order will prohibit large vehicles from accessing a location where their size would necessitate dangerous turning manoeuvres within a restricted turning radius, posing a risk to both motorists and pedestrians.
- 4.3 The Disabled Persons Parking Place proposal aims to improve the well-being and quality of life for disabled drivers by providing a convenient and readily available parking space near essential locations in Chepstow Town Centre.

5. OPTIONS APPRAISAL

- 5.1 Table One below provides an options appraisal of the proposal:

6. REASONS:

- 6.1 The proposals will support the national policy for improving road safety by creating a safer, highway environment for all highway users and lessening the frequency and severity of road traffic collisions and ensuring the free flow of traffic through the highway network.
- 6.2 The proposals are ultimately expected to benefit the health and well-being of residents in the affected communities, while also enhancing pedestrian and motorist safety.

7. RESOURCE IMPLICATIONS:

- 7.1 The proposals will be funded from the Council's Road Safety and Traffic Management budget and Active Travel Budget as part of the Caldicot Active Travel Scheme. If necessary, the implementation of some measures may be delayed until the new financial year.

377	Disagree - Wyesham Avenue Proposed Prohibition of Waiting	Vehicles have parked in the area proposed for the prohibition of waiting for at least the last 54 years that I have lived here. It is totally unreasonable to stop people parking here when there is no alternative area being provided in the vicinity, and I am concerned that the displaced vehicles will end up taking places in the main part of the Avenue, causing more congestion, and making access to the properties there more difficult.	Along this stretch of Wyesham Avenue, the narrow carriageway width and the road's geometry, compounded by the presence of parked vehicles, pose significant challenges to the access of emergency service vehicles and refuse collection vehicles to properties. The carriageway width is inadequate to accommodate both parked vehicles and the safe and unhindered passage of these essential services.

		I understand that this order is being sought following complaints about the one verge getting cut up by vehicles mounting the kerb to get past parked cars. The vehicles causing the damage are mostly the councils own bin lorries, so the simplest answer would be to get the bins in this part of the Avenue picked up by the narrower lorry that collects the bins in the lower part of Wyesham Avenue/Claypatch Road, which would cost nothing, other than the cost of sending letters to ten properties changing the collection day. Alternatively, the other way to alleviate the problem permanently would be to move the kerb where the verge is damaged back about 300mm, and infill with concrete. To loose this small amount of grass would have a negligible effect on the environment, especially as this area is now often cut up, and this would be my preferred solution.	Furthermore, local residents have expressed concerns regarding damage to the grass verge resulting from inconsiderate parking practices. While it is acknowledged that the implementation of this order may necessitate the relocation of parked vehicles, the benefits of its implementation in addressing the aforementioned issues are deemed to outweigh any potential drawbacks. Consequently, to ensure the safe and timely access of emergency services and refuse collection vehicles to properties along this section of Wyesham Avenue, the implementation of a prohibition of waiting at any time order is considered necessary to mitigate the disruption caused by the aforementioned issues.
378	Disagree - Wyesham Avenue Proposed Prohibition of Waiting	As a resident of the culdesac I understand why this is being proposed, due to vehicles blocking the entrance road. However, this proposal seems extreme in that it does not allow for even minimal visitor parking (I only have space for 1 car in front of my property), or for moving the car in the event of deliveries etc. This will cause huge issues and will also only serve to move parking to the front of the properties themselves, which will cause problems. The issues are being caused by a small number of properties (not in the culdesac) who have several cars, permanently parked here. In the absence of dealing with the relevant households I would therefore suggest either (a) a resident/ visitor parking permit system, or (b) consider removing	Your comments have been duly noted. 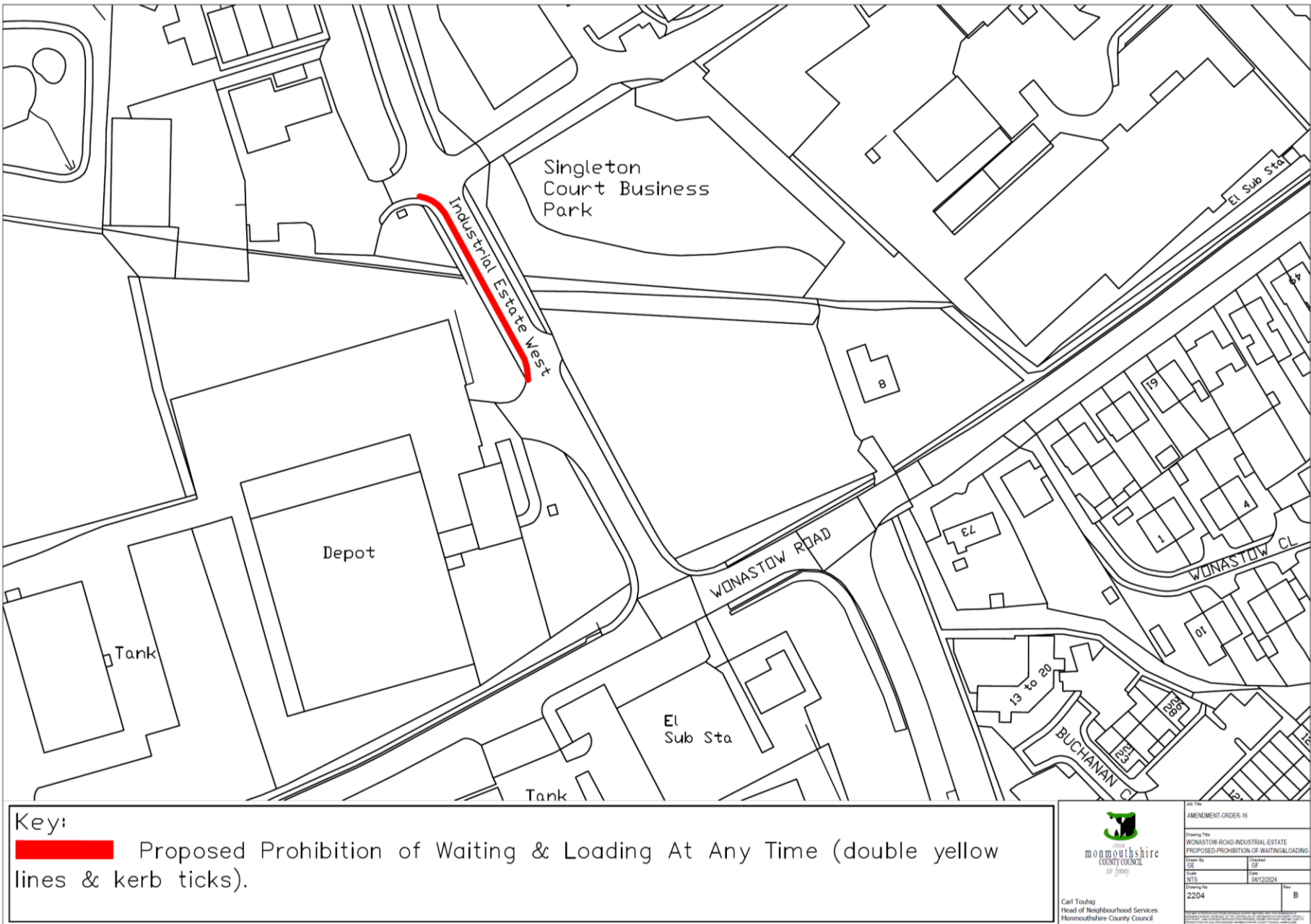

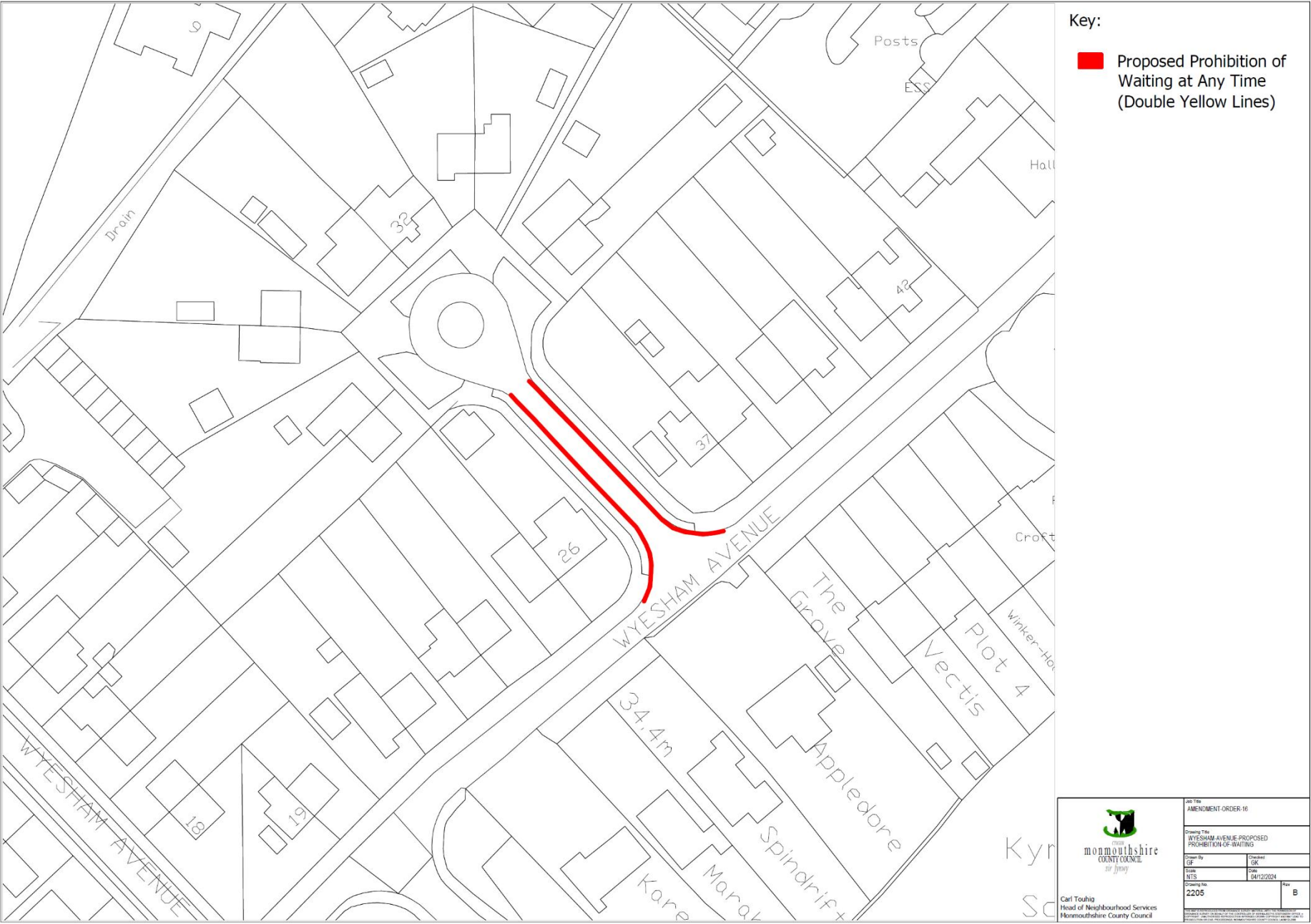
2205 REV A (Original Proposal) - Prohibition of Waiting at Any Time on Wyesham Avenue, Monmouth.

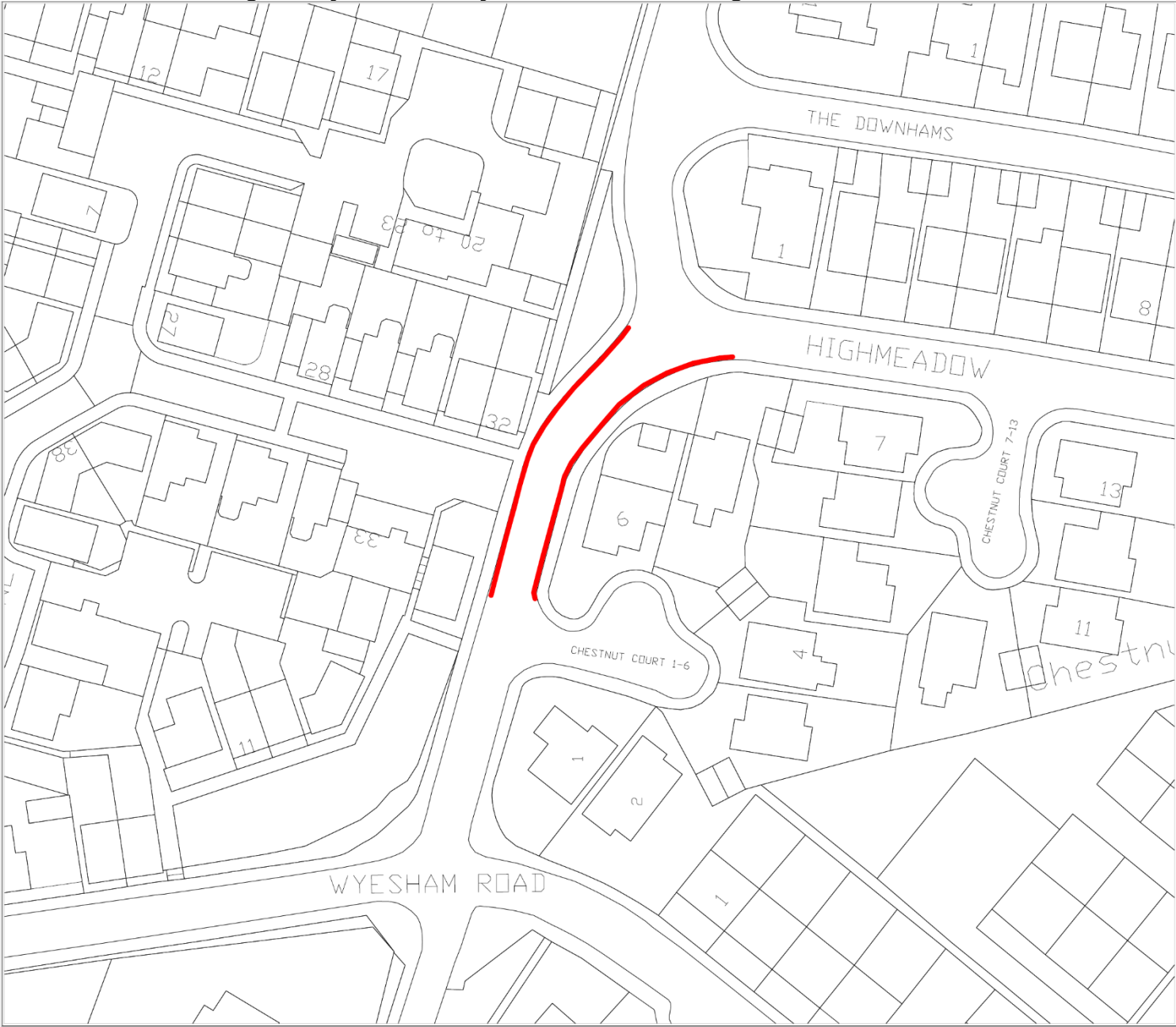
2205 REV B (Modified Proposal) - Prohibition of Waiting at Any Time on Wyesham Avenue, Monmouth.

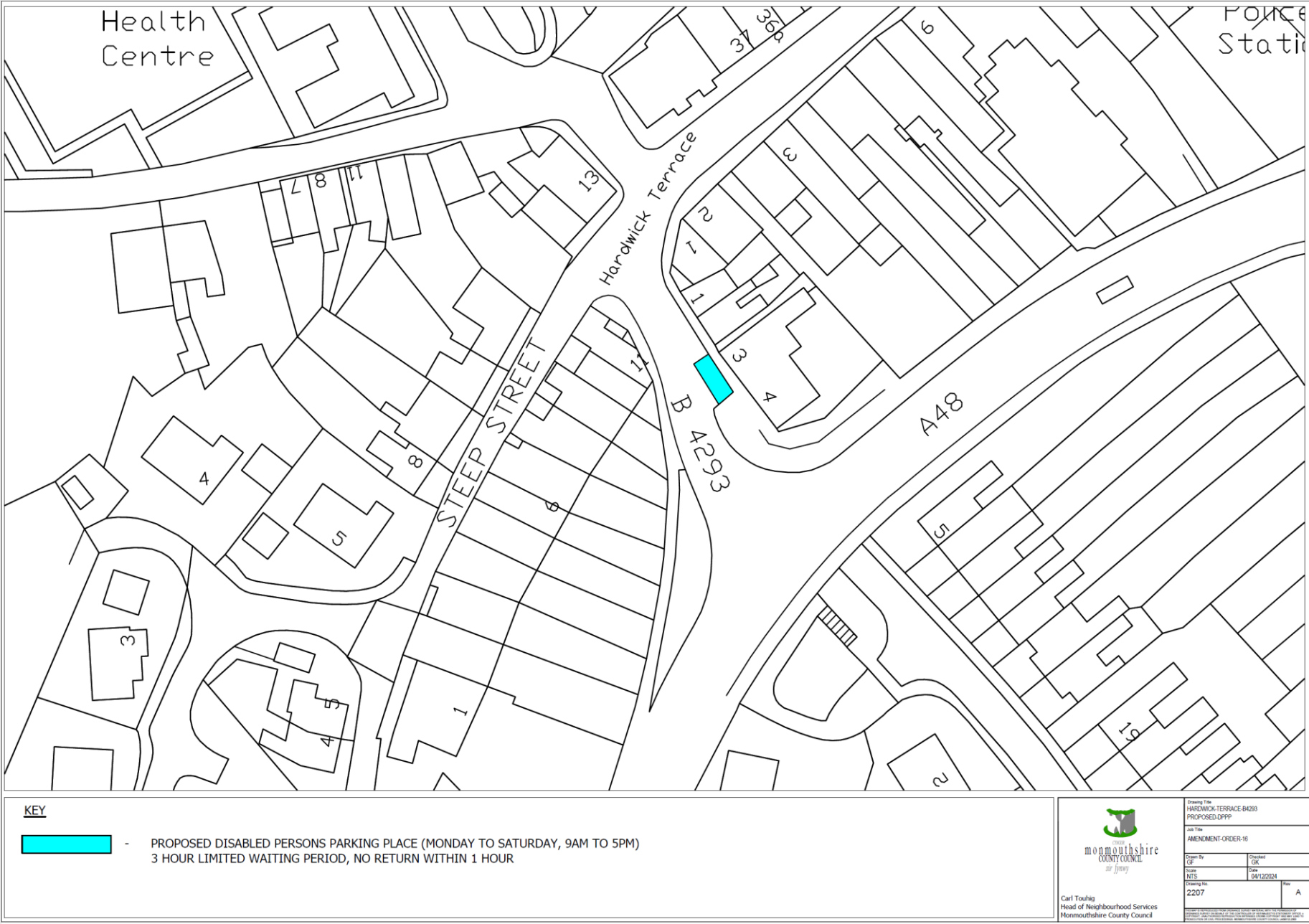
