The Chair welcomed David Cummings, Chair of the Gateway to Wales Action Group to present the following questions to in relation to the Deposit Replacement Local Development Plan:

- 1. Monmouthshire has set permissible Nitrogen Dioxide levels at four times the levels recommended by the World Health Organisation. Why has MCC chosen a site, close to A40, to build houses where the extra emissions from cars will further break those WHO levels and create more PM 2.5 particulates?
- 2. The catchment area in which HA4 is located already has phosphate levels exceeding the maxiumum permitted. Why has MCC chosen a site where run off will increase those levels and further pollute the Wye above where the drinking water for our town is extracted?
- 3. Site HA4 is primarily Grade 2 prime agricultural land. MCC is bound to use the lowest grade agricultural land first. Why has it not chosen a site with poorer quality agricultural land?
- 4. This site is close to the Wye Valley AONB and is the Gateway to Wales. Why have MCC chosen a site that, if developed, despoils and changes a view that has not changed for visitors since the Wye Tour of 1782?
- 5. We ask what assessment has been undertaken of the impact of the additional traffic exiting this site either for access to work via the A40 or into the town?
- 6. In view of the many issues with site HA4 should not an alternative site be chosen for Monmouth, such as CS0274 off Wonastow Road, which has far fewer issues? Can the council agree to consider this option during the Deposit Plan consultation process?

The Cabinet Member for Planning and Economic Development, Deputy Leader, thanked Mr. Cummings for the questions and provided a response.

- 1. Environment officers monitor air quality across the County. The evidence is that this site has permissible air quality levels according to nationally set standards. The evidence has not led to this area being an air quality management area. Nevertheless, because of the strong points made at the Scrutiny Committee, the Deputy Leader has asked that further testing of this site takes place during the public consultation period.
- 2. In terms of issues relating to water quality, the Monmouth Treatment Works are benefitting from investment in strategic treatment work improvements. This work is being undertaken now and once completed it will remove high levels of phosphates. All the new developments in Monmouthshire will require a sustainable drainage system to ensure there is no increased runoff as a consequence of the development.
- 3. With regards to agricultural land, in Monmouth the debate has been whether the future development should focus on the proposed Leesbrook site or the Wonastow site. The Leesbrook site has a marginally lower agricultural quality and that will be considered during the public consultation.

- 4. In terms of the position of the site, the proposed development site at Leesbrook is on a smaller scale than that agreed by the Council in 2020. The proposal has drawn further back from the hillside and provides a green corridor and a landscape buffer. The proposed development was thought to be seen as an extension of the existing settlement.
- 5. The site promoter has submitted transport strategies and statements to evidence the impact of the development on the local area. A strategic transport assessment has been conducted by Transport for Wales and this does not indicate significant impact consequential on the development itself.
- 6. Our assessment is that on balance Leesbrook has advantages over Wonastow but if during public consultation evidence emerges that there is a preference and more evidence which would favour Wonastow then that evidence will be given detailed consideration.



## SUBJECT: DEFORESTATION FREE CHAMPION COUNCIL

MEETING:FULL COUNCILDATE:12TH DECEMBER 2024DIVISION/WARDS AFFECTED:COUNTY WIDE

#### 1. PURPOSE:

1.1 That Council recognises the threat that tropical forests face and commits to better understand how Monmouthshire County Council could be contributing to deforestation, by signing the Deforestation Free Champions Charter and committing to develop an action plan which outlines how we will reduce our impact on deforestation and raise awareness of the issues in our communities.

#### 2. RECOMMENDATIONS:

2.1 That Council sign up to the Deforestation Free Champions Charter (see Appendix 1).

2.2 That officers develop and implement an action plan setting out the steps that we will take as Deforestation Free Champions both to understand and reduce our impact on tropical deforestation and to champion the importance of these issues in our communities. We have already taken some of these steps over the last year in collaboration with Monmouthshire's young people.

#### 3. KEY ISSUES:

3.1 Tropical forests are essential to life on Earth. They absorb vast amounts of carbon, produce oxygen, maintain the water cycle, and play a significant role in maintaining the global climate. Tropical forests are hotspots for biodiversity and are home to around 80% of documented species as well as millions of people.

3.2 The world's tropical forests are under threat. Demand for commodities such as beef, soy, palm oil, cacao and coffee drives deforestation in forests like the Amazon. In the process, one of our best defences against the climate crisis is being destroyed – an area nearly six times the size of Wales every year!

3.3 We are all part of the deforestation economy - it's in the food we eat, the products we buy, the fuel in our vehicles. When we think of the term *deforestation free* (DF), it's very difficult to completely remove all risk of deforestation as it is so embedded in our economy, but we can take practical actions that help to significantly reduce that risk, like using ethical certifications, circularity approaches and reducing waste.

3.4 Welsh charity Size of Wales have been working with pupils from 4 Monmouthshire primary schools, Osbaston, Kymin View, Raglan and Undy, to help pupils to understand how Wales contributes to deforestation and to look at the school menu to identify foods which may be

contributing. Students that have moved on to secondary school in Monmouth Comprehensive and Haberdasher's Monmouth Schools have continued to engage with the campaign and are pushing for deforestation free menus in these settings too. The work that the pupils have been doing has sparked the interest of Welsh Ministers, celebrity chefs and presenters and was even mentioned at the New York Climate Week! (see <u>The power of policy – how to put sustainable food on the public plate - YouTube</u> from 7m48)

3.5 Size of Wales has also collaborated with the community group ACE Monmouth who have taken on the deforestation free campaign as one of their own pillars of work, managing a regenerative farming mentoring scheme part funded by Size of Wales, MCC, Wye Valley Natural Landscapes which has led to the establishment of a growing 'regenerative farming' community online group and the elimination of soy from the animal feed chain at Lower House Farm in Chepstow. Size of Wales and Haberdashers Monmouth School have also collaborated with Great Trewen Farm in Llangrove (just over the border but a milk supplier to Monmouth/Haberdashers) to eliminate soy from their animal feed supply too.

3.6 The following video summarises progress to date. <u>Deforestation Free Monmouthshire | Sir</u> <u>Fynwy Dim Datgoedwigo - YouTube</u> Signing the Deforestation Free Charter and developing a Deforestation Free Action Plan will be the next steps to help Monmouthshire County Council continue our Deforestation Free Champions journey.

#### 4. EQUALITY AND FUTURE GENERATIONS EVALUATION (INCLUDES SOCIAL JUSTICE, SAFEGUARDING AND CORPORATE PARENTING):

4.1 Becoming a Deforestation Free Champion contributes positively to the Globally Responsible goal of the Wellbeing of Future Generations Act, as well as a Resilient Wales and a Prosperous Wales. There are no negative impacts on the wellbeing goals. Involvement and Collaboration have been intrinsic to the decision to become a Deforestation Free Champion, as the Council have listened to and involved young people in the decision, and worked closely with the Size of Wales, local Fairtrade Town groups and community groups like ACE Monmouth. The decision also embeds Long Term thinking and Prevention as a way of working, since preventing deforestation will make a significant difference to reducing climate change and protecting Indigenous communities now and for the long term.

On the basis of the options appraisal above, Option 3 is considered to be the most socially and environmentally responsible, with pros outweighing the cons.

### 6. EVALUATION CRITERIA

6.1 The Deforestation Free Charter requires the Council to review and report on progress in one year. It is proposed that we review progress in March 2026 at the end of the next full financial year.

## 7. REASONS:

7.1 Monmouthshire County Council recognises that the Wellbeing of Future Generations Act requires us to work towards the Globally Responsible wellbeing goal. Considering our impact on tropical forests is an important part of working towards this goal. In addition, the Council has declared both Climate and Nature Emergencies, and exploring ways in which we can reduce our contribution to tropical deforestation will benefit both climate and nature, help our young people to be ethical, responsible citizens and help us to "think globally, act locally".

### 8. RESOURCE IMPLICATIONS:

8.1 Work to date has taken place within existing staff resources. The chickpea korma that has been developed by the pupils as an alternative to chicken korma has been costed as cheaper per portion. However some deforestation free alternatives to items that we purchase may have a

financial impact. If this is the case, then any changes will be subject to the usual financial and procurement considerations.

#### **APPENDIX 1**

#### **Deforestation Free Champions – Charter and Action Plan**

We are all part of the deforestation economy - it's in the food we eat, the products we buy, the fuel in our vehicles. When we think of the term *deforestation free* (DF), it's helpful to compare it to the Plastic Free Campaign - you can take steps to reduce or stop using single use plastic, but it's very difficult to get rid of all plastic. This is the same for forest risk. It's very difficult to completely remove all risk of deforestation as it is so embedded in our economy, but we can take practical actions that help to significantly reduce that risk, like using ethical certifications, circularity approaches and reducing waste.

A *Deforestation Free Champion* is a school, business, organisation, community or individual who advocates for tropical forests, people and nature, by learning, raising awareness, acting for change and inspiring others.

#### **Deforestation Free Champion Charter**

As a public body Monmouthshire County Council are committed to helping deliver all of Wales' well-being goals included in the Wellbeing of Future Generations (Wales) Act, including global responsibility, and meeting our biodiversity duty under the Environment (Wales) Act 2016. We believe that becoming a Deforestation Free Champion will not only help us contribute to these goals, but enable us to act as an advocate for tropical forests, people and nature.

To become a Deforestation Free Champion:

- We commit to tackling our overseas deforestation footprint and habitat loss through our practices and behaviours, for example, through procurement across different stages, such as challenging what we are buying, considering the wellbeing impacts or via effective contract management.
- 2. We commit to developing and carrying out our Deforestation Free Action Plan and auditing our procurement of forest-risk products and services.
- 3. We commit to making changes to deforestation-risk commodities in favour of more ethically sourced ingredients.
- 4. We will review our Fairtrade commitment and ensure it is carried out in our procurement practice.
- 5. We commit to helping our council learn about the importance of tropical forests, consumption-driven deforestation and what they can do about it.
- 6. We commit to working with our community, businesses, suppliers and partners, including schools, to raise awareness and support action on consumption-driven deforestation to help create a community of deforestation free champions.

7. We will continue to work with our local schools to help establish Wales' first Deforestation Free Champion Community.

In order to do this, we will develop and carry out the following action plan:

#### Monmouthshire County Council - Deforestation Free Champion (DFC) Action Plan

- 1. Learn. Begin with a DF training session/workshop for staff who will be involved in helping to deliver this work and those in decision making/leadership roles. (Size of Wales can deliver this.)
- 2. **Reflect.** Look at your own practices and behaviours as a council and identify where changes can be made. For example:
  - a. Have you adopted circularity and waste reduction practices across your estate?
  - b. Have you made a public commitment to source sustainably?
  - c. Have you switched to an ethical pension fund for your employees?

You can use the Policies & Practices template to help you with this.

**3.** Audit. Carry out a DF audit of the services and products you procure as a council and identify areas for change. This will include any forest-risk products and ingredients you procure directly and indirectly, e.g. through services such as catering and cleaning.

You can use the <u>DF Procurement Toolkit</u> (or <u>Business Toolkit</u>) and practical <u>audit</u> <u>template</u> to help guide you through this process. (The Deforestation Free team at Size of Wales will be happy to support you with this).

- 4. **Act.** Start to implement the changes you have identified in steps 2 and 3. These might include:
  - a. Signing up to the DFC Charter and making your commitment public.
  - b. Creating or updating catering guidance to incorporate DF criteria.
  - c. Reducing ultra processed foods (UPFs)in meals served to staff and the public.
  - d. Increasing the amount of plant-based proteins served in school meals and serving less, but better quality meat and dairy.
  - e. Replacing forest-risk ingredients with an ethically certified alternative.
  - f. Reviewing your Fairtrade commitment and ensuring Fairtrade products are given preference over non-certified products, consistent with your Fairtrade status.
  - g. Commit to becoming an RSPO certified council. (Long-term commitment)

Please note, that we don't expect you to do all of this at once! This is a journey, so you may want to start with one practical action and continue to make changes step by step. However you decide to begin, we recommend that you sign up to the DFC Charter and make your commitment public.

- 5. **Collaborate.** Continue to work with and support your community partners to become deforestation free, in particular schools, businesses and farmers. Support local farmers engaged in nature friendly farming practices, to build local food resilience.
- 6. **Inspire / Raise awareness.** Some of this will happen naturally through conversations with your suppliers, i.e. when you make changes as a result of your audit. However, there will be many other opportunities to raise awareness and inspire others across your work. For example:
  - a. Across your services, there may be opportunities to influence the partners and stakeholders you work with.
  - b. Within your community, e.g. you could share the journey you are on as a council and how you are working with community partners to achieve change.
  - c. Across your staff team, e.g., by organising a DF Lunch and Learn. (Size of Wales could deliver this).
  - d. After signing the DFC Charter and starting your deforestation free journey, you could share your actions and behaviour change publicly to show impact and inspire others.

#### How will this be assessed?

As part of our action plan and award, MCC will need to have done at least:

- 1 learning session provided by Size of Wales
- 1 reflection this will help provide the baseline via the policy and practice questions
- 1 audit of forest-risk commodities and services, e.g. catering
- 1 policy action e.g. signing up to DFC charter, a council resolution, creating a deforestation free policy etc.
- 1 practical action e.g. changing a deforestation risk ingredient, reformulating a dish to reduce forest footprint ("one meal at a time"), taking effective steps to reduce food waste etc. NB: action has to be something new, not something that would have happened anyway through other commitments/policies.
- 1 sharing/engagement e.g. with businesses or the wider community

After 1 year, this will be compared against the baseline to measure the level of change.

The deforestation free communities pilot has been developed by Size of Wales, based on their data and evidence of the scale of deforestation and the ocommodities that are driving this.

Development of the chickpea korma for school menus has been informed by detailed nutritional data, cost data and feedback from children, and uptake and any potential impact on the uptake of free school meals will be closely monitored.

Becoming a Deforestation Free Champion contributes positively to all wellbeing goals in the Wellbeing of Future Generation Act, but in particular the Globally Responsible goal, as well as a Resilient Wales and a Prosperous Wales. #### SUBJECT: CHARTER FOR FAMILIES BEREAVED THROUGH PUBLIC TRAGEDY (The Hillsborough Charter)

MEETING: County Council

DATE: 12.12.24

DIVISION/WARDS AFFECTED: All

#### 1. PURPOSE:

1.1 To outline 'The Charter for Families Bereaved through Public Tragedy' (Hillsborough Charter) and to seek Council's agreement to adopt and commit to the outlined principles in the response to a major incident.

#### 2. **RECOMMENDATIONS**

- 2.1 That the Council adopts The Charter for Families Bereaved through Public Tragedy (Hillsborough Charter) and champions the transparent and supportive environment for families bereaved by public tragedy as outlined in the Charter.
- 2.2 That the charter is embedded into the Monmouthshire County Council Emergency Management Plan and other appropriate major incident response plans to ensure the principles captured can be easily referenced, monitored and adhered to during a response.

#### 3. REASONS:

- 3.1 The Hillsborough Stadium disaster on 15 April 1989 cost 97 people their lives. The Government has published its response to Bishop James Jones' report on the experience of the Hillsborough families in the aftermath of the disaster. There was a myriad of failings which should never be repeated. Bishop James-Jones, the Home Secretary's advisor on Hillsborough, provided a thoughtful and considered report that shared the experiences of the Hillsborough families, and raised important recommendations which included the creation of the 'Charter for Families Bereaved through Public Tragedy'. The charter is a series of commitments by public bodies to change, each related to transparency and acting in the public interest.
- 3.2 Public bodies are asked to commit to the Charter and its six commitments:
  - In the event of a public tragedy, activate its emergency plan and deploy its resources to rescue victims, to support the bereaved and to protect the vulnerable.
  - Place the public interest above our own reputation.

- Approach forms of public scrutiny including public inquiries and inquests — with candour, in an open, honest and transparent way, making full disclosure of relevant documents, material and facts. Our objective is to assist the search for the truth. We accept that we should learn from the findings of external scrutiny and from past mistakes.
- Avoid seeking to defend the indefensible or to dismiss or disparage those who may have suffered where we have fallen short.
- Ensure all members of staff treat members of the public and each other with mutual respect and with courtesy. Where we fall short, we should apologise straightforwardly and genuinely.
- Recognise that we are accountable and open to challenge. We will ensure that processes are in place to allow the public to hold us to account for the work we do and for the way in which we do it. We do not knowingly mislead the public or the media.
- 3.3 The Strategic Director, Learning, Skills and Economy was invited to a pan-Wales event where all Category 1 organisations<sup>1</sup> were asked to sign up to the charter and pledge to meeting its commitments during a major incident. This initial event was organised by South Wales Police who are championing the charter and coordinating all Welsh response agencies to sign. A subsequent event was hosted by South Wales Police on October 1st providing an opportunity for response partners to hear first-hand the experience of victims from 4 major incidents; all relating their stories to barriers they faced as part of the response and the importance of the Charter in relation to their own stories. The speakers (and Major Incidents they were victims of) at the event were as follows:
  - Jeff Edwards Aberfan Disaster October 21<sup>st</sup>, 1966 where 116 children and 28 adults lost their lives following the coal waste tip slipping down the mountainside engulfing Pantglas Junior School and surrounding properties.
  - Margaret Aspinal whose son James died in the Hillsborough Stadium Disaster in Sheffield on April 15<sup>th</sup>, 1989. In total 97 people lost their lives due to failure of crowd control – with an influx of supporters entering the stadium pens resulting in overcrowding and a fatal crowd crush.
  - Ed Daffarn was a survivor of the Grenfell Tower Disaster which claimed the lives of 72 people on June 14th, 2017. He lived on the 16th floor of the tower block and was rescued by a fire fighter.
  - Paul Price who sustained life changing injuries and lost his partner • Elaine McIver following the terrorist attack and bombing of the Manchester Arena on May 22<sup>nd</sup> 2017 – where 22 people lost their lives.- All told very powerful personal stories of loss and suffering during these horrific incidents – but always brought it back to how they

were treated by public bodies which also added to their individual trauma.

- 3.4 There is an aspiration that all response partners will seek to sign up to the charter across Wales by Spring 2025, although it is recognised that each organisation must seek to agree this via their own governance arrangements. The aspiration is '*One Charter for Wales*' with all signing. In demonstrating how MCC can meet this aspiration and in relation to the points outlined in the charter, there is significant evidence in place that such principles are already being met. This evidence is outlined below.
- 3.5 Monmouthshire CC has a robust and because of several incidents over recent years, well-rehearsed 'Emergency Management / Response Plan'. Monmouthshire CC also sit on the Human Aspects Group within the Gwent Local Resilience Forum area and have signed up to the 'Human Aspects Response Framework' that is currently in its final stages of development. It summarises the methods by which organisations can provide a coordinated, prompt and appropriate humanitarian response to incidents within the Gwent Police boundary supporting victims, the families of the bereaved and those vulnerable because of a major incident.
- 3.6 More specifically, within the Gwent Police area, the 5 local authorities and Gwent Police have signed up to a joint Crisis Support Workers Scheme. The Scheme maintains a pool of suitably trained Crisis Support Workers (CSWs) to work alongside Gwent Police Family Liaison Officers (FLOs) who have been deployed to families (resident within the Gwent Police boundary area) directly bereaved as the result of a major incident. Working in partnership will ensure that alongside the necessary police investigation, affected families are provided with the information, care and support they need during this time in a sensitive and compassionate manner. CSWs can provide initial care and practical support to the family and also provide signposting to individuals and organisations that can help meet any longer-term needs.
- 3.7 MCC has for many years adopted the key core values of openness, fairness, flexibility, teamwork and kindness with a priority being the protection of vulnerable people. These align directly with the ethos of the charter.
- 3.8 In support of the various Emergency Response plans in place, MCC also ensures that the council puts in place appropriate training and exercising so staff know their roles and responsibilities and how to deal compassionately with those that have been involved in major incidents. One example of this is the 'Live' Care Centre exercise that has been scheduled at Caldicot Leisure Centre on November 6<sup>th</sup> this year providing staff from Monmouthshire County Council, Gwent Police and Third Sector Organisations with an opportunity to work together in establishing and operating a Survivor Reception Centre, following procedures currently set out in the Monmouthshire Care Centre Handbook.
- 3.9 If all partner organisations who have a role in major incident response sign up to this charter there will be this clear set of principles that can be referred and adhered to with more positive outcomes for all those impacted by such disasters.
- 3.10 In addition to all of the above, and, as outlined by the Prime Minister, there is a move to put legislation in place that would compel public bodies to co-

operate with investigations into major disasters or potentially face criminal sanctions. This is currently being referred to as the 'Hillsborough Law' that will formally introduce a Duty of Candor on public bodies. This is because of a long-fought campaign by families of the Hillsborough Disaster to focus on the victims and individuals touched by such an event and 'protect' those that have been directly impacted. The law will seek to prevent public bodies 'closing ranks' and be made directly accountable for their actions and changes to some current cultures.

3.11 Prior to any such legislation being formally put in place the current aim and next steps is for all response partners to collectively sign a single Charter for Wales and accept this Charter as a moral obligation in line with organisational values as opposed to needing or waiting for such legislation to be adopted.

#### 3. KEY ISSUES

- 3.2 The Joint Council for Wales (JCW) is an all-Wales forum where the Local Authority Employers in Wales and the relevant Trades Unions meet on workforce issues of mutual concern and interest. Each local authority has two seats on the JCW. The majority of local authorities now nominate their Cabinet member as one of these members and this vacancy creates an opportunity to appoint Cllr Callard to the group alongside Cllr Murphy who is a long-standing member.
- 3.3 Y Prentis is an apprenticeship scheme focused on the construction industry. It was set up by the authority and Melin Homes and funded by the Construction Industry Training Board and the Welsh Government. Its focus is on supporting the development of young people into the construction industry to ensure we have a sustainable pipeline of young talent for the future. The Council has a seat on the Y Prentis Board.
