1. PURPOSE:

To consider an application for a new premises licence under the Licensing Act 2003 for Only Foods and Sauces Limited, Bulwark Industrial Estate, Bulwark, Chepstow, NP16 5QZ. A copy of the application and plan is attached as Appendix A.

2. RECOMMENDATION:

It is recommended that members consider and determine the application referred to in 3.1 below, based on the information provided. The options to members in considering the application are:

- To grant the licence
- To grant with the addition of conditions necessary to promote any of the licensing objectives
- To exclude from the scope of the licence any of the licensable activities to which the application relates
- To refuse to specify a person in the licence as the premises supervisor
- To reject the application

3. KEY ISSUES

3.1 An application for a new premises licence under the Licensing Act 2003 was received from Mrs Kelly Getting T/A Only Foods and Sauces Limited for Bulwark Industrial Estate, Bulwark, Chepstow, NP16 5QZ for the following:-

- Provision of Films: Friday-Sunday – 09:00 to 23:00 (Outdoors)
- Provision of Live Music: Friday-Sunday – 09:00 to 23:00 (Outdoors)
- Provision of Recorded Music: Monday-Thursday – 09:00-14:00 & Friday-Sunday – 09:00-23:00 (Outdoors)
- Supply of Alcohol: Friday-Sunday – 12:00-23:00 (On the Premises)
- Open Hours (Standard timings): Monday-Thursday – 09:00-14:00 & Friday-Sunday – 09:00-23:00

3.2 The applicant provided a general description of the premises which states the premises is Food/burger van, dessert van and drinks van serving alcoholic beverages with a seating area

3.3 A map of where the premises is located within Bulwark Industrial Estate and the surrounding area can viewed as Appendix B.

3.4 The applicant has stated the following when asked in the application to describe the steps intended to take to promote the licensing objectives:

General

We are committed to running a safe, family friendly food and dessert van that meets all four licensing objectives. All staff will be trained in food hygiene, age verification,

and customer service. Clear signage will be displayed around the van promoting safe conduct and respect for others. We will maintain a clean, well-lit environment, with CCTV installed where appropriate, and we'll keep an incident/refusals log to support responsible operation. We'll work closely with local authorities and respond to concerns promptly.

The Prevention of Crime and Disorder

We will operate a zero-tolerance policy towards any abusive or unlawful behaviour around the van. Our team will be trained in conflict management and will refuse service to any customer showing signs of aggression or intoxication. If needed, we will contact local police and cooperate fully with any investigations. The area around the van will be kept tidy and clear of obstructions to deter loitering and anti-social behaviour.

Public Safety

The van will be maintained to high standards of hygiene and safety. All food will be prepared and served in accordance with food safety legislation. Fire extinguishers, a first aid kit, and safety signage will be available inside the van. Trip hazards (e.g., cables or equipment) will be avoided with secure setups. We will assess the setup of any seating areas to ensure customer safety and ensure safe queuing practices during busy periods.

Prevention of Public Nuisance

We will ensure our van does not cause unnecessary disturbance to nearby residents or businesses. Waste will be properly disposed of in secure bins, and litter around the area will be regularly picked up by staff. Signage will remind customers to respect neighbours and leave the area quietly, especially during late trading hours.

Protection of Children from Harm

Our vans are family-friendly environments. We will not sell any age-restricted products without enforcing a Challenge 25 policy. All staff will be trained to check ID and refuse service where appropriate. Any inappropriate behaviour will be addressed immediately, and we will always ensure that the van's surroundings are safe and welcoming for children. All promotional materials will be suitable for all ages.

- 3.5 If granted the licence would also be subject to Mandatory Conditions, which are attached to this report as Appendix C.
- 3.6 It is important to note, if the sale of alcohol is granted the licence will also benefit from the Live Music Act 2012. The relaxation of amplified live/recorded music can only take place if alcohol is sold on the premises. The relaxation states that it must be between the hours of 08:00-23:00 and not exceed 500 people. In this instance it would mean that should the on-licence be granted then the music can be played between 12.00-23.00 on Friday-Sunday providing numbers do not exceed 500. The Live Music Act 2012 also states you do not need a licence to put on unamplified live music at any place between the hours of 08:00-23:00 or to put on amplified live music at a workplace between the hours of 08:00-23:00 and provided the audience is no more than 500 people.

Further information on the Live Music Act is attached as Appendix D.

- 3.7 Copies of their premises licence application were issued to the 'Responsible Authorities' namely Gwent Police, South Wales Fire Service, The Local Health

Board, Home Office (Immigration) and departments of Monmouthshire County Council being the Environmental Health Section, Social Services, Planning, Licensing and Trading Standards Department, which was carried out by the Licensing Authority. A notice also must be circulated in a newspaper within the area of the premises as well as a notice displayed at the premises to enable businesses and residents to make a representation. The applicant duly carried this out. The application is also advertised via the Council's website, which gives details on how a person can make a representation and this was carried out by the Licensing Authority.

- 3.8 Representations were received by Gwent Police (attached as Appendix E) and Environmental Health (attached as Appendix F). Gwent Police raised their representation against all 4 licensing objectives, whilst Environmental Health raised their representation against the prevention of public nuisance. To summarise the representations received by Gwent Police and Environmental Health were:

Gwent Police

- Supply of Alcohol to cease at 22:30 Friday-Sunday to allow 30 minutes of drink up time
- Additional training for staff working at the premises
- The implementation of CCTV in licensed areas of the premises
- Incident/refusal logbook
- Further monitoring of the premises and notices displayed at the premises
- Implementation of the Challenge 25 Scheme

Environmental Health

- Implementation of noise management plan
- Installation of a noise limiting device

The applicant confirmed in writing to the Licensing Authority their acceptance of the representations made by Gwent Police and Environmental Health. Upon acceptance of the conditions Gwent Police and Environmental Health do not raise an objection to the application as a statutory body. Therefore, the representations made will form part of the premises licence conditions should a licence be granted.

No representations were received by any other responsible authority. However, the Planning Authority has informed the Licensing Authority on 21st August 2025 of the following, "We cannot find any planning permissions for this food and drink use on the Bulwark Industrial Estate and will be opening an enforcement case to investigate this change of use.". However, the Licensing Committee is not bound by decisions made by the Planning Committee and vice versa.

- 3.9 38 representations objecting to the premises licence application were received by other persons. The objections to the application can be viewed as Appendix G, and are summarised below:

- Noise pollution will occur from events at the premises which may become more frequent should a premises licence be granted
- Concerns around persons leaving the premises intoxicated causing disruption to local businesses, groups and residents
- Concerns around large groups gathering in the industrial estate and surrounding area which may cause traffic and travel issues
- Increase in littering and rubbish around the area
- Concerns regarding the running of the premises and how the issues would be addressed should they continue on a permanent basis

- 3.10 90 representations of support to the premises licence application were received by other persons. The emails of support can be viewed as Appendix H, and are also summarised below:

- Music is only for occasional events and won't cause a nuisance
- The premises is bringing visitors from all over the country to the area
- Provides a place for persons of any age to attend which is a safe and fun space
- The premises is providing a service to the local community and local residents can and are benefitting from it
- The business is making use of a space which would be empty and derelict but can be used by the community now

3.11 The representations were issued to the applicant and who were asked whether they wish to amend the application in light of the representations received or wish to provide a comment on the representations received. The applicant's response can be viewed as Appendix I and is summarised as follows:

- The business is family run and community focused with a space which welcomes families and individuals
- Some of the representations made are not against the licensing objectives
- Further policies have been implemented around monitoring events and notifying local residents
- The premises is attracting customers from outside of the County to visit the area

3.12 Representations made under the Licensing Act 2003 must be made under the four key licensing objectives, namely:-

- The prevention of crime and disorder;
- Public Safety;
- The prevention of public nuisance; and
- The protection of children from harm.

However, Section 9.9 of the Guidance issued by the Home Office states:

It is recommended that, in borderline cases, the benefit of the doubt about any aspect of a representation should be given to the person making that representation. The subsequent hearing would then provide an opportunity for the person or body making the representation to amplify and clarify it.

3.13 When considering their decision members are asked to consider the licensing objectives guidance issued under the revised guidance under section 182 of the Licensing Act 2003 (attached as Appendix J)

3.14 In accordance with 9.2 of the Home Office Guidance issued under Section 182 of the Licensing Act 2003. A hearing is not required where an application has been properly made and no responsible authority or other person has made a relevant representation or where representations are made and subsequently withdrawn..... Licensing authorities should not hold hearings for uncontested applications, for example in situations where representations have been made and conditions have subsequently been agreed. As such, no agreement was reached with the other persons who made a representation, and a hearing is required.

4. REASONS:

4.1 The determination of an application is to be considered in accordance with Section 182 of the Licensing Act 2003.

- 4.2 In section 9.4 of the Guidance issued under section 182 of the Licensing Act 2003, the Secretary of State recommends that, a representation would only be “relevant” if it relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives.
- 4.3 In section 13.10 of the Guidance issued under Section 182. It is important that a licensing authority should give comprehensive reasons for its decisions in anticipation of any appeals. Failure to give adequate reasons could itself give rise to grounds for an appeal. It is particularly important that reasons should also address the extent to which the decision has been made with regard to the licensing authority’s statement of policy and this Guidance.
- 4.4 The Licensing Authority has a duty under the Act to carry out its functions with a view to promoting the licensing objectives. Sections 9-13 of Monmouthshire County Council’s Licensing Act Policy 2025 provides information on the promotion of the licensing objectives to applicants applying for a premises licence.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. - Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

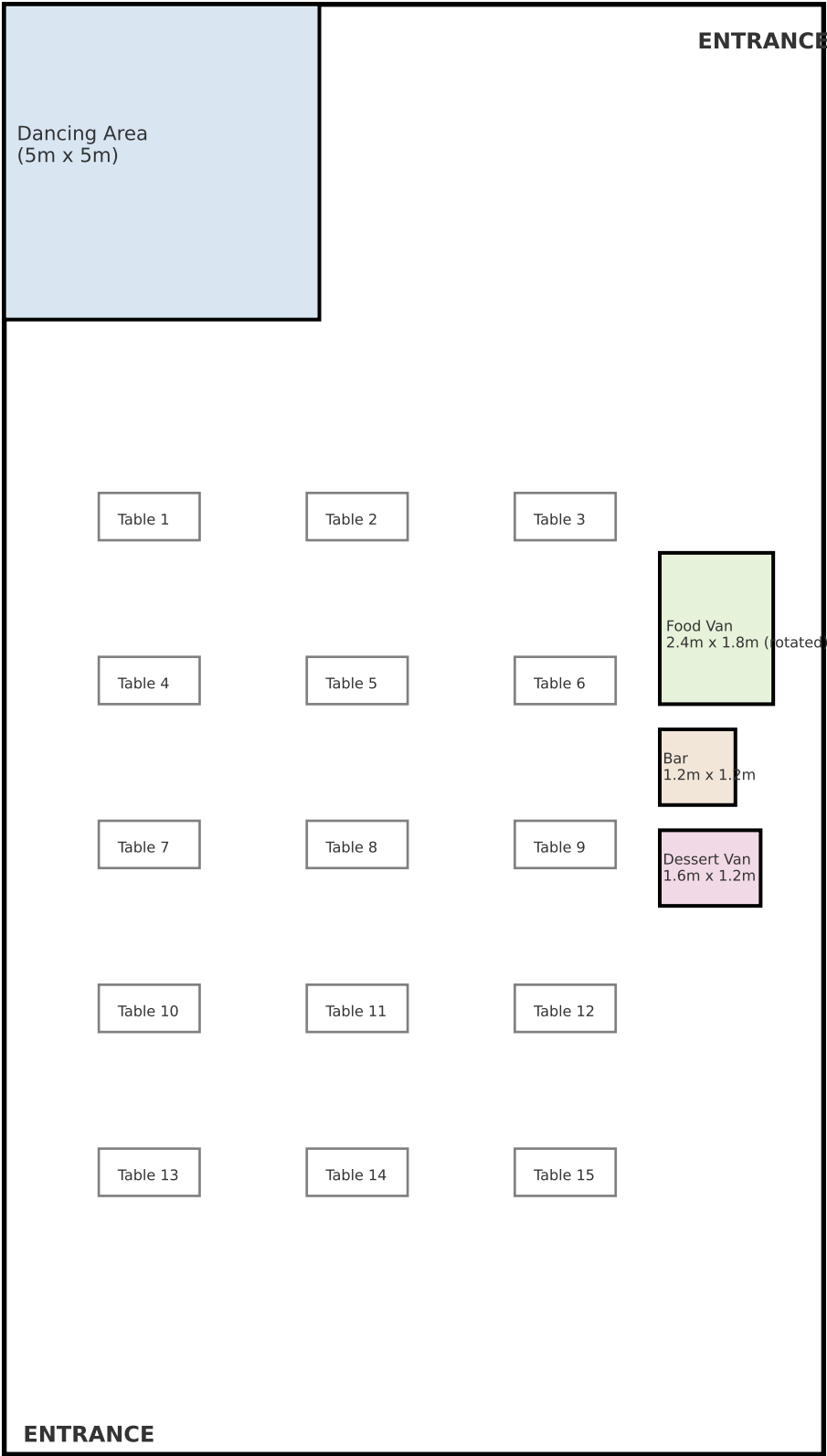

Annex 1 – Mandatory conditions

Mandatory Conditions – Supply of Alcohol

- 1 No supply of alcohol may be made under the premises licence:
- i) at a time when there is no designated premises supervisor in respect of the premises licence; or
 - ii) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2 Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory Conditions – Security Activity

- 3 Where at specified times one or more individuals may be at the premises to carry out a security activity, each individual must be licensed by the Security Industry Authority. For the purposes of this section:
- i) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies; and
 - ii) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Mandatory Conditions – Exhibition of a Film

- 4 The admission of children to the exhibition of any film must be restricted in accordance with any recommendation made by the British Board of Film Classification (BBFC) or in the absence of a recommendation from the BBFC, the Licensing Authority. For the purposes of this section:
- i) "children" means persons aged under 18 years of age.

Mandatory Conditions – Supply of Alcohol for Consumption On The Premises

- 5 The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or .

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);.

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; .

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; .

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; .

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

6. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

7. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.

8. The responsible person must ensure that—

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.”

Mandatory conditions - The ban of the sale of alcohol below the cost of duty plus VAT

9. (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

(2) In this condition:-

(a) "permitted price" is the price found by applying the formula $P = D + (D \times V)$, where-

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

(3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny.

(4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

1. Overview

Businesses, organisations and individuals who want to provide types of entertainment may require a licence or other authorisation from a licensing authority - a local council.

The types of businesses and organisations that need a licence for entertainment might include:

- nightclubs
- live music venues
- cinemas
- larger theatres
- larger street and open air festivals
- larger indoor sporting arena

In particular a licence may be required by:

- anyone that provides any entertainment between 11PM and 8AM;
- anyone that provides amplified [live or recorded music](#) to an audience of more than 500 people;
- anyone that provides [recorded music](#) to an audience on premises not licensed for the sale or supply of alcohol;
- anyone that puts on a performance of a [play or a dance](#) to an audience of more than 500 people, or an [indoor sporting event](#) to more than 1,000 spectators
- anyone that puts on [boxing or wrestling](#)
- anyone that screens a [film](#) to an audience

2. Do I need a licence for music entertainment?

Whether a licence is needed for music entertainment will depend on the circumstances. A licence is not required to stage a performance of live music, or the playing of recorded music if:

- it takes place between 8AM and 11PM; and
- it takes place at an alcohol on-licensed premises; and
- the audience is no more than 500 people

You also don't need a licence:

- to put on unamplified live music at any place between the same hours; or
- to put on amplified live music at a workplace between the same hours and provided the audience is no more than 500 people.

In other circumstances, a licence may be required. One [licence application \(https://www.gov.uk/alcohol-licensing\)](https://www.gov.uk/alcohol-licensing) can cover all types of regulated entertainment and the sale or supply of alcohol.

There are exemptions from the need for a licence for music entertainment, in defined circumstances as set out in the [Guidance](#), including for:

- places of public worship, village halls, church halls and other similar buildings
- schools
- hospitals
- local authority premises
- incidental music - music that is incidental to other activities that aren't classed as regulated entertainment

The [Guidance](#) also sets out the process by which a local council can review a licence where problems may occur in relation to music entertainment and noise nuisance.

3. Do I need a licence to put on a play or a performance of dance?

Whether a licence is needed for a performance of a play or a dance will depend on the circumstances. A licence is not required to stage a performance of a play or a performance of dance if:

- it takes place between 8AM and 11PM; and
- the audience is no more than 500 people.

In other circumstances, a licence may be required. One licence application can cover all types of regulated entertainment and the sale or supply of alcohol. A licence is always required for any activity that is [sexual entertainment](#)

4. Do I need a licence to stage an indoor sporting event?

Whether a licence is needed for an indoor sporting event will depend on the circumstances. A licence is not required to stage an indoor sporting event if:

- it takes place between 8AM and 11PM; and
- the number of spectators is not more than 1000 people.

In other circumstances, a licence may be required. One [licence application](#) (<https://www.gov.uk/alcohol-licensing>) can cover all types of regulated entertainment and the sale or supply of alcohol.

5. Do I need a licence to stage boxing or wrestling?

You will need a licence to stage boxing, wrestling and mixed martial arts. One [licence application \(https://www.gov.uk/alcohol-licensing\)](https://www.gov.uk/alcohol-licensing) can cover all types of regulated entertainment and the sale or supply of alcohol.

6. Do I need a licence to screen a film?

A licence is needed to screen a film or exhibit moving pictures. One [licence application \(https://www.gov.uk/alcohol-licensing\)](https://www.gov.uk/alcohol-licensing) can cover all types of regulated entertainment and the sale or supply of alcohol.

There are exemptions from the need for a licence for film entertainment, in defined circumstances as set out in the [Guidance](#), including for:

- places of public worship, village halls, church halls and other similar buildings
- education
- incidental film – moving pictures that are incidental to other activities that aren't classed as regulated entertainment
- television broadcasts

In other circumstances, a licence may be required to show a film:

- in public
- or in private, if those attending are charged for entry and the intention is to make a profit, including raising money for charity.

Licensing of entertainment under the Licensing Act 2003 is entirely separate from copyright authorisation to show [films in public \(https://www.gov.uk/showing-films-in-public\)](https://www.gov.uk/showing-films-in-public).

As you are aware this department has received a significant number of complaints alleging loud amplified music emanating from this premises over the weekend. I understand that a significant number of objections have been raised by members of the public and therefore this application will be referred to the Licensing committee. Whilst I am not in a position to substantiate the complaints received over the weekend at this stage, given the site is outdoor and that amplified music has the potential to cause disturbance to nearby premises I would request that the following conditions were included under the Prevention of Public Nuisance objective on any licence granted:

1. A noise management plan detailing appropriate controls to prevent unreasonable noise disturbance to nearby premises shall be retained at the premises and shall be reviewed from time to time.
2. A noise limiting device shall be installed and maintained on the premises and all amplified sound provided for the purpose of regulated entertainment shall be limited by this device. The device shall be set in agreement with the licensing authority to ensure that when amplified sound is provided on the premises it does not cause unreasonable noise disturbance to nearby premises. After commissioning, the noise limiting device will be sealed to prevent it being over-ridden or otherwise tampered with when regulated entertainment is being provided.

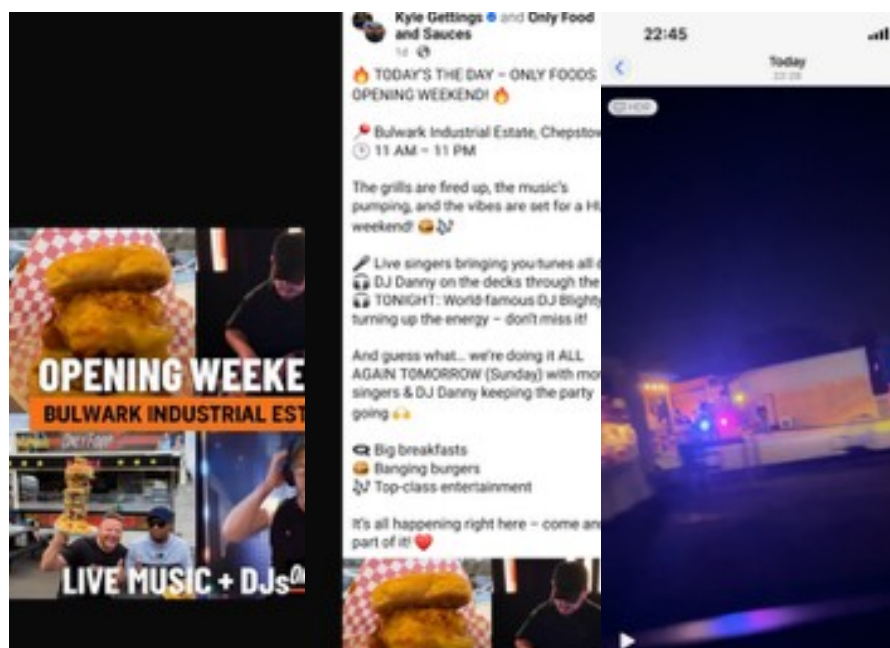
Hi emailing in confidence that you will keep my details confidential please as I almost went in myself to ask them to turn it down but didn't want to get a grief from people.

They have recently held a weekend event which caused considerable noise nuisance until late into the evening. - Noise disturbance - at least for the past fortnight, Only Foods and Sauces have been playing loud music near continuously on Saturdays and Sundays from around midday until around 11pm. Both the level of music and duration of music have been a nuisance and certainly disturb us at the house.
- Impact on work - I work in the NHS and, like many others, enjoy relaxing out of work in the peace and quiet of my own home - notably this has been impacted due to the noise from the industrial estate. The worst of which has been music after 9pm on both Saturday and Sunday.
- Concerns re this ongoing due to the fact that this has noticeably changed the atmosphere of our home environment. For instance, when trying to enjoy leisurely time in our garden
- Concerns re extending recorded music hours into the week too

We would be grateful for you to acknowledge our concerns as local residents and, whilst not wishing to close down their operations in totality, capping music hours, significantly lowering noise levels and preferably not extending licensing hours, are all things we would appreciate you considering and enacting.

I'm writing in regards to the current licensing application submitted by Only Foods and Sauces. This application seeks to allow them to:

- Play amplified music in the area throughout the week and until 11pm on weekends.
- Serve alcohol over the weekend.

I'd like to express my explicit opposition to this application as a concerned resident nearby.

Amplified Music

Recently, Only Foods and Sauces began playing music extremely loudly from their location, which was clearly audible throughout much of Bulwark. This included in peoples' gardens, in local fields and even from inside our house. Given that the food truck is not in a building itself, nor is the industrial estate it lies in particularly enclosed, the sound travelled well, much further than may be expected.

This area is largely residential, with many families, pet owners and elderly residents living here. As such, it is a peaceful and quiet environment. The music that has already been played disturbed this peace. As a one-off, it's tolerable, and I accept that the company throwing events for the local community has its benefits.

However, the application would give them unilateral permission to play this music whenever they decided. If given this freedom, it's entirely possible that the Bulwark neighbourhood has a continuous soundtrack ringing out, making it almost intolerable to live in. Residents wouldn't be able to raise their children in peace, walk their dogs in peace, enjoy a book in the garden in peace or even enjoy peaceful time in their own homes on a summers day with the window open. This is made more unreasonable given the application seeks permission to play music on weekends until 11pm. At this point, many residents are already asleep or trying to wind down, and the last thing we'd want is loud music playing through the neighbourhood preventing it.

Alcohol consumption

I have less concern with the sale and consumption of alcohol. However, my concern is again with the impacts this may have on local residents.

Only Foods and Sauces is positioned in an industrial estate, accessible primarily by footpaths through residential areas. While the company make clear in their application that they would not tolerate anti-social behaviour *on their premises* following the sale of alcohol, this does nothing to prevent those drunk people walking through the nearby residential areas and causing disruption.

While this wouldn't be a new concern - there are pubs and shops nearby that serve alcohol, of course - it would increase the amount of alcohol consumption and drunk behaviour in the area, providing acute challenges to local police and a reduction in the safety felt by residents in what is, otherwise, a safe neighbourhood.

Tiktok

Finally, if this were a reasonably anonymous food truck I'd perhaps have less concern. However, Only Foods and Sauces regularly broadcast their business to over 150,000 followers on Tiktok. I'm led to assume that much of their business comes from attracting people from outside the area to try their food through this advertising channel. My concern therefore is that if given permission to play music, sell alcohol and run frequent events, the disruption is not just limited to the number of local residents who may take an interest. Instead, it's entirely possible that there are large crowds from across the UK that turn up. This provides a number of challenges for local policing, potential crowd control, and potential infrastructure concerns that the Bulwark area of Chepstow is not equipped to manage effectively. It would also significantly damage local resident morale if the area becomes far more crowded than it is used to on a regular basis.

Conclusion

To conclude, I strongly oppose the application submitted by Only Foods and Sauces, and hope that the concerns of local residents in the nearby area are considered when making the decision.

I wish to formally object to the premises licence application for Only Foods and Sauces Limited at Bulwark Industrial Estate, Bulwark, Chepstow, NP16 5QZ, dated 17th July 2025.

My objection is based on the following:

1. Prevention of Public Nuisance

The proposed hours for recorded music, live music, and film screenings outdoors until 23:00 on Fridays, Saturdays, and Sundays are likely to cause significant noise disturbance to nearby residents. Outdoor amplified sound late in the evening will travel widely, especially in warmer months, affecting the peace and wellbeing of the local community.

Late-night alcohol sales may also lead to increased noise from patrons leaving the venue, including raised voices, vehicle noise, and anti-social behaviour in the surrounding area.

2. Prevention of Crime and Disorder

Alcohol sales until 23:00 across three consecutive nights create a heightened risk of alcohol-related incidents in an industrial estate location where natural surveillance is limited in the evenings. This can make disorderly or unsafe behaviour more difficult to monitor and control.

3. Public Safety

The site is within an industrial estate not designed for high volumes of pedestrians at night. Large outdoor gatherings will require substantial safety measures, including crowd management and traffic control, which have not been detailed in the application. Without these, there is a risk to the safety of attendees and other users of the area.

4. Protection of Children from Harm

Of particular concern is that there is a gymnastics club located directly next door, which is regularly attended by many children, including during evenings and weekends.

The presence of outdoor alcohol consumption and amplified music near a facility primarily used by children significantly increases the risk of children being exposed to inappropriate language or behaviour from intoxicated adults.

Increased traffic and footfall associated with late-night events may also present safety hazards for children and their parents accessing the gymnastics club.

While supporting the growth of local businesses, I believe that the nature, timing, and location of these proposed licensable activities, particularly outdoor amplified music and late-night alcohol sales, pose unacceptable risks in relation to public nuisance, public safety, and especially the protection of children from harm.

I therefore respectfully request that this application be refused or substantially restricted to safeguard the local community and the many children attending the neighbouring gymnastics club.

I am submitting this opposition to the application by Only Foods and Sauces Limited for a premises licence allowing the sale of alcohol (Friday–Sunday until 23:00), outdoor recorded and live music (Friday–Sunday 09:00–23:00), and films (Friday–Sunday 09:00–23:00) at the above address.

My objections are made in direct reference to the four licensing objectives under the Licensing Act 2003:

1. Prevention of Public Nuisance

The proposal to hold outdoor live and recorded music every weekend from morning until 23:00 will create excessive noise, disturbing the peace of nearby residential areas. This will cause repeated disruption to residents' daily lives, particularly affecting children's ability to sleep and concentrate. Outdoor events of this scale and duration are wholly incompatible with the quiet enjoyment of nearby homes.

2. Prevention of Crime and Disorder

Late-night alcohol sales, combined with live entertainment, significantly increase the likelihood of anti-social behaviour, public drunkenness, vandalism, and disorder in the local area. This is especially concerning given the industrial estate's proximity to residential streets, which could become hotspots for noise, littering, and rowdy behaviour after closing time.

3. Public Safety

An influx of drinkers into an area not designed for large-scale leisure activity poses safety risks, including dangerous driving, impaired behaviour, and confrontations.

The surrounding infrastructure is not equipped for the volume and nature of traffic and pedestrian movement that such events would create.

4. Protection of Children from Harm

Families with young children live within earshot of the proposed venue. Exposure to loud and prolonged music, as well as the increased presence of intoxicated individuals, creates an unsuitable and potentially unsafe environment for children. This would directly undermine the safeguarding of young people in our community.

Additional Concern – Negative Impact on Local Amenity and Property Values

The persistent disturbance caused by weekend events of this kind will make the area less attractive to potential buyers, reducing the long-term saleability and value of local homes. This is a real and foreseeable consequence that further justifies refusing this application.

The scale, frequency, and duration of the proposed activities will inevitably cause noise disturbance, increase the risk of disorder, and create a harmful environment for children, all in direct conflict with the Licensing Act's four statutory objectives.

For the sake of protecting public safety, community wellbeing, and the residential character of the area, I urge the Licensing Authority to reject this application in full.

The noise levels from music and loud voices have been unbearable, with sound carrying directly into our homes and gardens from morning through to late evening. These disturbances have occurred throughout the day on weekends and, on multiple occasions, have continued late into the night, severely impacting the peace and quiet of the neighbourhood.

Granting a licence for:

Sale of alcohol from Friday to Sunday until 23:00

Outdoor recorded music Monday–Sunday,

would, in my view, create a substantial and ongoing public nuisance for nearby residents. The proposed hours, especially with outdoor amplified sound, are wholly inappropriate for a location so close to a residential area.

Will there be any physical measures to contain noise.

What restrictions will there be on volume and how will these and opening hours be monitored?

It risks setting a precedent that our neighbourhood is no longer considered a quiet residential area, but instead an entertainment zone—something that residents have not agreed to. I strongly believe that the introduction of a licensed venue serving alcohol and playing amplified music, raises serious concerns. I fear that if this application is approved, it will attract large crowds and potentially lead to increased antisocial behaviour, noise pollution, and a general decline in the quality of life for local residents.

I am writing regarding the licensing application at Only Foods and Sauces, Bulwark Industrial Estate, NP16 5QZ.

The van had an event on over the weekend of 9 and 10th of August 2025. There was music between 11.00am to 11.00pm. I could hear this in my house and garden throughout the day. I thought this was an occasional event and hoped everyone had a lovely time and enjoyed the fine weather. There was also an event on a weekend earlier in the summer. You could hear music that weekend too.

I have not seen any publicity or a notice about this application. How have local residents been informed about it?

While the van is sited on an industrial site, there are residential properties nearby. The van is outside. The music is outside and sound carries. An outdoor site near houses is not suitable for frequent loud music. I could hear music this weekend and the application is for longer, for example, from 9.00am on Fridays, Saturdays and Sundays. The noise was intrusive this weekend but as a very occasional event, it would be tolerable. More frequent use will be unacceptable; it will be a nuisance and disruptive. I am not the 'nearest' neighbour by any means.

This seems to be a change and intensification of use. There are other businesses on the industrial estate, for example, a bus depot and workshops. It is also the approach road to Elis laundry. It can be a busy area with parked cars, and cars, lorries and buses manoeuvring. Therefore, I am also concerned about road safety.

I do not believe that this is a suitable location for this use. I would also add again that there has not been any publicity to allow residents to make representations. I only became aware of this application yesterday evening.

Last weekend they had a temporary licence for music from 10-11pm Friday Sat and Sunday I believe. It was all day. The music boomed at us with the volume from the bass and we had the repetitive beat all day. A combination of live singing and recorded. So much so we had to leave the house and go to another family member to have a break from it as my son was struggling with it.

While I applaud what they are doing and wish them loads of luck they have to work with us neighbours and keep the volume down to a minimum please. It sounded like an all day rave. It was oppressive. Too long.

The odd party now and then with a sensible cut off time is fine and a short bit of music is sensible. But the music was just too loud for all day it was torturous. I felt too vulnerable on my own at 10.30 to go up and ask them to turn it down. I did drive up there to do so but didn't want to get out. But I know that other neighbours did and fair play they did turn it down for a bit but it soon crept back up.

Musical all day amplified on speakers or hi powered speakers is just too much. Whether it's singing or recorded music. Please can they just tone it down. Have music for a much shorter time not all day. It nearly drove us to distraction. It's like they are an outdoor pub.

No one wants to see them fail, they look like they are having a fab time and that is brilliant and it looks like their business is booming which is also great too. But please consider the neighbours. Some of us work nights. Some of us have children who struggle with repetitive sounds. The bass at some points was very overwhelming. It may not have felt like it to them but the sound travels down the units and the road straight down to us.

I wish them well. I really do. But just please no long days of loud music. The odd evening is ok but just not so loud and not all day. Our peaceful gardens were not peaceful. We really struggled to relax that weekend after a really stressful week in work.

I attach a video short from close by when I went up at 10.30 to ask them to turn it down but didn't feel confident enough to do so. You can hear the booming base and I'm about 150 yards from it. But I had stopped from going further because I felt too vulnerable.

Please can you consider the above. While I do not want them to fail I would like a bit of sensitivity around volume and length of time for playing music considered for the neighbours. I don't understand why it had to be so loud. I love seeing people have fun, but the needs of others has to be considered too. All day just pushed us over the edge. It was relentless and I get it was an opening weekend. But we didn't get a break from it. Now and then is ok. But not all the time and not so loud. Good luck for their business. I really do wish them that. Just think of us too. We get what you want to do. But please consider us too.

My name is [REDACTED], and I am writing to express my full support the business, Only Foods, which is currently facing the loss of its licence. As a father of two, a local neighbour renting the property next door to the van, and someone who cares deeply about our community, I believe closing this business would be a serious mistake.

I rent the property immediately next to Only Foods. I am closer to it than any of the other objectors, and I have no issue with its presence whatsoever. I see it day in, day out, and I can honestly say it has never caused me any disturbance. In fact, what I see is a safe, friendly, and positive environment where families gather and enjoy themselves. If I rent next door and find no problem — only benefits — then I think it's fair to say some of the 22 objections may be overly extreme.

Only Foods has grown into far more than just a burger van. The owner has opened up the back, created a warm, family-oriented atmosphere, and put on events that encourage people to come together. In relation to the objections raised, I would like to make the following comments:

- Our business is family-run and community-focused. We aim to provide a safe and welcoming space for families and individuals to enjoy food and social events.
- Any concerns regarding competition are not, in our view, a valid licensing ground. There are already many similar businesses operating close to one another in our town (e.g., coffee shops, burger outlets, barbers), and customers rightly benefit from having choice.
- We are committed to working with the council and the local community to ensure our events are run responsibly and in line with all licensing objectives (public safety, prevention of nuisance, protection of children, etc.). To demonstrate this commitment, we have gone door-to-door informing local residents of upcoming events, and we provide them with a dedicated email contact that is monitored constantly. This means if there are any issues such as noise or nuisance complaints, they can reach us directly and we are able to deal with them immediately.
- We have also been monitoring our customer base and can demonstrate that a significant proportion of our visitors are travelling from outside of Chepstow specifically to attend our site. This proves that we are not only drawing local residents but actively bringing additional people into the town. As a result, we are helping Chepstow's economy by attracting visitors who may also use other local businesses while here.
- In fact, we are seeing more customers coming from outside of Chepstow than from within the town itself. This is clear evidence that our presence is creating positive economic growth, increasing footfall, and helping Chepstow thrive at a time when, unfortunately, the high street is struggling. Chepstow is a beautiful

place and we want to see it grow and succeed, and we believe our business plays a valuable role in that.

2. The licensing objectives

Crime and disorder

- 2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).
- 2.2 In the exercise of their functions, licensing authorities should seek to co-operate with the Security Industry Authority (“SIA”) as far as possible and consider adding relevant conditions to licences where appropriate. The SIA also plays an important role in preventing crime and disorder by ensuring that door supervisors are properly licensed and, in partnership with police and other agencies, that security companies are not being used as fronts for serious and organised criminal activity. This may include making specific enquiries or visiting premises through intelligence led operations in conjunction with the police, local authorities and other partner agencies. Similarly, the provision of requirements for door supervision may be appropriate to ensure that people who are drunk, drug dealers or people carrying firearms do not enter the premises and ensuring that the police are kept informed.
- 2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in licensed premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.
- 2.4 The inclusion of radio links and ring-round phone systems should be considered an appropriate condition for public houses, bars and nightclubs operating in city and town centre leisure areas with a high density of licensed premises. These systems allow managers of licensed premises to communicate instantly with the police and facilitate a rapid response to any disorder which may be endangering the customers and staff on the premises.
- 2.5 Conditions relating to the management competency of designated premises supervisors should not normally be attached to premises licences. It will normally be the responsibility of the premises licence holder as an employer, and not the licensing authority, to ensure that the managers appointed at the premises are competent and appropriately trained. The designated premises supervisor is the key person who will usually be responsible for the day to day management of the premises by the premises licence holder, including the prevention of disorder. A condition of this kind may only be justified as appropriate in rare circumstances where it can be demonstrated that, in the circumstances associated with particular premises, poor management competency could give rise to issues of crime and disorder and public safety.

- 2.6 The prevention of crime includes the prevention of immigration crime including the prevention of illegal working in licensed premises. Licensing authorities should work with Home Office Immigration Enforcement, as well as the police, in respect of these matters. Licence conditions that are considered appropriate for the prevention of illegal working in licensed premises might include requiring a premises licence holder to undertake right to work checks on all staff employed at the licensed premises or requiring that evidence of a right to work check, either physical or digital (e.g. a copy of any document checked as part of a right to work check or a clear copy of the online right to work check) are retained at the licensed premises.
- 2.7 The objective to crime under the Licensing Act 2003 would include taking measures to prevent incidents of spiking which would usually be prosecuted under section 23 and 24 of the Offences Against the Person Act 1861, and section 61 of the Sexual Offences Act 2003. The following examples are within the range of behaviours that would be considered spiking. This list is not exhaustive:
- Putting alcohol into someone's drink without their knowledge or permission
 - Putting prescription or illegal drugs into an alcoholic or non-alcoholic drink without their knowledge or permission
 - Injecting another person with prescription or illegal drugs without their knowledge or permission
 - Putting prescription or illegal drugs into another person's food without their knowledge or permission
 - Putting prescription or illegal drugs into another person's cigarette or vape without their knowledge or permission

Public safety

- 2.8 Licence holders have a responsibility to ensure the safety of those using their premises, as a part of their duties under the 2003 Act. This concerns the safety of people using the relevant premises rather than public health which is addressed in other legislation. Physical safety includes the prevention of accidents and injuries and other immediate harms that can result from alcohol consumption such as unconsciousness or alcohol poisoning. Conditions relating to public safety may also promote the crime and disorder objective as noted above. There will of course be occasions when a public safety condition could incidentally benefit a person's health more generally, but it should not be the purpose of the condition as this would be outside the licensing authority's powers (be ultra vires) under the 2003 Act. Conditions should not be imposed on a premises licence or club premises certificate which relate to cleanliness or hygiene.
- 2.9 A number of matters should be considered in relation to public safety. These may include:
- Fire safety;
 - Ensuring appropriate access for emergency services such as ambulances;
 - Good communication with local authorities and emergency services, for example communications networks with the police and signing up for local incident alerts (see paragraph 2.4 above);

- Ensuring the presence of trained first aiders on the premises and appropriate first aid kits;
- Ensuring the safety of people when leaving the premises (for example, through the provision of information on late-night transportation);
- Ensuring appropriate and frequent waste disposal, particularly of glass bottles;
- Ensuring appropriate limits on the maximum capacity of the premises (see paragraphs 2.12-2.13, and Chapter 10; and
- Considering the use of CCTV in and around the premises (as noted in paragraph 2.3 above, this may also assist with promoting the crime and disorder objective).

2.10 The measures that are appropriate to promote public safety will vary between premises and the matters listed above may not apply in all cases. As set out in Chapter 8 (8.38-8.46), applicants should consider when making their application which steps it is appropriate to take to promote the public safety objective and demonstrate how they achieve that.

2.11 Counter terrorism and public safety

2.12 Licensing committees may wish to give due consideration to appropriate counter-terrorism measures and advice when considering licence applications, for example at high profile or large premises or events or where there are factors which may increase attractiveness to attacks, and in particular when in receipt of relevant advice from police counter terrorist staff.

2.13 It is particularly relevant to consider conditions around health care provision in this regard. Any additional licensing conditions should be appropriate and proportionate to the venue as noted in para 1.16. We recommend that all licensing authorities pay particular attention to terrorist threats when making specific licence conditions in relation to security or health care provision at appropriate premises and events applying for a licence.

2.14 As noted in para 2.8 licensing authorities can recommend conditions where appropriate to do so, such as ensuring appropriate access for emergency services and vehicles such as ambulances; good communication with local authorities and emergency services, for example communications networks with the police and signing up for local incident alerts (see paragraph 2.4); and ensuring the presence of sufficient trained first aiders on the premises and appropriate first aid kits.

2.15 However, in some instances, licensing authorities may wish to tailor their approach, depending on the particular nature of the application, and go further when addressing concerns around possible terrorist or other such risks. We have provided an Annex to help inform and support licensing authorities in their decision making with regards to additional licence conditions for premises and events, that may benefit from further security planning and health care provision in the aftermath of a particular type of incident.

Ensuring safe departure of those using the premises

2.16 Licence holders should make provision to ensure that premises users safely leave their premises. Measures that may assist include:

- Providing information on the premises of local taxi companies who can provide safe transportation home; and
- Ensuring adequate lighting outside the premises, particularly on paths leading to and from the premises and in car parks.

Maintenance and repair

- 2.17 Where there is a requirement in other legislation for premises open to the public or for employers to possess certificates attesting to the safety or satisfactory nature of certain equipment or fixtures on the premises, it would be inappropriate for a licensing condition to require possession of such a certificate. However, it would be permissible to require as a condition of a licence or certificate, if appropriate, checks on this equipment to be conducted at specified intervals and for evidence of these checks to be retained by the premises licence holder or club provided this does not duplicate or gold-plate a requirement in other legislation. Similarly, it would be permissible for licensing authorities, if they receive relevant representations from responsible authorities or any other persons, to attach conditions which require equipment of particular standards to be maintained on the premises. Responsible authorities – such as health and safety authorities – should therefore make their expectations clear in this respect to enable prospective licence holders or clubs to prepare effective operating schedules and club operating schedules.

Safe capacities

- 2.18 “Safe capacities” should only be imposed where appropriate for the promotion of public safety or the prevention of disorder on the relevant premises. For example, if a capacity has been imposed through other legislation, it would be inappropriate to reproduce it in a premises licence. Indeed, it would also be wrong to lay down conditions which conflict with other legal requirements. However, if no safe capacity has been imposed through other legislation, a responsible authority may consider it appropriate for a new capacity to be attached to the premises which would apply at any material time when the licensable activities are taking place and make representations to that effect. For example, in certain circumstances, capacity limits may be appropriate in preventing disorder, as overcrowded venues can increase the risks of crowds becoming frustrated and hostile.
- 2.19 The permitted capacity is a limit on the number of persons who may be on the premises at any time, following a recommendation by the relevant fire and rescue authority under the Regulatory Reform (Fire Safety) Order 2005. For any application for a premises licence or club premises certificate for premises without an existing permitted capacity where the applicant wishes to take advantage of the special provisions set out in section 177 of the 2003 Act¹, the applicant should conduct their own risk assessment as to the appropriate capacity of the premises. They should send their recommendation to the fire and rescue authority which will consider it and decide what the “permitted capacity” of those premises should be.
- 2.20 Public safety may include the safety of performers appearing at any premises, but does not extend to the prevention of injury from participation in a boxing or wrestling

¹ S 177 of the 2003 Act now only applies to performances of dance

entertainment.

Public nuisance

- 2.21 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.
- 2.22 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.
- 2.23 Conditions relating to noise nuisance will usually concern steps appropriate to control the levels of noise emanating from premises. This might be achieved by a simple measure such as ensuring that doors and windows are kept closed after a particular time, or persons are not permitted in garden areas of the premises after a certain time. More sophisticated measures like the installation of acoustic curtains or rubber speaker mounts to mitigate sound escape from the premises may be appropriate. However, conditions in relation to live or recorded music may not be enforceable in circumstances where the entertainment activity itself is not licensable (see chapter 16). Any conditions appropriate to promote the prevention of public nuisance should be tailored to the type, nature and characteristics of the specific premises and its licensable activities. Licensing authorities should avoid inappropriate or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are expensive to purchase and install and are likely to be a considerable burden for smaller venues.
- 2.24 As with all conditions, those relating to noise nuisance may not be appropriate in certain circumstances where provisions in other legislation adequately protect those living in the area of the premises. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be appropriate.
- 2.25 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise

emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.

- 2.26 Measures to control light pollution will also require careful thought. Bright lighting outside premises which is considered appropriate to prevent crime and disorder may itself give rise to light pollution for some neighbours. Applicants, licensing authorities and responsible authorities will need to balance these issues.
- 2.27 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in anti-social behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises instead of outside, and to respect the rights of people living nearby to a peaceful night.

Protection of children from harm

- 2.28 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.
- 2.29 The Government believes that it is completely unacceptable to sell alcohol to children. Conditions relating to the access of children where alcohol is sold and which are appropriate to protect them from harm should be carefully considered. Moreover, conditions restricting the access of children to premises should be strongly considered in circumstances where:
- adult entertainment is provided;
 - a member or members of the current management have been convicted for serving alcohol to minors or with a reputation for allowing underage drinking (other than in the context of the exemption in the 2003 Act relating to 16 and 17 year olds consuming beer, wine and cider when accompanied by an adult during a table meal);
 - it is known that unaccompanied children have been allowed access;
 - there is a known association with drug taking or dealing; or
 - in some cases, the premises are used exclusively or primarily for the sale of alcohol for consumption on the premises.
- 2.30 It is also possible that activities, such as adult entertainment, may take place at certain times on premises but not at other times. For example, premises may operate as a café bar during the day providing meals for families but also provide entertainment with a sexual content after 8.00pm. It is not possible to give an exhaustive list of what amounts to entertainment or services of an adult or sexual nature. Applicants, responsible authorities and licensing authorities will need to consider this point carefully. This would broadly include topless bar staff, striptease, lap-, table- or pole-dancing, performances involving feigned violence or horrific incidents, feigned or actual sexual acts or fetishism,

or entertainment involving strong and offensive language.

- 2.31 Applicants must be clear in their operating schedules about the activities and times at which the events would take place to help determine when it is not appropriate for children to enter the premises. Consideration should also be given to the proximity of premises to schools and youth clubs so that applicants take appropriate steps to ensure that advertising relating to their premises, or relating to events at their premises, is not displayed at a time when children are likely to be near the premises.
- 2.32 Licensing authorities and responsible authorities should expect applicants, when preparing an operating schedule or club operating schedule, to set out the steps to be taken to protect children from harm when on the premises.
- 2.33 Conditions, where they are appropriate, should reflect the licensable activities taking place on the premises. In addition to the mandatory condition regarding age verification, other conditions relating to the protection of children from harm can include:
- restrictions on the hours when children may be present;
 - restrictions or exclusions on the presence of children under certain ages when particular specified activities are taking place;
 - restrictions on the parts of the premises to which children may have access;
 - age restrictions (below 18);
 - restrictions or exclusions when certain activities are taking place;
 - requirements for an accompanying adult (including for example, a combination of requirements which provide that children under a particular age must be accompanied by an adult); and
 - full exclusion of people under 18 from the premises when any licensable activities are taking place.
- 2.34 Please see also Chapter 10 for details about the Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.
- 2.35 Licensing authorities should give considerable weight to representations about child protection matters. In addition to the responsible authority whose functions relate directly to child protection, the Director of Public Health may also have access to relevant evidence to inform such representations. These representations may include, amongst other things, the use of health data about the harms that alcohol can cause to underage drinkers. Where a responsible authority, or other person, presents evidence to the licensing authority linking specific premises with harms to children (such as ambulance data or emergency department attendances by persons under 18 years old with alcohol-related illnesses or injuries) this evidence should be considered, and the licensing authority should also consider what action is appropriate to ensure this licensing objective is effectively enforced. In relation to applications for the grant of a licence in areas where evidence is presented on high levels of alcohol-related harms in persons aged under 18, it is recommended that the licensing authority considers what conditions may be appropriate to ensure that this objective is promoted effectively.
- 2.36 The 2003 Act provides that, where a premises licence or club premises certificate authorises the exhibition of a film, it must include a condition requiring the admission of children to films to be restricted in accordance with recommendations given either by a body designated under section 4 of the Video Recordings Act 1984 specified in the

licence (the British Board of Film Classification is currently the only body which has been so designated) or by the licensing authority itself. Further details are given in Chapter 10.

- 2.37 Theatres may present a range of diverse activities and entertainment including, for example, variety shows incorporating adult entertainment. It is appropriate in these cases for a licensing authority to consider restricting the admission of children in such circumstances. Entertainments may also be presented at theatres specifically for children. It will be appropriate to consider whether a condition should be attached to a premises licence or club premises certificate which requires the presence of a sufficient number of adult staff on the premises to ensure the wellbeing of the children during any emergency.

Offences relating to the sale and supply of alcohol to children

- 2.38 Licensing authorities are expected to maintain close contact with the police, young offenders' teams and trading standards officers (who can carry out test purchases under section 154 of the 2003 Act) about the extent of unlawful sales and consumption of alcohol by minors and to be involved in the development of any strategies to control or prevent these unlawful activities and to pursue prosecutions. Licensing authorities, alongside the police, are prosecuting authorities for the purposes of these offences, except for the offences under section 147A (persistently selling alcohol to children). Where, as a matter of policy, warnings are given to retailers prior to any decision to prosecute in respect of an offence, it is important that each of the enforcement arms should be aware of the warnings each of them has given.

LICENSING ACT COMMITTEE PROCEDURE

1. The Chair will introduce members of the Panel and Officers present and explain the procedure to be followed.
2. The Chair will identify those persons or representatives entitled to address the hearing and to submit questions, including any nominated representatives. In appropriate cases, and subject to applicable regulations or government guidance, the Chair will propose a time allocation of up to a maximum of 10 minutes for the initial address and up to a maximum of 10 minutes for summing up (Rule 11). This time allocation shall be based on equality for all parties. However, this is a guidance time, and the chair must ensure that sufficient time is given to ensure a fair hearing.
3. The Licensing Officer will present the statement of facts, summarising:
 - The facts of the application before the panel.
 - Any objections or representations made by Responsible Authorities.
 - Any representations made by other persons.
 - Those sections of the government guidance and Licensing Policy document applicable to the case.
 - The statement of facts/report will not contain a recommendation.
4. If the Applicant is not present, the Panel may either:
 - Proceed with the hearing in the absence of the Applicant, or
 - Where it considers it necessary in the public interest, adjourn the hearing to another date (Rule 20).
5. The Chair will invite the representatives of the Responsible Authorities who have made objections or representations to address the Panel and submit relevant evidence. The Chair will then invite any questions from the Applicant & other persons and finally from the Panel.
6. The Chair will invite other persons who have made relevant representations to address the Panel. Any such address must relate to the representations submitted to the Licensing Officer prior to the hearing and may not introduce new representations or evidence. The Chair will then invite any questions from the Applicant and the Responsible Authorities and finally from the Panel.

7. The Panel will consider any relevant admissible written representations lodged by Responsible Authorities or other persons not present at the hearing. The Chair may, if he/she considers it appropriate, adjourn the hearing for a period to facilitate this. The Chair (advised by the Legal Adviser) will remind the Panel of the weight to be attached to such evidence.
8. The Chair will invite the Applicant or his/her representative to address the Panel and submit the relevant evidence. The Chair will then invite questions from the Responsible Authorities and other persons and finally from the Panel.
9. The Chair will invite in the following order:
 - The Responsible Authorities present who have made objections or representations.
 - Those other persons present who have made representations.
 - The Applicant. To respectively sum up their cases.
10. If the proceedings are in the opinion of the Chair being disrupted by the behaviour of any person attending the hearing, the Chair may (as an alternative to adjourning the hearing) require that person to leave the hearing and may:
 - Refuse to permit that person to return to the hearing, or
 - Permit him/her to return only on such conditions as the Chair may specify.

But such a person may, before the end of the hearing, submit to the Panel in writing any information which that persons would have been entitled to give orally had he/she not been required to leave..
11. The Panel will retire to consider the application and make their decision without any other person being present, save that:
 - The Panel may ask the Legal Advisor to join them at any time to advise on any legal issue arising out of the hearing.
 - When the Panel have reached their conclusion they will invite the Legal Adviser and the Committee Clerk to join them for the purpose of recording and reporting their decision and the reasons for it.
12. The Panel will return to the hearing room and the Chair will announce the decision of the Panel including the reasons for it, and any conditions imposed. This Rule will apply save where (pursuant to the Licensing Act 2003) the Panel's decision may be, and is, deferred.
