

SUBJECT: Extending Public Spaces Protection Orders (PSPOs) to tackle Anti-Social Behaviour (ASB)
MEETING: Single Cabinet Member Decision
DATE: 27th September 2023
WARDS
AFFECTED: Park, Grofield and Pen-Y-Fal in Abergavenny; and Town in Monmouth

1. PURPOSE:

1.1 To seek approval to extend three Public Spaces Protection Orders (PSPO) in respect of Bailey Park, Abergavenny; Lower Abergavenny (including Castle Meadows) and Monmouth Town (including Chippenham Fields), in Monmouthshire.

2. RECOMMENDATIONS:

- 2.1 To approve the extension of Public Spaces Protection Orders in respect of Bailey Park, Abergavenny; Abergavenny Lower and Monmouth Town in Monmouthshire.
- 2.2 That the three PSPOs which are due to expire 20th October 2023, be extended for a further three years to 20th October 2026.

3. KEY ISSUES:

3.1 Key Issues - Bailey Park

- 3.1.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Bailey Park connected to the consumption of alcohol. The boundary of the park is identified on the attached map at **Appendix A1**.
- 3.1.2 Due to these issues a Designated Public Place Order (DPPO) was imposed in September 2008 by the Licensing Committee of Monmouthshire County Council.
- 3.1.3 The order provided the police with powers to deal with people in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.
- 3.1.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20th October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, when they would convert into a PSPO. This current order is due to expire in October 2023.

3.1.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB in Bailey Park between 2020 and 2023. Gwent Police Logs data are attached at **Appendix A2**.

3.2 Key Issues – Abergavenny Lower, Abergavenny

3.2.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Abergavenny Lower Town (including Castle Meadows) connected to the consumption of alcohol. The boundary of the area concerned is identified on the attached map at **Appendix B1**.

3.2.2 Due to these issues a Designated Public Place Order (DPPO) was imposed in September 2008 by the Licensing Committee of Monmouthshire County Council.

3.2.3 The order provided the police with powers to deal with persons in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.

3.2.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20th October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, when they would convert into a PSPO. This current order is due to expire in October 2023.

3.2.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB in Abergavenny Town between 2020 and 2023. Gwent Police Logs data are attached at **Appendix B2**.

3.3 Key Issues – Monmouth Town, Monmouth

3.3.1 Historically there have been issues with Anti-Social Behaviour (ASB) in Monmouth Town connected to the consumption of alcohol. The boundary of the area concerned is identified on the attached map at **Appendix C1**.

3.3.2 Due to these issues a Designated Public Place Order (DPPO) was imposed in October 2008 by the Licensing Committee of Monmouthshire County Council.

3.3.3 The order provided the police with powers to deal with people in possession of alcohol who had caused, were causing or likely to cause anti-social behaviour.

3.3.4 Under new legislation, The Anti-Social Behaviour, Crime and Policing Act 2014, which commenced 20th October 2014, the DPPO was replaced by the PSPO. Written into the act was the provision for the DPPO to remain in force for three years, when they would convert into a PSPO. This current order is due to expire in October 2023.

3.3.5 There have been a number of calls to Gwent Police complaining about alcohol related ASB Monmouth Town between 2020 and 2023. Gwent Police Logs data are attached at **Appendix C2**.

4. REASONS:

- 4.1 Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 states Local Authorities have the responsibility to make a Public Spaces Protection Order providing two conditions are met:
- 4.2 The first condition is that –
- (a) Activities carried out in a public space within the authority's area have had a detrimental effect on the quality of life of those in the locality, or
 - (b) It is likely that activities will be carried on in a public place within that area and they will have such an effect.
- 4.3 The second condition is that the effect, or likely effect, of the activities –
- (a) Is, or is likely to be, of a persistent or continuing nature;
 - (b) Is, or is likely to be, such as to make the activities unreasonable, and,
 - (c) Justifies the restrictions imposed by the police.
- 4.4 A Public Spaces Protection Order is an Order that prohibits specified activities taking place in a restricted area.
- 4.5 Not to extend the PSPOs would mean that the orders will expire on 20th October 2023 and will be discharged, that would undoubtedly give rise to the return of the problems within the localities, to the detriment of the local communities.
- 4.6 Discussions with police on whether to justify keeping the orders in place, that although the full offence is rarely committed, the presence of them provides a basis with which to tackle potential alcohol fueled ASB much earlier, rather than wait until it has escalated into a more resource impactive situation.

5. RESOURCE IMPLICATIONS:

- 5.1 The MCC Community Safety Officers will work with Gwent Police and community partners as part of the substantive role to issue the Public Spaces Protection Orders and Gwent Police will enforce the Order through their usual policing practices.
- 5.2 Should the Order be granted, there is a requirement for signage to be erected outlining the conditions of the Order. The current signs are adequate to continue in situ, so no additional cost will be necessary.

6. WELLBEING OF FUTURE GENERATIONS IMPLICATIONS (INCORPORATING EQUALITIES, SUSTAINABILITY, SAFEGUARDING AND CORPORATE PARENTING)

7. CONSULTEES

- 7.1 Under the Anti-social Behaviour, Crime and Policing Act 2014, no consultation was required in 2017 to convert the DPPO into the PSPO as no objections had been raised in the preceding three years of the order. From the 20th October 2017 they were treated as PSPO's.
- 7.2 Under the Act, at any point before expiry, the council can extend a PSPO by up to three years if they consider it is necessary to prevent the original behaviour from occurring or recurring.
- 7.3 Consultation has taken place with the Gwent Police for the concerned areas in order to establish the necessity of continuing with the restrictions, and they have confirmed their agreement to the extension of the PSPOs for another three years.
- 7.4 In addition consultation was also carried out in the community at the effected areas in a street survey format by the Partnership Team of MCC. It was not possible to avail this to the social media platform. This was carried out between week beginning July 24th to week ending August 4th 2023.
- 7.5 The below statutory partners and other identified stakeholders were emailed advising of the proposal and invited to provide feedback as part of the consultation. These include:
- Chief Officer Gwent Police (Local)
 - Police & Crime Commissioners Office (OPCC)
 - County Councillors, Park, Grofield and Pen-Y-Fal, Abergavenny and Town, Monmouth
 - Cabinet Member for Equalities and Engagement
 - Gwent Police, Abergavenny and Monmouth local policing teams
 - MCC – Chief Officer for Communities and Place
 - MCC – Head of Policy and Performance
 - MCC Head of Neighbourhood Services
 - MCC Head of Legal
 - MCC Head of Public Protection
 - Abergavenny and Monmouth Town Councils and Clerks
- 7.6 The local police support the continuation of the restrictions imposed by the PSPO's in their current format.
- 7.7 From the Street Survey it was noted that overall 93% were in favour of the Orders remaining in place. 70% had not actually experienced any ASB at the locations and 80% were even aware of their existence. So that is evidence that the majority of the community are not adversely affected by the orders being there, but the majority wish them to remain, believing that they are having the desired affect.
- 7.8 The draft PSPO's are attached.

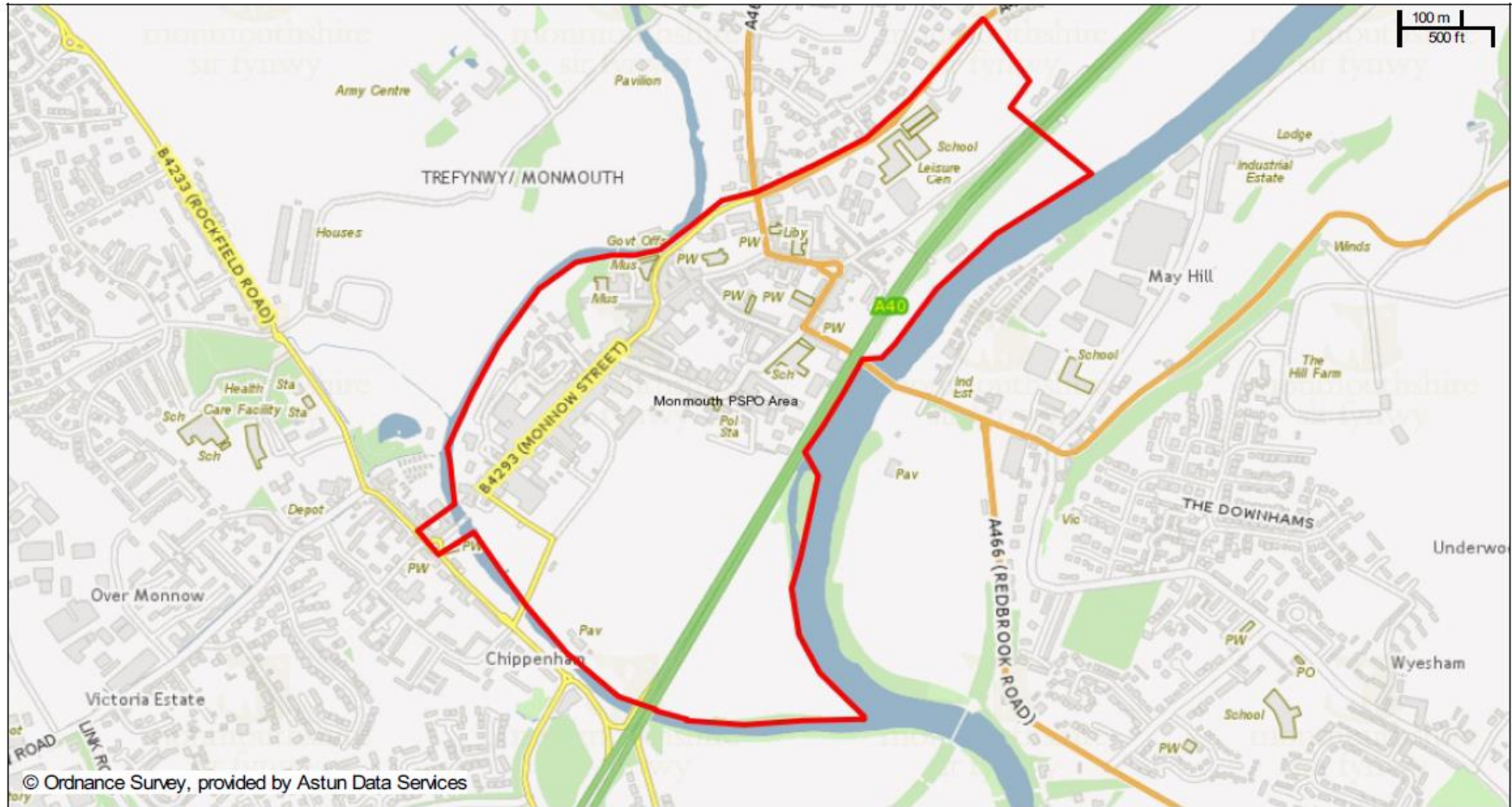

2. The Order relates to the areas defined edged red on the attached map(s) known as Monmouth Town (referred to in this Order as “the Restricted Area”).
3. The Order is made because the Council is satisfied on reasonable grounds that activities at the Restricted Area are having a detrimental effect on the quality of life of those in the locality, or it is likely that activities will have such an effect, and that the effect is, or will be, of a persistent or continuing nature and is, or will be, unreasonable and justifies the restrictions imposed by the Order.
4. In making this Order consultation has taken place with the Chief Constable, the Office of the Police and Crime Commissioner, relevant community representatives, the Town and Community Councils, and owners/occupiers of the Restricted Area (where relevant) and of neighbouring properties.
5. The effect of the Order is to impose the following prohibitions and requirements within any part of the Restricted Area.
 - 5.1. **No person shall within the restricted area refuse to stop drinking alcohol or hand over containers (sealed or unsealed) which are believed to contain alcohol, when required to do so by an authorised officer to prevent public nuisance and disorder.**
 - 5.2. **This Order does not prevent the taking place of community events organised by the Council**

5.3. In respect of Chippenham Mead fields no glass containers allowed.

6. Section 67 of the Act applies to the prohibitions and requirements set out in paragraphs 5.1 to 5.3 of this Order, namely:

6.1. It is an offence for a person without reasonable excuse

- a) To do anything that the person is prohibited from doing by paragraphs 5.1 to 5.3 of this Order
- b) To fail to comply with a requirement to which a person is subject under paragraph 5.1 to 5.3 of this Order

6.2. A person guilty of an offence under this section is liable under summary conviction to a fine not exceeding level 3 on the standard scale or a Fixed Penalty Notice of maximum £100 as an alternative to the prosecution (reduced to £75 if paid within 14 days).

6.3. A person does not commit an offence under this section by failure to comply with a prohibition or requirement that the Council does not have power to include in the Public Spaces Protection Order

7. Appeals

7.1. Any challenge to this Order must be made in the High Court by an interested person within six weeks of it being made. An interested person is someone who lives in, regularly works in, or visits any of the Restricted Area. This means that only those who are directly affected by the restrictions have the power to challenge.

7.2. The right to challenge also exists where an Order is varied by the Council. Interested persons can challenge the validity of this Order on two grounds: that the Council did not have power to make the Order, or to include particular prohibitions or requirements; or that a requirement of the legislation was not complied with in relation to the Order.
