7. What evidence and data has informed the development of your proposal?

In their joint report on the '<u>True Cost of Gambling'</u> – Published 29 January 2019, Public Health Wales and Bangor University highlighted that as well as affecting children and young people, gambling-related harm disproportionately affects certain socio-economic groups, which exacerbates existing inequalities. The report stated that population groups at greater risk of experiencing problem gambling and/or gambling related harms include:

- Children, either because of their own gambling or because of parental or carer gambling.
- Individuals living in most deprived areas, with problem gambling being over seven times higher compared to individuals living in least deprived areas.
- Those with constrained economic circumstances due to unemployment, underemployment, financial difficulties and debt.

The proposed Statement of Gambling Policy sets out how the Council will discharge their functions under the objectives under the Gambling Act 2005 regarding the following.

- Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime,
- Ensuring that gambling is conducted in a fair and open way, and
- Protecting children and other vulnerable persons from being harmed or exploited by gambling.

Regard has been given to the joint report from Public Health Wales and Bango University report above when requesting the resolution to retain within the proposed policy not to permit casinos within the County of Monmouthshire.
