10.1.1	Deletion of the words 'up to' in relation to the number of independent members of the Standards Committee	The Council is required to appoint 5 independent members and no less in order to comply with legislative quorum requirements
11.1.1(a)	Insertion of the correct legislation governing the appointment of independent members of the Standards Committee	The correct legislation is Standards Committees (Wales) Regulations 2001
14.1.2	Deletion of entire paragraph	This should be deleted because the Chief Executive has power to deploy staff as required to meet the operational needs of the Council. The Chief Executive is already obliged to publish a description of the organisational structure (para.14.1.4) which is available on the Council's website.
