**7. What evidence and data has informed the development of your proposal?**

The Flood and Water Management Act 2010 (FWMA) requires Monmouthshire County Council, as a Lead Local Flood Authority, to produce, develop, maintain, apply and monitor a Local Flood Risk Management Strategy. The Local Strategy focuses on local sources of flood risk, namely surface water runoff, Groundwater and ordinary watercourses within Monmouthshire, but acknowledges and considers other sources of flood risk (including main rivers, sea, and sewers) and associated responsible RMAs.

The content of the Local Strategy has been informed by the objectives and content of Welsh Government's National and Strategy for Flood and Coastal Erosion Risk Management in Wales.

Keys sources of information include:

- MCC's Local Flood Risk Management Strategy 2013
- MCC's Local Flood Risk Management Plan 2016
- Pre-consultation Online public survey (2023) which collated people's awareness, understanding and concerns of flood risk in Monmouthshire
- NRW's Communities at Risk Register (CaRR)
- NRW's Flood Risk Assessment Wales (FRAW) dataset
- JBA's Groundwater flood map (licensed specifically for this Local Strategy)
- Numerous environmental datasets from DataMapWales.
- Statutory public consultation over 8 weeks (2025) which included public drop-in sessions at community Hubs and an online survey.

Additional sources of information include MCC's flood and drainage asset database, historic flood and land drainage records, Section 19 Flood Reports, as well as local knowledge from communities and MCC staff.
