**PURPOSE:**

1. To seek approval to align waste income projections to the medium term financial plan and Fees and Charges proposals.

**RECOMMENDATIONS:**

2. That the Cabinet Member agrees:
  - 2.1 for the garden waste charge to increase to £18 per bag.
  - 2.2 that all future increases are included within the Fees and Charges process
  - 2.3 to the removal of waste disposal exemptions from schools and school catering.

**BACKGROUND:**

3. Waste and Street Services are able to recover reasonable costs for several waste streams and rely on this income generation to deliver budget savings and maintain a high quality waste service. In line with the Income Generation strategy the service has previously reviewed what it is able to charge for, to reduce baseline budgets and ensure that income is maximised to contribute to core cost of service delivery.
  - 3.1 There is no statutory duty to collect garden waste and the council began charging for this service in 2013. The Council can recover all reasonable costs associated with the collection of this material but cannot charge for the treatment.
  - 3.3 Changes in legislation in 2011 meant that many establishments that had previously been exempt from disposal charges were no longer subsidised by the domestic waste collection budget. In a Cabinet Report in 2015 it was agreed that the exemptions would be removed on all premises except schools. The schools would receive free recycling services and Waste and Street Services would work with schools to reduce the residual waste.

**KEY ISSUES**

4. As part of the recycling review and in an attempt to reduce treatment costs of garden and food waste these materials will be collected separately from 2017. The review proposals and service planning and route optimisation have allowed us to identify the actual collection costs of

delivering the garden waste service to the 12,000 customers who purchase this service of £340,000. The modelling has demonstrated that if the cost of the service increases to £18 per bag then the garden waste service will virtually become self-financing. It is appreciated that this is a significant increase – double to the increases in previous years, but due to the need for the Council to once again deliver significant savings in 2017/18 it has been deemed preferable to increase the charge exponentially. Previously there have been concerns over the ability to pay and the impact of the charge on low income families. This is mitigated through the ability to use the Household Waste Recycling Centres free of charge or MCC promotes home composting to help householders manage their garden waste. When looked at on an annual basis £18 can be seen as affordable as amounts to 36p per week.

- 4.1 The trade waste charges increases have historically been captured within the fees and charges report. As part of the Council's aspiration to strengthen our customer base and grow this income generation opportunity the charges have remained largely static.
- 4.2 Our charges remain at the upper end of the commercial waste collection market but with a high quality service, reliability and additional benefits of working with Monmouthshire we believe these charges still offer good value for money.
- 4.3 To continue to grow the commercial waste customer base it is important that all our customers, both internal and external, are charged equally to cover the costs of the service. All other Council departments cover the full cost for their waste service and therefore on the principles of fairness and parity it is deemed suitable for schools to have the same charge.

#### **FINANCIAL IMPLICATIONS:**

5. The additional charges for garden waste collections will allow the service to be delivered at little cost to the Authority with current cross subsidy being used to meet the 2017 budgets savings proposals. It is anticipated that an increase of £4 per bag will see the garden waste income increase by £50,000. This figure includes an assumption that some customers will divert to the HWRCs, although data from 2013-2016 has not shown a decrease in customer numbers so this may well prove a conservative figure which will be monitored closely through the revenue budget monitoring process.
- 5.1 It is anticipated that the waste disposal charge on schools and schools catering will deliver an additional £30,000 of income. The majority of schools will see an annual increase of £300 per year. Officers will work with schools to reduce costs for W&SS and the schools as recycling is far cheaper than waste disposal.

#### **Consultees**

- 7.1 Officers provided a briefing document for Education colleagues to share with Head Teachers at a recent forum meeting. Whilst there was disappointment in the proposed increase there was understanding that they had benefitted from the exemption compared to other public bodies, and appreciated the need to align producer responsibility/waste creation costs with their

expenditure. A commitment has also been made for the service to continue to work closely with Schools on their education and eco-programmes and help them look at how they can reduce residual waste to contain costs.
