

**SUBJECT: SACRE Terms of Reference for Agreed Syllabus Conference**

#### 1. PURPOSE:

To consider the composition of the Agreed Syllabus Conference and a revised terms of reference for the SACRE committee.

#### 2. RECOMMENDATION:

To recommend to Full Council the formation of the Agreed Syllabus Conference and an updated terms of reference for SACRE.

#### 3. KEY ISSUES:

#### **Agreed Syllabus Conference**

Following the implementation of the Curriculum and Assessment (Wales) Act 2021, each local authority must prepare and adopt a syllabus of Religion, Values and Ethics (RVE) for use in all maintained schools and have due regard to guidance given by Welsh Ministers on this matter.

Religion, values, and ethics is a statutory requirement of the Curriculum for Wales and is mandatory for all learners from age 3 to 16. RVE forms part of the Humanities Area. This Area encompasses geography; history; religion, values, and ethics; business studies. These disciplines share many common themes, concepts, and transferable skills, whilst having their own discrete body of knowledge and skills.

The local authority has a legal duty to establish and convene an Agreed Syllabus Conference (ASC) to prepare a syllabus of RVE for adoption by the local authority.

In preparing the RVE syllabus, the ASC must have due regard to Curriculum for Wales (CfW) guidance and in particular, the RVE guidance. In addition, the syllabus must reflect the following points:

- (a) the religious traditions in Wales are in the main Christian while taking account of the teaching and practices of the other principal religions represented in Wales
- (b) a range of non-religious philosophical convictions are held in Wales
- (c) the local authority may make different provision in respect of different descriptions of schools maintained by the local authority and different descriptions of learners.

#### Structure of the Agreed Syllabus Conference

An Agreed Syllabus Conference is a statutory body convened to prepare and recommend or reconsider an agreed syllabus for RVE for the local authority to adopt.

The local authority is responsible for convening the Agreed Syllabus Conference which implies a duty to facilitate, fund and support its work.

The ASC is a separate legal body from a Standing Advisory Council. However, it has the same group structure as the Standing Advisory Councils:

#### The ASC must:

- have regard to any guidance given by the Welsh Ministers
- ensure that any sub-committees appointed by the conference shall include at least one member of each of the committees constituting the conference
- give one vote only for each of the committees constituting the conference, upon any question to be decided by the conference or by any subcommittee thereof
- seek unanimous agreement upon a syllabus of RVE to be recommended for adoption by the local education authority
- meet in public and be chaired by an appointee of the local authority or be permitted to choose its own Chair.

#### **Membership of the Agreed Syllabus Conference**

The ASC is made up of representatives from the following three groups:

- Group A a group of persons to represent Christian denominations and other religions and denominations of such religions, non-religious philosophical convictions.
- Group B a group of persons to represent such associations representing teachers as, in the opinion of the authority, ought to be represented, having regard to the circumstances of the area
- Group C a group of persons to represent the authority. There
  is no legal provision for an Agreed Syllabus Conference to
  include co-opted members, but it can seek the advice it
  considers appropriate from those it considers appropriate, to
  inform the development of effective RVE provision in its area.

#### **Legislative Changes**

In additional to the changes relating to the content of the RVE syllabus within the Curriculum and Assessment (Wales) Act 2021; there are also legislative changes relating to the roles and legal responsibilities

of Agreed Syllabus Conferences and Standing Advisory Councils. These are that:

- any agreed syllabus for RVE must reflect both religious beliefs and also non-religious which are philosophical convictions within the meaning of Article 2 Protocol 1 to the European Convention on Human Rights
- provision for the appointment of persons who represent holders of non-religious philosophical convictions is carried out in the same way as the appointment of persons who represent holders of religious beliefs.

## Timeline for the Agreed Syllabus Conference and adoption of the Religion, Values and Ethics Syllabus

The locally Agreed RVE syllabus must be implemented in nurseries and primary schools from the 1<sup>st of</sup> September 2022 and in all year groups and all schools by September 2026.

The following table outlines the proposed timeline for meetings to ensure that the Agreed RVE syllabus is in place in Monmouthshire by the end of May to give schools sufficient time to plan for its implementation from 1<sup>st</sup> September 2022.

9th March 2022	Agreed representation from SACRE to support the ASC
28th March 2022	Agree Syllabus Conference and workshops
26th April 2022	Draft Agreed RVE Syllabus for discussion in SACRE
19th May 2022	Agreed RVE Syllabus for consideration by full Council
6 <sup>th</sup> June 2022	Agreed RVE Syllabus circulated to schools

#### **Appointments of Teaching Representatives**

At the meeting of SACRE on the 20<sup>th of</sup> October 2021, the committee discussed the possibility of allowing teacher representatives to be appointed to the committee directly from head teachers rather than through the teaching associations to allow the filling of seats more quickly on the committee.

The Committee will need to consider how the balance of these appointments should be made if they wish for the appointments to come from head teachers considering factors such as the type of school settings the representatives are working in and how many seats should be appointed to this group.

## Terms of Reference amendment – Non-Religious Group Representative

In addition to this, the authority has received a request from the Humanist group to allow a representative from a non-religious group to sit on SACRE.

Many authorities received applications from the humanist group in 2018 and amended their terms of reference at that time following guidance from the then Welsh Government Minister which confirmed that they would be entitled to appoint a representative on to the committee. The Monmouthshire terms of reference at that time was not amended to allow for the change.

Subsequently, further legislative changes have taken effect that support the decision of the Minister and as such the Council are required to amend the terms of reference to cater for this change.

The legislation however requires that the committee allow for a representative of a non-religious belief and not specifically from the humanist group. A future meeting of SACRE will need to determine how they should fill that seat once the new terms of reference have been adopted.

A template terms of reference for the committee to start the debate is attached at appendix 1.

#### 4. OPTIONS APPRAISAL

#### **Do Nothing**

Not agreeing to the formation of the agreed syllabus conference will result in the Council not meeting its legal obligations of ensuring an agreed curriculum is in place for the start of the next year school year. Similarly, not agreeing to the amendment of the terms of reference to allow non-religious representatives to be members of SACRE will result in the authority not meeting its legal obligations and being constituted appropriately. If the committee do not agree to amend the terms of reference, the councils Monitoring Officer may put forward an amendment on the committees behalf to ensure compliance with the relevant legislation.

## Agree to update the terms of reference & formation of an agreed syllabus conference

Recommending the formation of an agreed syllabus conference as well as an updated term of reference to Full Council will ensure the authority is meeting its legal requirements in terms of representation as well allowing the committee to retain its flexibility in how it appoints the correct people to sit on the committee.

# Appendix 1 – Template Terms of Reference for Agreed Syllabus Conference

#### **Current Terms of Reference**

#### 3. Composition

SACRE shall consist of representation from:

- Christian denominations and other religions and religious denominations, to broadly reflect the proportionate strength of the denomination in the area. It is recognised that there will be occasions when the interests of efficiency override the requirement for directly proportionate representation.
- Such associations representing teachers as, in the opinion of the authority, ought to be represented; and
- The local education authority.

It may also appoint co-opted members if required although these members have no voting rights.

It is for the LEA to appoint the members of the three groups.

Each group has a single vote on any matter to be decided by SACRE.

#### Amended Terms of Reference – Option 1

Composition

SACRE shall consist of representation from:

- Such Christian and other religious denominations as, in the opinion of the authority, will appropriately reflect the principal religious traditions in the area, together with a place for a group who hold non-religious beliefs. It is recognised that there will be occasions when the interests of efficiency override the requirement for directly proportionate representation (13 members)
- Such associations representing teachers as, in the opinion of the authority, ought to be represented or where suitable appointments from associations cannot be made local head teachers are approached to make appointments from schools directly. (7 members)
- The local education authority. It may also appoint co-opted members if required although these members have no voting rights. It is for the LEA to appoint the members of the three groups. Each group has a single vote on any matter to be decided by SACRE. (2 members)

#### Amended Terms of Reference – Option 2

Composition

SACRE shall consist of representation from:

 Such Christian and other religious denominations as, in the opinion of the authority, will appropriately reflect the principal religious traditions in the area, together with a place for a group who hold non-religious beliefs. It is recognised that there will be occasions when the interests of efficiency override the requirement for directly proportionate representation (13 Members)

- Teaching representatives, appointed by the head teachers of schools within the local authority area that reflect the teaching representatives in appropriate delivery of the curriculum. (7 members)
  - {Note, SACRE need to consider numbers of reps, where they come from (primary and or secondary), should one place be retained for association representations etc}
- The local education authority. It may also appoint co-opted members if required although these members have no voting rights. It is for the LEA to appoint the members of the three groups. Each group has a single vote on any matter to be decided by SACRE. (2 members)

#### **Guiding principles for the Members of the Agreed Syllabus Conference**

Religion, values and ethics (RVE) is a statutory requirement of the Curriculum for Wales and is mandatory for all learners from age 3 to 16. RVE forms part of the Humanities Area. This Area encompasses geography; history; religion, values and ethics; business studies. These disciplines share many common themes, concepts and transferable skills, whilst having their own discrete body of knowledge and skills.

#### **Some Notable Points:**

- The LA holds the legal duty of convening an ASC and deciding on its composition.
- Clearly defined and separate meeting to the SACRE meeting with its own agenda, minutes and membership.
- The Agreed Syllabus Conference must 'have regard' to the CfW guidance and the RVE guidance, noting the 'subsidiarity' of the CfW model.
- 'Subsidiarity' the principle that decisions should always be taken at the lowest possible level or closest to where they will have their effect, for example in an individual learning organisation, or a local region rather than for a whole country.
- The Agreed Syllabus could be a document which refers to the RVE Guidance and the <u>Humanities AoLE</u> documentation (see 'Hwb').
- There is a call for a national approach to the agreed syllabus and an appetite to work together on a national syllabus to ensure consistency.
- Voluntary aided schools can teach additional content to the agreed syllabus.

- Voluntary controlled
   – teach their own syllabus in line with the Church but all children if
   parents request that the child follows RVE Faith schools will have to still follow the AoLE
   framework.
- There is no parental right to request that a child is withdrawn from RVE in the Curriculum for Wales.

#### **The Role of the Agreed Syllabus Conference**

- prepare a syllabus of Religion, Values and Ethics to be adopted by a local education authority which may make different provision in respect of different descriptions of:
- (a) schools maintained by the local authority
- (b) learners
- ensure that the syllabus must reflect the fact that:
- (a) the religious traditions in Wales are in the main Christian while taking account of the teaching and practices of the other principal religions represented in Wales
- (b) a range of non-religious philosophical convictions are held in Wales
- have regard to any guidance given by the Welsh Ministers
- ensure that any sub-committees appointed by the conference shall include at least one member of each of the committees constituting the conference
- give one vote only for each of the committees constituting the conference, upon any question to be decided by the conference or by any subcommittee thereof
- seek unanimous agreement upon a syllabus of RVE to be recommended for adoption by the local education authority.

The Agreed Syllabus Conference must also **meet in public** and **be chaired by an appointee of the local authority or be permitted to choose its own Chair**.

Reconsideration of any agreed syllabus for RVE should take place **no later than five years** after the appointed day on which the local authority adopted the agreed syllabus for RVE.

#### **Membership of the Agreed Syllabus Conference**

The Agreed Syllabus Conference is a separate legal body from a Standing Advisory Council. However, it has the same group structure as the Standing Advisory Councils:

- Group A a group of persons to represent: Christian denominations and other religions and denominations of such religions; non-religious philosophical convictions. A local authority in Wales, in appointing such persons must take all reasonable steps to secure the outcome that the number of members appointed to the committee to represent a religion, denomination or non-religious philosophical conviction shall, so far as consistent with the efficient discharge of the committee's functions, reflect broadly the proportionate strength of that religion, denomination or non-religious philosophical conviction in the area
- Group B a group of persons to represent such associations representing teachers as, in the opinion of the authority, ought to be represented, having regard to the circumstances of the area
- Group C a group of persons to represent the authority. There is no legal provision for an Agreed Syllabus Conference to include co-opted members, but it can seek the advice it considers appropriate from those it considers appropriate, to inform the development of effective RVE provision in its area.

#### **Legislative Changes**

The legislative changes in the Act relating to the roles and legal responsibilities of Agreed Syllabus Conferences and Standing Advisory Councils are:

- The Act makes it explicit that any agreed syllabus for RVE must reflect both religious beliefs and also non-religious which are philosophical convictions within the meaning of A2P1
- provision for the appointment of persons who represent holders of non-religious philosophical convictions in the same way as they permit the appointment of persons who represent holders of religious beliefs.

The Act provides for the appointment of persons who represent holders of non-religious philosophical beliefs in the same way as they permit the appointment of persons who represent holders of religious beliefs. It is a matter for the local authority to decide on the appointment of appropriate persons. The final decision on an appointment is dependent on the relevant local authority's determination that such a representative would help ensure the relevant traditions of the area are appropriately reflected. The local authority must take all reasonable steps to secure that the membership of the group is broadly proportionate to the strength of each religion, denomination, or conviction in its local area (see new subsection (6A) and (6B) of section 390 inserted by paragraph 9(8) of the Schedule.

#### Aims of the agreed syllabus

The agreed syllabus is not designed to be a scheme of work, but rather a helpful guide and legal reference point for schools to support them in designing an appropriate and relevant curriculum for their learners which includes RVE within the Humanities Area. The approach of the Curriculum for Wales Framework is based on the principle of subsidiarity and, as such, each agreed syllabus should recognise and reflect the autonomy of each school and setting in realising its own curriculum. One of the intentions of this statutory RVE guidance is to provide the right balance between the central steer of the Curriculum for Wales Framework and the requirements of local determination for RVE, as set out in agreed syllabi across Wales. Therefore, the statutory RVE guidance has been written as the basis for the agreed syllabus. Should a local authority wish to adopt or adapt this guidance as their agreed syllabus they may do so. It will ultimately be the responsibility of the provider to ensure that non-denominational RVE is provided pluralistically. Agreed syllabuses should recognise that while the principal religions and their traditions in Wales should be taught in all schools, other beliefs (including non-religious philosophical convictions such as humanism and atheism) are now a recognised part of life within local areas in Wales and beyond. This is reflected in the Act which states that the agreed syllabus:

- must reflect the fact that the religious traditions in Wales are in the main Christian while taking account of the teaching and practices of the other principal religions represented in Wales
- must also reflect the fact that a range of non-religious philosophical convictions are held in Wales.

#### The agreed syllabus and the Curriculum for Wales Framework

Establishing the relationship between the agreed syllabus and the Curriculum for Wales
Framework is the legal duty of Agreed Syllabus Conferences. Local authorities, Standing Advisory
Councils and Agreed Syllabus Conferences must have regard to the Curriculum for Wales
Framework, which includes this statutory RVE guidance, when developing and adopting an agreed
syllabus. The agreed syllabus is the first point of reference for RVE provision in schools and
settings, therefore it is essential for the agreed syllabus to recognise and reflect the approach of
the Curriculum for Wales Framework and the principles set out in this statutory RVE guidance in
order to create balance and maintain coherence across the Curriculum for Wales. This statutory
RVE guidance enables Agreed Syllabus Conferences to establish, with confidence, this relationship
between the locally agreed syllabus and the Curriculum for Wales Framework for learners aged 3
to 16. This includes guidance to support schools and settings in ensuring that there is appropriate
breadth and depth in RVE while recognising the principle of subsidiarity.

#### Questions for agreed syllabus conferences to consider:

- Are religious and non-religious philosophical convictions appropriately represented?
- Would it be useful to identify faith and belief groups represented locally in the agreed syllabus?
- Would it be appropriate to offer schools and settings useful information about these faith and belief groups and how to contact them?
- Would it be helpful to include exemplar material and resources to support the locally agreed syllabus?
- How can collaboration between the Agreed Syllabus Conference and local authority schools and settings be facilitated to ensure an appropriate agreed syllabus is produced for your area?
- Are there any other groups or organisations in Wales that could support the Agreed Syllabus Conference in developing the locally agreed syllabus for your area?
- How will the locally agreed syllabus be promoted to schools and settings and other interested parties in your area?
- In addition to the statutory RVE guidance for learners from 3 to 16, do schools and settings in your area require anything further to support curriculum design for RVE in ways which support the principle of subsidiarity? For example:
- advice on links to other Areas
- suggestions for optional post 16 RVE
- a glossary of terms
- advice on engaging with sensitive issues in RVE
- guidance on what critical, objective and pluralistic RVE might look like.

#### Other things to consider:

#### **Legacy Agreed Syllabus Review**

The Local Authority may need to include a review of the **current** agreed syllabus for learners who are educated under the **legacy curriculum**. This is only necessary if a recent review has not taken place within the last five years. A separate agenda, minutes are required as it needs, legally, to be a separate ASC meeting. In practice, the **two ASC meetings** (for legacy and new Agreed Syllabus discussions) can take place on the same day, with the same membership, but with an official break in between them and running them as two separate meetings. **As ASC members you may well be asked to attend both sessions, if there is a 'legacy' Agreed Syllabus to re-adopt, if it hasn't been done in the since February 2017.** 

#### Post 16

It is currently unclear as to when RE/RVE becomes optional for post 16? The Agreed Syllabus will need to outline this. When is compulsory RE being removed and optional implemented in all educational settings? 2022? Guidance for Post 16 – Does this need to be added to the Agreed Syllabus? We are awaiting clarification on this, but the Local Authorities legal Team my wish to explore this prior to the first ASC meeting. So that the ASC members can be clear of what to include in the Agreed Syllabus from the first meeting.

#### **Curriculum Time**

The Curriculum for Wales framework and the RVE Guidance does not stipulate how much curriculum time should be considered for RVE, rather that it is statutory. How will SACREs/SACs and Estyn determine and monitor the provision for statutory RVE? Does the ASC need to consider this for their Agreed Syllabus?



Concerns were expressed at the number of vacancies on the SACRE, and the underrepresentation of different faith groups.

- i. The Chair agreed to follow up the County Council vacancies.
- ii. The temporary Church in Wales Diocesan Director is retiring. Mrs. Quinlan agreed to follow up the resulting vacancy.
- iii. The Chair will work with Hayley Jones to make direct approaches to faith leaders locally and outside Monmouthshire to attempt to fill the vacancies.
- iv. A request has been received from Wales Humanists applying for membership of Committee A. The request was deferred, and the Chair will send a holding response whilst efforts are made to fill vacancies and pending advice on process to add to Committee A. Initial findings suggest that this would be a Council decision.
- v. SACRE should raise its profile and work in schools. The EAS is working on this.
- vi. Under the terms of reference teacher representatives are appointed by professional associations. It was questioned if this was the most effective way to appoint teacher representatives and if the terms of reference could be reviewed so that nominations can be made via Headteachers with possibly one designated place to represent professional associations.
- vii. Mrs Cave offered to contact the Interfaith Council regarding the faith vacancies.

#### 4. To confirm the Annual Report 2020/21

The draft report was confirmed as presented subject to the following amendments:

- i. Revd Greaves to represent the Baptist Church not the Free Church Council.
- ii. An amendment was required to make clear that the letter from the Minister, received in May 2018, provided guidance to local authorities on discretion concerning representatives from organisations representing non–religious beliefs such as Humanists to sit on Committee A.

#### 5. Curriculum Updates

Hayley Jones RVE Adviser provided an update on the assessment adaptions published by the WJEC. It was noted that the GCSE adaptions are the same as last year. For GCE A Level, there has been some streamlining in terms of teaching time/content due to the pressures arising from Covid 19 alongside retaining a balance so that assessment will enable access to further education.

Qualifications Wales has announced some plans to prepare should Covid levels increase. The Minister for Education has also written a statement that pupils will have their qualifications awarded through a Centre Determined Grade (CDG). It was commented that there is need for caution as many children are in and out of school and that exams will be difficult this year. The changes were welcomed.

#### 6. <u>Curriculum Wales Updates</u>

There is a national roll-out of modules for different phases of curriculum design to support senior leaders. The sessions were recorded and available to view for those who were unable to attend. The focus now is on the roll out of the Curriculum for Wales development programme for middle leadership that provides the opportunity to specialise in Areas of Learning Experience.

Attendance has been very low due to the pressured circumstances and problems releasing staff to attend. There has been a flexible approach to when and how sessions are provided to ensure access for as many staff as possible. It was acknowledged that there is reliance on the goodwill of staff who are overwhelmed.

An additional secondary design group has been set up to address that the focus has mainly been on primary sector; regional and national networks are the next step.

The EAS has set up task and finish groups on various aspects but the availability of school staff to attend remains a difficulty.

A Member asked whether the introduction could be postponed due to the pressures. It was confirmed that the introduction of the Curriculum for Wales has been put back a year for secondary schools but not for primary schools. It was questioned why there a distinction between secondary and primary. It was possibly due to the pressures related to CDGs. The Chair will raise this point at a meeting of Cabinet Leads with the WLGA. It was confirmed that trials of the curriculum are running this year with Y7 engaging in a joint AOLE Humanities project at King Henry VIII Comprehensive School. It was agreed that a letter would be written by SACRE to the Minister (copying in EAS and SACRE Members) to apply pressure to extend the postponement to the primary phase.

A Member asked how the draft RVE statutory guidance is progressing recalling that SACRE recommended that the legal elements should be statutory but the more subjective teaching elements should be non-statutory guidance. The current RE framework is non-statutory guidance.

There has to be a SACRE agreed syllabus. WASACRE recently discussed if this could be less prescriptive to allow headteachers more discretion. There were concerns about SACREs not being properly consulted.

It was explained that SACRES have termly updates containing e.g. RVE and any changes to collective worship. The new RVE guidance will have a significant impact on agreed syllabus. SACRE can adopt the guidance as its agreed syllabus, amend it or do own something different. No action can be taken until the final guidance is published. The next update is expected in December 2021. It was agreed to consider an additional meeting if this is the case.

#### 7. Agreed Syllabus Conference

It was agreed to revisit this item at the March meeting when more information may be available.

#### 8. WASACRE Business
