### ADVICE TO COUNCILLORS:

The Councillor's Code of Conduct requires you to declare Personal Interests. Some Personal Interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this.

This form enables you to record those interests, or to show that you have no such interests to declare.

**Please remember** that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting. Please refer to the Councillor's Code of Conduct for the rules on this.

**Complete all Grey areas, Sign and Date form and return to Democratic Services.**

### Personal Interests

**You (Councillors and Co-opted Members) must in all matters consider whether you have a Personal Interest, and whether the Code of Conduct requires you to disclose that interest.**

**You must regard yourself as having a Personal Interest in any business of your Authority if it relates to, or is likely to affect any of the following categories.**

i	<b><i>Details of any employment or business carried on by you;</i></b>  COUNTY COUNCILLOR
ii	<b><i>Details of any person who employs or has appointed you, any firm in which you are a partner or any company for which you are a remunerated director;</i></b>  MCC

III	<p><b>Details of any person, other than your Authority, who has made a payment to you in respect of your election or any expenses incurred by you in carrying out your duties as a member;</b></p> <p>NONE</p>
IV	<p><b>Details of any corporate body which has a place of business or land in your Authority's area, and in which you have a beneficial interest in a class of securities of that body that exceeds the nominal value of £25,000 or one hundredth (1/100) of the total issued share capital of that body;</b></p> <p>NONE</p>
V	<p><b>Details of any contract for goods, services or works made between your Authority and you or a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in (iv) above;</b></p> <p>NONE</p>
VI	<p><b>Details of any land (Give the address or other description sufficient to identify the location) in which you have a beneficial interest* and which is in the area of your Authority;</b>  * This means being the owner, landlord or tenant of land or property (including your home), other than under a trust.</p> <p>[REDACTED]</p>

<b>ee)</b>	<b>private club, society or association operating within your Authority's area.</b>  MEMBER OF CONSERVATIVE ASSOCIATION ABERGAVENNY RUGBY CLUB
