ADVICE TO COUNCILLORS:

The Councillor's Code of Conduct requires you to declare Personal Interests. Some Personal Interests have to be recorded by you in the statutory public register, within 28 days of your election or appointment to office, and have to be updated by you within 28 days of any change.

There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this.

This form enables you to record those interests, or to show that you have no such interests to declare.

Please remember that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting. Please refer to the Councillor's Code of Conduct for the rules on this.

Complete all Grey areas, Sign and Date form and return to Democratic Services.

Personal Interests

You (Councillors and Co-opted Members) must in all matters consider whether you have a Personal Interest, and whether the Code of Conduct requires you to disclose that interest.

You must regard yourself as having a Personal Interest in any business of your Authority if it relates to, or is likely to affect any of the following categories.
