**ADVICE TO COUNCILLORS:**

The Councillor's Code of Conduct requires you to declare Personal Interests. Some Personal Interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this.

This form enables you to record those interests, or to show that you have no such interests to declare.

**Please remember** that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting. Please refer to the Councillor's Code of Conduct for the rules on this.

**Complete all Grey areas**, Sign and Date form and return to Democratic Services.

**Personal Interests**

**You (Councillors and Co-opted Members) must in all matters consider whether you have a Personal Interest, and whether the Code of Conduct requires you to disclose that Interest.**

**You must regard yourself as having a Personal Interest in any business of your Authority if it relates to, or is likely to affect any of the following categories.**
